Generation of Matter

This matter was initiated based on a complaint filed by
Lauren Larson on October 13, 1983, alleging that the Committee to
Return Ron deLugo to Congress ("the Committee") accepted
corporate (in-kind) contributions prohibited by 2 U.S.C.
§ 441b(a); and that the Virgin Isle Hotel, Coral Air Inc., and
Antilles Air Boats made corporate (in-kind) contributions in
violation of 2 U.S.C. § 441b(a).

Legal and Factual Analysis

The Committee to Return Ron deLugo to Congress was the Principal Campaign Committee for Ron deLugo's campaign for re-election to the U.S. House of Representatives in 1980. 1/ For the period in question, Ruth Malen Christensen served as treasurer of the Committee.

In its 30 Day Post General Election Report, covering the period from October 16, 1980 through November 24, 1980, the Committee disclosed the receipt of in-kind contributions on Schedule A (receipt schedule) as follows:

The complainant charges that the in-kind contributions reportedly received from the Virgin Isle Hotel, Coral Air, Inc., and Antilles Air Boats violate the Federal Election Campaign Act of 1971, as amended, 2 U.S.C. § 431 et seq.

By letter of November 9, 1983, the Committee to Return Ron deLugo to Congress and its treasurer, Ruth Malen Christensen, responded through counsel to the allegations involved. See Attachment I at pages 1-3. The respondents maintain that the three contributions raised in the complaint were proper contributions from individuals as recorded on Schedule A (receipt schedule) and that the contributions were incorrectly noted on Schedule B (disbursement schedule).

According to the response, the \$2,000 hotel contribution was from four members of the Branch family. The hotel bill was paid as a trade-off by Branch Electric Company, then a sole proprietorship, the trade-off credited to the family members who were listed on Schedule A as having made in-kind contributions. This information is verified by the Virgin Isle Hotel which responded on November 15, 1983, to the allegation involved. See Attachment II at pages 4 and 5.

With respect to the \$440 in-kind contribution reportedly received from Coral Air, Inc., the Committee's response states that the \$440 in Coral Air tickets were purchased by Mr. Jervis and given to the committee as indicated on Schedule A.

Regarding the alleged receipt of in-kind contributions from Antilles Air Boats, totaling \$721.40, the Committee explains that Ron deLugo purchased the \$721.40 in airline tickets from Antilles Air Boats for use by the Committee. According to the response, this was listed as an in-kind contribution from Mr. deLugo to the Committee on Schedule A along with other expenditures by him totaling \$1,000. To rectify all of the above reporting errors, the Committee has submitted an amended report. See Attachment III at pages 6-9.

Copies of the complaint were also sent to Coral Air, Inc., and Antilles Air Boats on October 20, 1983. 2/ No response has been received from these organizations.

Based on the response of the Virgin Isle Hotel, the Committee to Return Ron deLugo to Congress and its treasurer, Ruth Malen Christensen, the Office of General Counsel recommends that the Commission find that there is no reason to believe that a violation of 2 U.S.C. § 441b(a) occurred and close the file in this matter.

Recommendations

1. Find no reason to believe that the Committee to Return Ron

2/ The Commission's notification of the complaint to Antilles Air Boats was returned on October 31, 1980. The Lt. Governor's Office in the Virgin Islands has verified that the corporation was dissolved on August 10, 1982. A second mailing was sent on November 8, 1983, to the former President who was listed in the articles of incorporation.

deLugo to Congress and its treasurer, Ruth Malen Christensen, violated 2 U.S.C. § 441b(a) by accepting corporate (in-kind) contributions.

2. Find no reason to believe that the Virgin Isle Hotel violated 2 U.S.C. § 441b(a) by making a corporate (in-kind) contribution to the Committee to Return Ron deLugo to Congress.

3. Find no reason to believe that Coral Air, Inc. violated 2 U.S.C. § 441b(a) by making a corporate (in-kind) contribution to the Committee to Return Ron deLugo to Congress.

4. Find no reason to believe that Antilles Air Boats violated 2 U.S.C. § 441b(a) by making a corporate (in-kind) contribution to the Committee to Return Ron deLugo to Congress.

5. Approve and send the attached letters.

6. Close the file in MUR 1593.

We represent the Committee to Return Ron deLugo to Congress, Treasurer Ruth Malen Christensen, in the above referenced matter. This letter is in response to your October 20, 1983 notification letter to Ms. Christensen which she received on October 26.

Our review of the facts and the Committee records indicates that the three contributions raised in the complaint letter were proper contributions from individuals as recorded on the Schedule A - Receipt pages of the November 30, 1980 report. The contributions were incorrectly noted on the Schedule B - Disbursement pages as disbursement to corporations rather than as in-kind contributions from the same individuals listed on the Receipt pages. This bookkeeping error will be rectified in an amendment to be filed shortly by Ms. Christensen.

Ron de Lugo purchased the \$721.40 in airline tickets from Antilles Air Boats for use by the Committee. This was listed as an in-kind contribution from Mr. de Lugo to the Committee on Schedule A, page 1 of 1, along with other expenditures by him totaling \$1,000. The Antilles Airboat tickets portion of this \$1,000 was incorrectly recorded as an in-kind contribution from Antilles Air Boats, rather than Mr. de Lugo, in the Disbursements portion of the report, Schedule B, page 4 of 5. This accounting will be clarified in the amended report.

The \$440.00 in Coral Air tickets were purchased by Mr. Jervis and given to the Committee, correctly recorded as contributions from Mr. Jervis on Schedule A, page 7 of 7. This was incorrectly recorded as from the airlines on Schedule B, page 4 of 5. This will be clarified in the amended report.

The \$2,000.42 hotel contribution was from four Members of the Branch Family. The hotel bill was paid as a trade off by Branch Electric Company, then a sole proprietorship, the trade off credited to the family members who are credited with the contributions on Schedule A, pages 6 and 7 of 7. These contribution were incorrectly listed as from the hotel on the Disbursement, Shcedule B, page 4 of 5. This will be clarified in the amended report.

In answer to your inquiry concerning the Virgin Isle Hotel's contribution of \$2,000.00 to the "Committee to Return Ron DeLugo to Congress", the Virgin Isle Hotel in no manner contributed \$2,000.00 to Congressman DeLugo's campaign.







We represent the Committee to Return Ron deLugo to Congress, Treasurer Ruth Malen Christensen, in the above referenced matter. This letter is in response to your October 20, 1983 notification letter to Ms. Christensen which she received on October 26.

Our review of the facts and the Committee records indicates that the three contributions raised in the complaint letter were proper contributions from individuals as recorded on the Schedule A - Receipt pages of the November 30, 1980 report. The contributions were incorrectly noted on the Schedule B - Disbursement pages as disbursement to corporations rather than as in-kind contributions from the same individuals listed on the Receipt pages. This bookkeeping error will be rectified in an amendment to be filed shortly by Ms. Christensen.

Ron de Lugo purchased the \$721.40 in airline tickets from Antilles Air Boats for use by the Committee. This was listed as an in-kind contribution from Mr. de Lugo to the Committee on Schedule A, page 1 of 1, along with other expenditures by him totaling \$1,000. The Antilles Airboat tickets portion of this \$1,000 was incorrectly recorded as an in-kind contribution from Antilles Air Boats, rather than Mr. de Lugo, in the Disbursements portion of the report, Schedule B, page 4 of 5. This accounting will be clarified in the amended report.

The \$440.00 in Coral Air tickets were purchased by Mr. Jervis and given to the Committee, correctly recorded as contributions from Mr. Jervis on Schedule A, page 7 of 7. This was incorrectly recorded as from the airlines on Schedule B, page 4 of 5. This will be clarified in the amended report.
