

This letter is to notify you that on November 3, 1988, the Federal Election Commission received a complaint which alleges that Citizens For Coleman and you, as treasurer, may have violated certain sections of the Federal Election Campaign Act of 1971, as amended, the Act. A copy of the complaint is enclosed. We have numbered this matter MJE 2763. Please refer to this number in all future correspondence.

Under the Act, you have the opportunity to demonstrate in writing that no action should be taken against you and Citizens For Coleman in this matter. Please submit any factual or legal materials which you believe are relevant to the Commission's analysis of this matter, where appropriate. Statements should be submitted under oath. Your response, which should be addressed to the Federal Election Commission, must be submitted within 15 days of receipt of this letter. You are encouraged to respond to this notification promptly. In order to facilitate an expeditious response, we have enclosed a pre-addressed postage paid, special delivery envelope. If no response is received within 15 days, the Commission may take further action based on the available information.

The complaint may be dismissed by the Commission prior to the receipt of your response if the evidence submitted does not indicate that a violation of the Act has been committed. Should the Commission dismiss the complaint, you will be notified by overnight express mail.

This matter will remain confidential in accordance with Section 437g(a)(4)(B) and Section 437g(a)(1)(C) of Title 2 unless you notify the Commission in writing that you wish the matter to be made public.



The Office of the General Counsel received a complaint on November 3, 1988, from Douglas R. Hughes (Doug Hughes). The complaint alleges that a letter soliciting contributions, forwarded by Citizens for Coleman, may have violated 2 U.S.C. § 438(a)(4). Attached to the letter paid for by Citizens for Coleman, and submitted as part of the complaint, was a portion of Mr. Hughes campaign finance report.

**PRELIMINARY FACTUAL AND LEGAL ANALYSIS**

Pursuant to 2 U.S.C. § 438(a)(4), information copied from committee reports may not be sold or used for the purpose of soliciting contributions or for any commercial purposes. See also 11 C.F.R. § 104.15.

The complaint raises the issue of whether the attachment of a campaign finance report to a letter soliciting contributions was an unlawful use of campaign finance information, in violation of 2 U.S.C. § 438(a)(4). In MUR 2683, a report raising similar issues was objected to by the Commission. This Office recommends permitting the fifteen day notice period to run, pending Commission resolution of the issues presented in that matter.


Accordingly, upon receiving a response from the committee, this Office will report to the Commission with appropriate recommendations.

Dear Mr. Noble:

This responds to your letter to Citizens for Coleman and Teresa A. Loar as its treasurer, dated November 4, 1988, regarding a complaint filed with the Federal Election Commission on or about November 3, 1988 by Doug Hughes. By letter, dated November 17, 1988, Teresa A. Loar acknowledged the receipt of the complaint and requested a fifteen day extension of time within which to secure counsel and file a written response.

Enclosed is a Statement of Designation of Counsel, designating the undersigned as counsel to the respondents in this matter.

In his complaint, Doug Hughes alleged that a mailing by Citizens for Coleman, a copy of which was attached to the complaint, was in violation of the provisions of 2 U.S.C. 438(a)(4). Evidently, this allegation was based on the fact that the Citizens for Coleman mailing included a compilation of the names and addresses of, as well as dates and amounts contributed by, seven political committees which had contributed to the Hughes for Congress Committee. No individual contributors to the Hughes for Congress Committee were included in respondents' mailing.

Section 438(a)(4) generally allows for inspection and copying of reports and statements filed with the Federal Election Commission but prohibits the sale or use of such copied information to solicit contributions, or for any other commercial purpose, with the exception of using the name and address of any political committee to solicit contributions from such committee.



In its interpretation and enforcement of this Section, the Commission has concluded that the prohibition on the copying and use of names of individual contributors is crucial; and, that, except for information identifying individual contributors, any of the information found in documents filed with the Commission may be copied and used. See Advisory Opinions 1980-78, 1980-101, 1981-38 and 1983-44. In fact, in Advisory Opinion 1980-101, the Commission expressly concluded that 2 U.S.C. 438(a)(4) does not prohibit the kind of copying and use which is the subject of the instant complaint.

Based upon the foregoing, it is respectfully submitted that there is no reason to believe that respondents violated the provisions of 2 U.S.C. 438(a)(4) by compiling and mailing a list of contributions received by the Hughes for Congress Committee from political committees. Therefore, the file on this matter should be closed.

GENERAL COUNSEL'S REPORT

I. BACKGROUND

This matter was generated by a signed and sworn complaint by Douglas R. Hughes (Doug Hughes) alleging violations of the Act by Citizens for Coleman ("Coleman Committee") and Teresa Ann Loar, as treasurer. Specifically, complainant alleges that a letter soliciting contributions, forwarded by the Coleman Committee to contributors, violated 2 U.S.C. § 438(a)(4) because of its inclusion of Mr. Hughes' campaign finance information. A partial copy of the letter and Schedule A of complainants' disclosure report, as attached to the solicitation letter, was submitted in support of the complaint. The response of the Coleman Committee was received on November 22, 1988. (Attachment 1).

II. ANALYSIS

The thrust of Mr. Coleman's solicitation letter appears to be the showing of a financial connection between special interest groups and Mr. Hughes, his opponent. In this regard, Mr. Coleman attached one page of Schedule A of Mr. Hughes' disclosure report to the solicitation letter. The page of Mr. Hughes' Schedule A shows several contributions from political action committees to the Hughes campaign. The Schedule A lists names, addresses, dates and amounts of PAC contributions for each PAC contributor. No individual contributors are listed.

Title 2 U.S.C. § 438(a)(4) prohibits the use of any information copied from reports filed with the Commission "for the purpose of soliciting contributions or for commercial purposes, other than using the name and address of any political committee to solicit contributions from such committee."

The complaint raises the issue of whether the attachment of contributor information of political action committees from FEC reports is an unlawful use of campaign finance information, in violation of 2 U.S.C. § 438(a)(4).

The response of the Coleman Committee argues that Commission interpretation and enforcement of 2 U.S.C. § 438(a)(4) "has concluded that the prohibition on the copying and use of names of individual contributors is crucial, and, that, except for information identifying individual contributors, any information found in documents may be copied and used." (Attachment 1, page 2 citing A.O. 1980-101). Based on the foregoing, Respondents conclude that there is no reason to believe a violation of 2 U.S.C. § 438(a)(4) has occurred with respect to the mailing in question.

The Coleman Committee's inclusion of campaign finance information in its solicitation letter to voters does not fall within the prohibition contained in 2 U.S.C. § 438(a)(4) for the following reasons. Section 438(a)(4) does not prohibit politically motivated disclosure of contributor information of political action committees on FEC reports, but rather prohibits monetary solicitations directed to individuals who make contributions and are identified on FEC reports by name and address. See AOs 1980-78, 1981-38, 1983-44. The Commission has

interpreted the congressional intent behind this section to be the prevention of list brokering which might discourage continued contributions from "public spirited citizens," not the suppression of financial information. Id.

The primary purpose of the Coleman Committee's use of FEC campaign finance information was to enlighten voters about the opponent's political views. Only financial information concerning political action committees was included in the mailing. No individual contributor information was included in the mailing and thus no invasion of individual privacy has occurred.

Accordingly, this Office recommends that the Commission find no reason to believe Citizens for Coleman and Teresa Ann Loar, as treasurer, violated 2 U.S.C. § 438(a)(4). See MUR 2683.

### III. RECOMMENDATIONS

1. Find no reason to believe Citizens for Coleman and Teresa Ann Loar, as treasurer, violated 2 U.S.C. § 438(a)(4).
2. Approve the attached letters.
3. Close the file.

On April 19, 1989, the Federal Election Commission reviewed the allegations of your complaint dated October 26, 1988, and found that on the basis of the information provided in your complaint, and information provided by Citizens for Coleman and Teresa Ann Loar, as treasurer, there is no reason to believe the Citizens for Coleman and Teresa Ann Loar, as treasurer violated 2 U.S.C. § 438(a)(4). Accordingly, on April 19, 1989, the Commission closed the file in this matter. The Federal Election Campaign Act of 1971, as amended ("the Act") allows a complainant to seek judicial review of the Commission's dismissal of this action. See 2 U.S.C. § 437g(a)(8).
