

The purpose of this letter is to bring to the attention of the Federal Election Commission (pursuant to 2 USC 437g(a)(1) and 11 CFR 111.4) what I believe to be a violation of the public disclosure requirements of the Federal Election Campaign Act and accompanying regulations. Specifically, I have reason to believe that Jim Slattery, Congressman from Kansas, raised at least \$5,000 toward a 1990 reelection campaign more than three weeks ago. However, as of the date of this letter, FEC records show that Congressman Slattery has yet to file the required public declaration of his intentions.

Once an individual has raised or spent \$5,000, he or she is required under federal law to file a Statement of Candidacy designating a Principal Campaign Committee within 15 days (2 USC 432(e)(1) and 11 CFR 101.1(a) and 11 CFR 100.3(a)). This Statement must contain:

1. The candidate's name and address;
2. The party affiliation and office sought; and
3. The name and address of his or her principal campaign committee.

In addition, each committee so designated must file a Statement of Organization within 10 days (2 USC 433(b) and 11 CFR 102.2) of the Statement of Candidacy listing:

1. The name, address and type of committee;
2. The name, address, relationship and type of any connected organization or affiliated committee;
3. The name, address and committee position of the custodian of books and accounts of the committee;
4. The name and address of the treasurer of the committee;
5. The candidate's name, the office sought and party affiliation, and the address to which communications should be sent; and
6. A listing of all banks, safe deposit boxes, or other depositories used by the committee.

The Federal Election Commission received a complaint which alleges that you may have violated the Federal Election Campaign Act of 1971, as amended (the "Act"). A copy of the complaint is enclosed. We have numbered this matter MUR 2902. Please refer to this number in all future correspondence.


Under the Act, you have the opportunity to demonstrate in writing that no action should be taken against you in this matter. Please submit any factual or legal materials which you believe are relevant to the Commission's analysis of this matter. Where appropriate, statements should be submitted under oath. Your response, which should be addressed to the General Counsel's Office, must be submitted within 15 days of receipt of this letter. If no response is received within 15 days, the Commission may take further action based on the available information.

This matter will remain confidential in accordance with Section 437g(a)(4)(B) and Section 437g(a)(12)(A) of Title 2 unless you notify the Commission in writing that you wish the matter to be made public. If you intend to be represented by counsel in this matter, please advise the Commission by completing the enclosed form stating the name, address, and telephone number of such counsel, and authorizing such counsel to receive any notifications and other communications from the Commission.

If you have any questions, please contact James Brown, the attorney assigned to this matter, at (202) 376-5690. For your information, we have attached a brief description of the Commission's procedures for handling complaints.

I have received your letter of June 20, 1989 requesting a response to the above referenced complaint from Mr. Fred Logan, Jr., State Chairman of the Kansas Republican Party regarding the filing of my Statement of Candidacy for the 1990 election.

I am writing to respond and request that no formal action be taken in this matter. If conciliation is appropriate, I would request your consideration of that method to resolve this issue. I have enclosed a Statement of Designation of Counsel authorizing Dan Watkins, the assistant treasurer of my campaign committee, to receive notifications and other communications from the commission and to act on my behalf on this matter.

The Slattery for Congress Committee held its only fundraising event of 1989 on May 16, 1989 and did receive more than \$5000 in contributions. I filed my Statement of Candidacy on June 6, 1989. In reviewing the FEC requirements and the dates of the receipts from that fundraising event, it is my judgement that my Statement of Candidacy should have been filed prior to June 6, 1989. Contributions to my Committee for the 1990 election cycle totaled \$5000 by April 26, 1989, meaning a Statement of Candidacy should have been filed by May 11, 1989.

The delay in filing this required statement was not intentional. It was an oversight and I have taken steps to make sure that any future filings will be made in a timely fashion.



Dear Fred:

I am writing to respond to your two recent media conferences in which you raised questions concerning the fundraising activities of the Slattery for Congress Committee. I understand you gave a copy of a letter to the press on May 16 addressed to Congressman Slattery with questions concerning the potential expenditure of funds raised by the Slattery for Congress Committee. While your questions have been reported in the press, your letter has not been received by the Congressman nor by the Slattery for Congress Committee. However, in the interest of setting the record straight, the Slattery for Congress Committee would like to provide some information about federal election laws and the operation of the Slattery for Congress Committee.

The Federal Election Commission requires a statement of organization designating a principal campaign committee. This statement is required to be filed each election cycle unless a candidate is redesignating the same principal campaign committee. In that case a Statement of Organization is required only if there is a change of information previously submitted on the form. The Slattery for Congress Committee has been redesignated as the principal campaign committee and the Statement of Organization information remains current with the most recent statement filed March 8, 1988.

The Statement of Candidacy filed June 6, 1989 designates the Slattery for Congress Committee as the Principal campaign committee for Congressman Jim Slattery. The address for the committee is PO Box 1978, Topeka, KS 66601 and its FEC ID # is C00148692-098230. Mike Van Dyke of Topeka is the Treasurer and Dan Watkins of Lawrence is the Assistant Treasurer. Mr. Van Dyke and I would both be willing to address questions you may have regarding the Slattery for Congress Committee.

As you know, the committee regularly files the required reports itemizing all contributions, expenditures and other information required by law. These reports are public information and are on file with the Kansas Secretary of State as well as the Federal Election Commission. They are reported by the media at filing times. In election years, seven reports are required including quarterly reports, a pre-primary election report, a pre-general election report, a post-general election report and a year end (4th quarter) report. In non-election years, two semi-annual reports are required. These reports provide regular and complete information about the contributions and expenditures of the Slattery for Congress Committee.

The Slattery for Congress Committee has ongoing expenses during an election cycle in both non-election and election years. The Committee has routinely raised funds for these authorized expenditures through fundraising events in Kansas and in Washington, D.C. during the off years, as well as during election years. The Committee's goal is to legally and adequately fund ongoing and congressional campaign expenses. The funds raised by the Slattery for Congress Committee legally cannot be and are not spent for any reason other than those allowed by a principal campaign committee for a federal office.

A copy of a letter from Scott Anderson regarding his letter to an unnamed individual which you released May 16 is enclosed for your information. It is clear the fundraising invitation and event were sponsored and paid for by the Slattery for Congress Committee. Funds raised from the reception will be used only for allowable expenditures under federal law and regulations. No committee to receive contributions in support of a possible Slattery for Governor candidacy exists. Although numerous offers of financial support for such a candidacy have been made, none have been accepted.


As stated earlier, all the contributions and expenditures of the Slattery for Congress Committee are a matter of public record and that record is regularly updated.

I. GENERATION OF MATTER

On June 14, 1989, Fred J. Logan, Jr. filed a complaint against U.S. Representative Jim Slattery ("Respondent"), alleging that the Respondent violated Section 432(e)(1) of the Act by not filing a Statement of Candidacy designating a Principal Campaign Committee within 15 days of raising or spending \$5,000 toward a 1990 candidacy.

II. FACTUAL AND LEGAL ANALYSIS

A. The Law

The Federal Election Campaign Act of 1971, as amended ("the Act") requires each candidate for Federal office to file a

Statement of Candidacy within 15 days after becoming a candidate which designates in writing a political committee to serve as his principal campaign committee. 2 U.S.C. § 432(e)(1). Under the Act, a person becomes a candidate once he has received contributions aggregating in excess of \$5,000 or has made expenditures aggregating in excess of \$5,000.

2 U.S.C. § 431(2). Within ten (10) days after it has been designated by the candidate, each principal campaign committee must file a Statement of Organization. 2 U.S.C. § 433(a). While each individual candidate must file a Statement of Candidacy for each election cycle, Statements of Organization apply to authorized campaign committees and are only filed once. See 2 U.S.C. § 432(e); 11 C.F.R. § 102.1(b); and MUR 2188. The Act and Commission Regulations provide for later amendment of a Statement of Organization if the information revealed by it changes in subsequent election cycles. 2 U.S.C. § 433(c); 11 C.F.R. § 102.2(a)(2).

B. The Facts

The Slattery for Congress Committee filed a Statement of Organization on March 10, 1988. That statement denoted that Jim Slattery was a Democratic candidate in the 1988 Kansas 2nd District U.S. House of Representatives election. The committee's financial reports have been consistently filed with the Commission, but no new Statement of Candidacy was filed until June 6, 1989. This filing apparently occurred after Complainant, the Kansas Republican State Chairman, released a

letter to the press on May 16, 1989, raising questions concerning the fundraising activities of the Slattery for Congress Committee. This Statement of Candidacy indicated Mr. Slattery's intention to be a candidate for the 1990 Kansas 2nd District U.S. House seat. While the Statement of Organization was amended by a change of treasurers on July 26, 1988, the Commission was notified of no other changes regarding the committee or the candidate until the June 6, 1989 Statement of Candidacy filing.

On July 5, 1989, the Commission received a response to the present complaint from Jim Slattery in which he acknowledges the delay in filing the required Statement of Candidacy for the 1990 election cycle. Respondent claims that the filing was not intentionally neglected, but rather resulted from an oversight. (Attachment I). The response states that the Slattery for Congress Committee held a fundraising event on May 16, 1989, at which more than \$5,000 in contributions was raised. The response further admits that contributions to the Slattery Committee for the 1990 election cycle totaled \$5,000 by April 26, 1989. After a telephone conversation with counsel for the Slattery Committee, and subsequent examination of the Slattery contribution records, it appears that the Committee actually crossed the \$5,000 threshold on April 28, 1989.¹ Jim Slattery did not file his Statement of Candidacy until June 6, 1989, thirty-nine (39) days after crossing the \$5,000 candidacy

1. In fact, approximately \$40,000 in contributions was received by the Committee by May 16, 1989.

threshold. This means that the statement was filed twenty-four (24) days late. The Slattery response states that steps have been taken to ensure that future filings will be made in a timely fashion. The response also asks that no formal action be taken, or if appropriate, pre-probable cause conciliation be undertaken.

Based on the foregoing analysis, it appears that Congressman Slattery failed to comply with the requirements for the timely filing of a Statement of Candidacy for the 1990 election cycle. This Office therefore recommends that the Commission find reason to believe that U.S. Representative Jim Slattery violated 2 U.S.C. § 432(e)(1).

1. Find reason to believe that U. S. Representative James Charles Slattery violated 2 U.S.C. § 432(e)(1), and enter into conciliation prior to a finding of probable cause to believe.

The attached agreement contains no changes from the agreement approved by the Commission on September 29, 1989.



IV. The pertinent facts in this matter are as follows:

1. Respondent is a candidate in the 1990 Kansas 2nd Congressional district election.

2. Respondent was required to file a Statement of Candidacy no later than 15 days after becoming a candidate pursuant to 2 U.S.C. § 432(e)(1).

3. Respondent's authorized committee received contributions which aggregated in excess of \$5,000 as of April 28, 1989.

4. Respondent was required to file a Statement of Candidacy by May 13, 1989. Respondent filed his Statement of Candidacy on June 6, 1989.

V. Respondent did not file his Statement of Candidacy in a timely manner thus violating 2 U.S.C. § 432(e)(1).

VI. Respondent will pay a civil penalty to the Federal Election Commission in the amount of three hundred dollars (\$300), pursuant to 2 U.S.C. § 437g(a)(5)(A).


VII. The Commission, on request of anyone filing a complaint under 2 U.S.C. § 437g(a)(1) concerning the matters at issue herein or on its own motion, may review compliance with this agreement. If the Commission believes that this agreement or any requirement thereof has been violated, it may institute a civil action for relief in the United States District Court for the District of Columbia.

VIII. This agreement shall become effective as of the date that all parties hereto executed same and the Commission has approved the entire agreement.


