**III. BACKGROUND:**

**Failure to File a Required Report of Receipts and Disbursements**

The Sibley for Congress committee ("the Committee") has failed to file the 1990 April Quarterly Report of Receipts and Disbursements. Prior Notices were sent February 5 and March 22, 1990, informing the Committee that the report was due on April 15, 1990 (Attachment 2). A Non-Filer Notice was sent to the Committee on May 7, 1990, for failure to file the report (Attachment 3). The Non-Filer Notice informed the Committee that failure to file this report might result in audit or legal enforcement action.

On June 4 and 7, 1990, a Reports Analysis Division analyst attempted to reach both the treasurer and the candidate. The analyst was unable to contact the treasurer on both dates. The analyst did speak with someone at the candidate's residence. The analyst requested on June 4 and 7 that Mr. Sibley return the call as soon as possible because the analyst had an urgent matter to discuss with him. Both times the analyst was told that Mr. Sibley would return the call.

As of this date, the 1990 April Quarterly Report has not been filed.

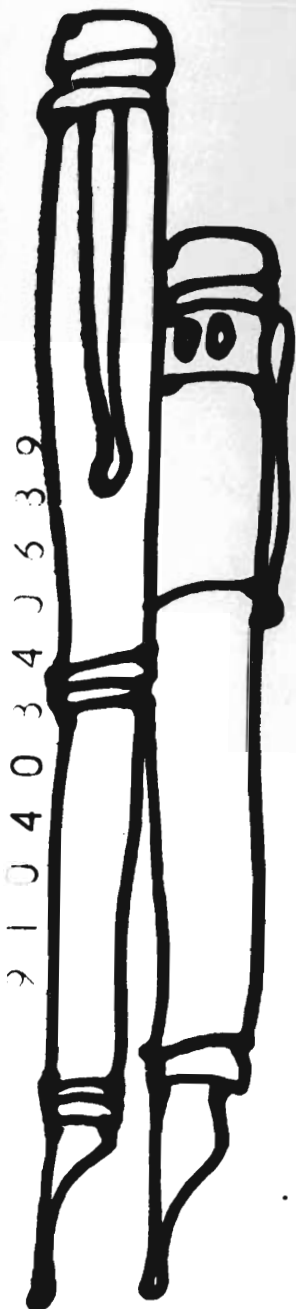

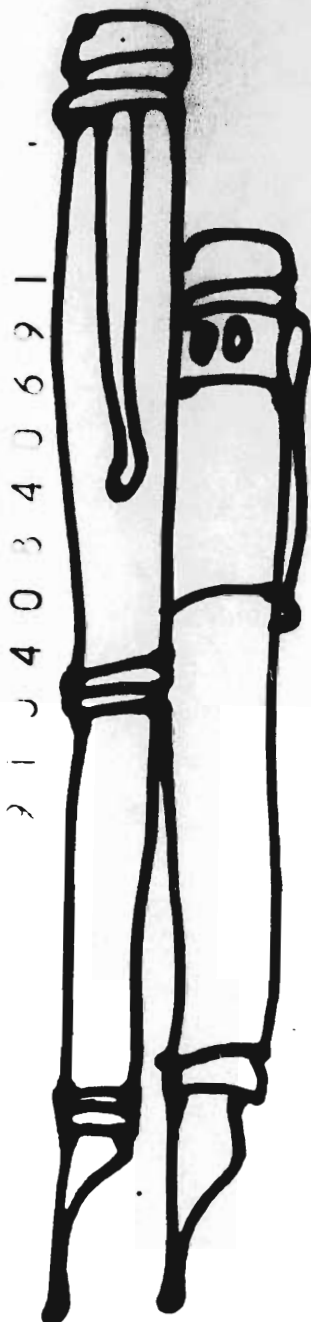

Dear Dr. McCall:

On October 17, 1990, the Federal Election Commission found that there is reason to believe Sibley for Congress ("Committee") and you, as treasurer, violated 2 U.S.C. § 434(a)(2)(A)(iii), a provision of the Federal Election Campaign Act of 1971, as amended ("the Act"). The Factual and Legal Analysis, which formed a basis for the Commission's finding, is attached for your information.

Under the Act, you have an opportunity to demonstrate that no action should be taken against the Committee and you, as treasurer. You may submit any factual or legal materials that you believe are relevant to the Commission's consideration of this matter. Please submit such materials to the General Counsel's Office within 15 days of your receipt of this letter. Where appropriate, statements should be submitted under oath.

In the absence of any additional information demonstrating that no further action should be taken against the Committee and you, as treasurer, the Commission may find probable cause to believe that a violation has occurred and proceed with conciliation.

In order to expedite the resolution of this matter, the Commission has also decided to offer to enter into negotiations directed towards reaching a conciliation agreement in settlement of this matter prior to a finding of probable cause to believe. Enclosed is a conciliation agreement that the Commission has approved.

If you are interested in expediting the resolution of this matter by pursuing preprobable cause conciliation and if you agree with the provisions of the enclosed agreement, please sign and return the agreement, along with the civil penalty, to the Commission. In light of the fact that conciliation negotiations, prior to a finding of probable cause to believe, are limited to a maximum of 30 days, you should respond to this notification as soon as possible.

Requests for extensions of time will not be routinely granted. Requests must be made in writing at least five days prior to the due date of the response and specific good cause must be demonstrated. In addition, the Office of the General Counsel ordinarily will not give extensions beyond 20 days.

If you intend to be represented by counsel in this matter, please advise the Commission by completing the enclosed form stating the name, address, and telephone number of such counsel, and authorizing such counsel to receive any notifications and other communications from the Commission.

This matter will remain confidential in accordance with 2 U.S.C. §§ 437g(a)(4)(B) and 437g(a)(12)(A), unless you notify the Commission in writing that you wish the investigation to be made public.

**SUMMARY OF ALLEGATIONS**

It is alleged that the Sibley for Congress and Dr. Abner V. McCall, as treasurer (the "Committee") failed to file its 1990 April and July Quarterly Reports in violation of 2 U.S.C. § 434(a)(2)(A)(iii).

**FACTUAL AND LEGAL ANALYSIS**

The Federal Election Campaign Act of 1971, as amended (the "Act"), provides that for years in which regularly scheduled congressional elections are held, the treasurer of the principal campaign committee shall file quarterly reports on behalf of the committee no later than the 15th day after the last day of each calendar quarter. 2 U.S.C. § 434(a)(2)(A)(iii).

David Sibley was a candidate for the U.S. House of Representatives from the 11th congressional district of the state of Texas in the March 13, 1990 primary election. According to the Statement of Organization filed with the Commission, Sibley for Congress is the principal campaign committee of David Sibley and Dr. Abner V. McCall, is the treasurer. Pursuant to 2 U.S.C. § 434(a)(2)(A)(iii),

respondents were required to file the 1990 April Quarterly Report no later than April 15, 1990. Pursuant to 2 U.S.C. § 434(a)(2)(A)(iii), respondents were required to file the 1990 July Quarterly Report no later than July 15, 1990.

The Committee was notified on February 5 and March 22, 1990 that the 1990 April Quarterly Report was due on April 15, 1990. On May 7, 1990 the Committee was sent a Non-Filer Notice for failing to file the report. On August 6, 1990 the Committee was sent a second Non-Filer Notice for the failing to file the report. Both Notices informed the Committee that failure to file the reports might result in audit or legal enforcement action.

On June 21, 1990 the Committee was notified that the 1990 July Quarterly Report was due on July 15, 1990. On August 6, 1990 the Committee was sent a Non-Filer Notice for failing to file the 1990 July Quarterly Report. The Notice informed the Committee that failure to file the report might result in audit or legal enforcement action.

The Committee has not yet filed the 1990 April and July Quarterly Reports. Therefore, there is reason to believe that Sibley for Congress and Dr. Abner V. McCall, as treasurer violated 2 U.S.C. § 434(a)(2)(A)(iii).

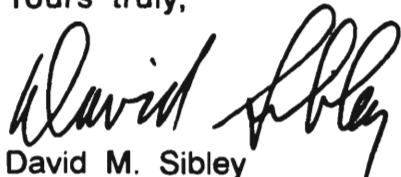

RESPONDENT'S ANSWER  
Factual Analysis

David Sibley was a candidate for the U.S. House of Representatives from the 11th congressional district of Texas. He was defeated in the March 13, 1990, primary election. He missed the run-off election by 200 votes out of 25,000 cast. The Sibley for Congress campaign office was closed down on March 15, 1990.

While Abner McCall was the treasurer, he had no duties other than as figurehead treasurer for the campaign. The responsibility for filing the reports was not his and I respectfully request that his name be dropped from any further proceedings and that the name of David Sibley be substituted for Dr. Abner McCall.

When the campaign was shut down, the responsibility for filing the final report was assigned to a campaign worker. The April 15 and July 15 reports were not filed in a timely manner and the responsibility falls on David Sibley.

The Sibley for Congress Committee was not given notice of the failure to file the reports. I am told that notices were mailed, but I do not remember receiving any notices. The termination report has been filed (copy enclosed). This termination report is identical to the report that should have been filed April 15, 1990, thus making the July 15 report unnecessary. Please accept this report in lieu of the April 15 and July 15 reports.

RESPONDENT'S ARGUMENT

While it is true that the report was not filed on time, it was due to an administrative oversight, not some scheme concocted to make money or hide contributions. It was not a willful, knowing or intentional violation. As you can see from the report, my campaign was underfunded to begin

with. I have never run for federal office before and started with no money on December 26, 1989, when I decided to run.

I was a serious candidate for this office. I missed the run-off by 200 votes out of 20,000 cast even though I was outspent by my opponents by 7 to 1 ratio (\$400,000 to \$57,000). I won 50% of McLennan County, my home county and the largest in the district, even though I was outspent by another McLennan County resident by a ratio of 4 to 1.

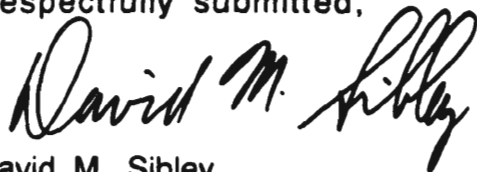
I have suffered professionally and financially because I ran for office. In order to run I resigned my position as Assistant District Attorney.

I am not a wealthy man. There is no way I can fund my own campaign or afford legal counsel for this matter. I would have received a promotion to felony prosecutor had I not resigned. When I returned to the DA's office, the felony prosecutor position was filled and I am still waiting for the promotion. It cost me a great deal to run in terms of professional advancement and money.

It also cost me a great deal in terms of time with my family. My wife of 20 years and I have three children, aged 14, 12 and 10. I have always coached my boys' basketball teams until this year when I gave up the teams in order to run.

Surely the ends of justice and the purpose of the Federal Election Commission will not be advanced by fining me a large amount of money for so small a violation, especially since no notice was received of any pending action. I realize the importance of the job you do in supervising campaigns and I assure you that the failure to report was not intentional. Any fine will be paid with borrowed money and will come at the expense of my family, not some PAC or fat cat supporter.

CONCILIATION AGREEMENT

This matter was initiated by the Federal Election Commission ("Commission"), pursuant to information ascertained in the normal course of carrying out its supervisory responsibilities. The Commission found reason to believe that Sibley for Congress and David M. Sibley, as treasurer ("Respondents") violated 2 U.S.C. § 434(a)(2)(A)(iii).

NOW, THEREFORE, the Commission and the Respondents, having participated in informal methods of conciliation, prior to a finding of probable cause to believe, do hereby agree as follows:

I. The Commission has jurisdiction over the Respondents and the subject matter of this proceeding, and this agreement has the effect of an agreement entered pursuant to 2 U.S.C. § 437g(a)(4)(A)(i).

II. Respondents have had a reasonable opportunity to demonstrate that no action should be taken in this matter.

III. Respondents enter voluntarily into this agreement with the Commission.

IV. The pertinent facts in this matter are as follows:

1. David Sibley was a candidate for the U.S. House of Representatives in the 1990 Primary Election. Sibley for Congress is an authorized political committee for Mr. Sibley's congressional campaign.

2. David M. Sibley is the treasurer of Sibley for Congress.

3. Section 434(a)(2)(A)(iii) of Title 2 provides that for years in which regularly scheduled congressional elections are held, principal campaign committees shall file quarterly reports no later than the 15th day after each calendar quarter.

4. Respondents were required to file the 1990 April Quarterly Report no later than April 15, 1990.

5. Respondents were required to file the 1990 July Quarterly Report no later than July 15, 1990.

6. Respondents filed a Termination Report covering activity from February 22, 1990 through "Final," on October 30, 1990. The Termination Report disclosed receipts totaling \$14,161 and disbursements totaling \$25,172.

7. The financial information contained in the Termination Report for the period covering January 1, 1990 through March 31, 1990 was disclosed 198 days late.

8. The financial information contained in the

Termination Report for the period covering April 1, 1990 through June 30, 1990 was disclosed 107 days late.

V. 1. Respondents failed to timely file the 1990 April Quarterly Report in violation of 2 U.S.C. § 434(a)(2)(A)(iii).

2. Respondents failed to timely file the 1990 July Quarterly Report in violation of 2 U.S.C. § 434(a)(2)(A)(iii).

VI. 1. Respondents will pay a civil penalty to the Federal Election Commission in the amount of one thousand dollars (\$1,000), pursuant to 2 U.S.C. § 437g(a)(5)(A).

VII. The Commission, on request of anyone filing a complaint under 2 U.S.C. § 437g(a)(1) concerning the matters at issue herein or on its own motion, may review compliance with this agreement. If the Commission believes that this agreement or any requirement thereof has been violated, it may institute a civil action for relief in the United States District Court for the District of Columbia.

VIII. This agreement shall become effective as of the date that all parties hereto have executed same and the Commission has approved the entire agreement.

IX. Respondents shall have no more than 30 days from the date this agreement becomes effective to comply with and implement the requirement contained in this agreement and to so notify the Commission.

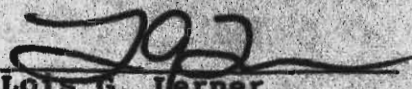

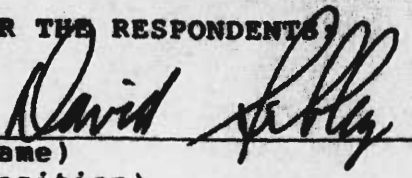
