III. BACKGROUND:

- A. Chronic Late Filing of Reports, Failure to File the 1989 Year End Report by Election Day, November 6, 1990 and Failure to File the 1990 Year End Report

The Committee for Quality Hospital Care ("the Committee") failed to file five (5) Reports of Receipts and Disbursements in a timely manner for the 1989-1990 election cycle (see Chart and Attachments). Three of the reports (the 1990 April Quarterly, July Quarterly and the 30 Day Post-General Reports) were filed between eight (8) and one hundred eighty-five (185) calendar days late. Additionally, the Committee failed to file the 1989 Year End Report by Election Day, November 6, 1990. The Committee also has failed to file the 1989 and 1990 Year End Reports.

A Prior Notice was sent to the Committee on December 27, 1989 as a reminder to the Committee that the 1989 Year End filing deadline was January 31, 1990 (Attachment 2). A Non-Filer Notice was sent to the Committee on December 5, 1990 for failing to file the 1989 Year End Report (Attachment 3).

A Chronic Late Filer Notice was sent to the Committee on December 6, 1990, for failing to file the 1989 Year End, 1990 April Quarterly and the 1990 July Quarterly Reports in a timely manner (Attachment 8). The Notice advised the Committee that any additional late filing of reports may result in legal enforcement action. Subsequent to sending the Chronic Late Filer Notice, the Committee failed to file the 1990 Year End Report in a timely manner. A Prior Notice was sent to the Committee on December 27, 1990 to remind the Committee of the 1990 Year End Report filing deadline (Attachment 10).

On January 24, 1991, Mike McGrail called the Reports Analysis Division ("RAD") analyst to request an extension to the 1990 Year End filing deadline date. The analyst informed Mr. McGrail that the Commission did not grant extensions to filing deadline dates and asked the Committee to submit the Year End Report as soon as possible (Attachment 11).

On January 25, 1991, the analyst called the treasurer of the Committee, Bernard Flynn, and left a message with Mr. Flynn's secretary to return the call. Mr. Flynn called the analyst later that day. The analyst asked Mr. Flynn to file the 1989 Year End Report and reminded him of the 1990 Year End filing deadline date (Attachment 12).

On February 22, 1991 a Non-Filer Notice was sent to the Committee (Attachment 13). On March 13, 1991, the analyst called Paul Moran, the assistant treasurer of the Committee to discuss the omitted 1990 Year End Report. Mr. Moran informed the analyst that the 1990 Year End Report would be sent to the Commission within two days (Attachment 14). As of this date, neither the 1989 Year End Report nor the 1990 Year End Report has been filed.

**B. Failure to Clarify Source of Initial Cash-on-Hand**

On August 3, 1989, the Committee submitted its first report subsequent to registering with the Commission. The Committee's 1989 Mid-Year Report reported \$26,613.48 on Line 6(a), Column B of the Summary Page. This amount reflected the total cash-on-hand as of December 15, 1988 (Attachment 15).

A Request for Additional Information ("RFAI") was sent to the Committee on March 21, 1990, requesting the source of the Committee's initial cash-on-hand (Attachment 16). As the Committee did not respond to the RFAI, a Second Notice was sent on April 12, 1990 (Attachment 17). The Committee did not respond.

On May 17, 1990, a representative of the Committee, Ms. Genette Orsino, called the analyst to clarify the Commission's RFAI. The analyst informed Ms. Orsino that the Commission needed to know the source of the Committee's initial cash-on-hand in order to determine the permissibility of those funds. Ms. Orsino claimed that the initial cash-on-hand total was comprised of individual contributions that covered the Committee's \$26,613.48 initial cash-on-hand at the time of registration. The analyst asked the Committee to submit an amendment supporting that claim and Ms. Orsino agreed to follow the analyst's instructions (Attachment 18). The Committee failed to respond.

On January 25, 1991, the analyst called Mr. Flynn to discuss the Committee's source of initial cash (Attachment 12). Mr. Flynn said that he would file an amendment documenting that the Committee's initial cash-on-hand at its time of registration consisted of individual contributions permissible under the Act.

On March 13, 1991, the analyst called Paul Moran, assistant treasurer of the Committee. Mr. Moran informed the analyst that he would have a response concerning the Committee's source of initial cash submitted by March 22, 1991. As of this date, an amendment has not been filed (Attachment 14).

**I. GENERATION OF MATTER**

The Reports Analysis Division ("RAD") referred The Committee for Quality Hospital Care ("Committee") and Bernard D. Flynn, as treasurer, to the Office of the General Counsel on April 18, 1991. See Attachment 1. The basis of the attached RAD referral is the Committee's failure to file or to timely file several Reports of Receipts and Disbursements in accordance with 2 U.S.C. § 434(a)(4)(A)(i), (iii) and (iv), provisions of the Federal Election Campaign Act, as amended, ("the Act"). The Committee failed to timely file the 1990 April Quarterly, July Quarterly and 30 Day Post-General Reports. Also, the Committee failed to file the Year End Reports for 1989 and 1990. The Committee was also referred for failure to clarify its initial cash on hand, totaling \$26,613.48, in accordance with

2 U.S.C. § 434(b)(3) and 11 C.F.R. § 104.12.

II. FACTUAL AND LEGAL ANALYSIS

On August 3, 1989, the Committee submitted the 1989 Mid-Year Report, its first report subsequent to registering with the Commission. This Report reflected \$26,613.48 in cash on hand as of December 15, 1988. See Attachment 1 at page 25. On March 21, 1990 RAD sent the Committee a Request for Additional Information ("RFAI") concerning the source of the Committee's initial cash on hand. The RFAI, as well as a Second Notice sent on April 12, 1990, failed to elicit a response from the Committee concerning this issue. Despite several telephone conversations between the RAD analyst and Committee officials, the Committee has failed to respond to the Commission's inquiries regarding this issue.

Pursuant to 11 C.F.R. § 104.12, political committees which have cash on hand at the time of registration shall disclose on their first report the source of such funds. Furthermore, full disclosure concerning the source of initial cash on hand includes contributor identification information required by 11 C.F.R. § 104.3(a) and 2 U.S.C. § 434(b)(3). To date, the Committee has not identified its source of initial cash on

hand.<sup>2</sup> Therefore, this Office recommends that the Commission find reason to believe that The Committee for Quality Hospital Care and Bernard D. Flynn, as treasurer, violated 2 U.S.C. § 434(b)(3) and 11 C.F.R. § 104.12. This Office intends to inquire about the Committee's source of initial cash on hand to determine if any further violations of the Act have occurred with regard to the Committee's possible acceptance of excessive or prohibited contributions.

For the Factual and Legal Analysis concerning the Committee's failure to file and failure to timely file certain reports of receipts and disbursements, see Attachment 2. This Office does not recommend that the Commission offer to enter into pre-probable cause conciliation concerning the Committee's unfiled and untimely filed reports until the issue regarding the Committee's source of initial cash on hand has been fully investigated.

### III. RECOMMENDATIONS

1. Open a MUR.
2. Find reason to believe that The Committee for Quality Hospital Care and Bernard D. Flynn as treasurer violated 11 C.F.R. § 104.12 and 2 U.S.C. § 434(b)(3).
3. Find reason to believe that The Committee for Quality Hospital Care and Bernard D. Flynn, as treasurer, violated 2 U.S.C. § 434(a)(4)(A)(i), (iii) and (iv).



On June 24, 1991, the Federal Election Commission found that there is reason to believe The Committee for Quality Hospital Care ("Committee") and you, as treasurer, violated 2 U.S.C. §§ 434(b)(3), 434(a)(4)(A)(i), (iii), and (iv), as well as 11 C.F.R. § 104.12, provisions of the Federal Election Campaign Act of 1971, as amended ("the Act"). The Factual and Legal Analysis, which formed a basis for the Commission's finding, is attached for your information.

Under the Act, you have an opportunity to demonstrate that no action should be taken against the Committee and you, as treasurer. You may submit any factual or legal materials that you believe are relevant to the Commission's consideration of this matter. Please submit such materials to the General Counsel's Office, along with an accounting of the Committee's initial cash on hand, within 15 days of your receipt of this letter. Where appropriate, statements should be submitted under oath.

In the absence of any additional information demonstrating that no further action should be taken against the Committee and you, as treasurer, the Commission may find probable cause to believe that a violation has occurred and proceed with conciliation.

If you are interested in pursuing pre-probable cause conciliation, you should so request in writing. See 11 C.F.R. § 111.18(d). Upon receipt of the request, the Office of the General Counsel will make recommendations to the Commission either proposing an agreement in settlement of the matter or recommending declining that pre-probable cause conciliation be pursued. The Office of the General Counsel may recommend that pre-probable cause conciliation not be entered into at this time so that it may complete its investigation of the matter. Further, the Commission will not entertain requests for pre-probable cause conciliation after briefs on probable cause have been mailed to the respondent.



On August 3, 1989, The Committee for Quality Hospital Care ("Committee") submitted the 1989 Mid-Year Report, its first report subsequent to registering with the Commission. This Report reflected \$26,613.48 in cash on hand as of December 15, 1988. On March 21, 1990 the Reports Analysis Division ("RAD") sent the Committee a Request for Additional Information ("RFAI") concerning the source of the Committee's initial cash on hand. The RFAI, as well as a Second Notice sent on April 12, 1990, failed to elicit a response from the Committee concerning this issue. Despite several telephone conversations between the RAD analyst and Committee officials, the Committee has failed to respond to the Commission's inquiries regarding this issue.

Pursuant to 11 C.F.R. § 104.12, a provision of the Commission's regulations, political committees which have cash on hand at the time of registration shall disclose on their first report the source of such funds. Furthermore, full disclosure concerning the source of initial cash on hand includes contributor identification information required by 11 C.F.R. § 104.3(a), as well as 2 U.S.C. § 434(b)(3), a provision of the Federal Election Campaign Act, as amended, ("the Act"). To date, the Committee has not identified its source of initial cash on hand. Therefore, there is reason to believe that The Committee for Quality Hospital Care and Bernard

D. Flynn, as treasurer, violated 2 U.S.C. § 434(b)(3) and 11 C.F.R. § 104.12 by failing to disclose the source of initial cash on hand.

Concerning the filing of Reports of Receipts and Disbursements, the Act provides that an unauthorized committee, filing quarterly, shall file quarterly reports in a calendar year in which a regularly scheduled general election is held. 2 U.S.C. § 434(a)(4)(A)(i). Quarterly Reports are to be filed no later than the 15th day after the last day of each calendar quarter. Id. Furthermore, pursuant to 2 U.S.C. § 434(a)(4)(A)(iii), a post-general election report must be filed no later than the 30th day after the general election and shall be complete as of the 20th day after such general election. The Act also provides that in any other calendar year, a report covering the period beginning July 1 and ending December 31 shall be filed no later than January 31 of the following calendar year. 2 U.S.C. § 434(a)(4)(A)(iv). Thus, the due date for the 1989 Year End Report was January 31, 1990, the due date for the 1990 April Quarterly Report was April 15, 1990, the due date for the 1990 July Quarterly Report was July 15, 1990, the due date for the 1990 30 Day Post-General Report was December 6, 1990 and the due date for the 1990 Year End Report was January 31, 1991.

The Committee has failed to file its 1989 and 1990 Year End Reports, filed activity which was to be filed separately as the 1990 April and July Quarterly Reports on October 17, 1990 as part of the October Quarterly Report and filed the 1990 30 Day

Post-General Report on December 14, 1990. Therefore, there is reason to believe that The Committee for Quality Hospital Care and Bernard D. Flynn, as treasurer, violated 2 U.S.C.

§ 434(a)(4)(i), (iii) and (iv) by failing to file the 1989 and 1990 Year End Reports and failing to timely file the 1990 April and July Quarterly Reports, as well as the 1990 30 Day Post-General Report.



I. BACKGROUND

On June 24, 1991, the Commission found reason to believe that the Committee for Quality Hospital Care ("Committee") and Bernard Flynn, as treasurer, violated 2 U.S.C. § 434(a)(4)(A)(i), (iii), and (iv) by filing several late reports during the 89-90 cycle. The Commission also found reason to believe the Committee violated 2 U.S.C. § 434(b)(3) based upon the Committee's failure to disclose the source of its initial cash on hand upon its registration as a federal political committee.

II. ANALYSIS

In response to informal requests, the Committee has begun to provide this Office with copies of its state reports prior to its registration with the Commission, to address the issue of the initial cash on hand (the voluminous reports will be circulated to the Commission at a later date). As part of its July 12, 1991 submission, the Committee has requested conciliation in this matter (Attachment 1, p. 1). This Office has been following up the Committee's submissions and the issue of the Committee's initial cash on hand is not yet resolved. Furthermore, while this

matter was pending, on August 27, 1991, the Commission voted to refer the Committee for a threshold audit pursuant to 2 U.S.C. § 438(b). On October 21, 1991, the field audit of this committee began. Because of the outstanding factual issues, as well as the audit now in progress, this Office recommends the Commission decline at this time the request for pre-probable cause conciliation.

### III. RECOMMENDATIONS


1. Decline, at this time, to enter into conciliation with the Committee for Quality Hospital Care, and Bernard Flynn, as treasurer, prior to a finding of probable cause to believe.
2. Approve the appropriate letter.



I. BACKGROUND

On June 24, 1991, the Commission found reason to believe that the Committee for Quality Hospital Care ("Committee") and Bernard Flynn, as treasurer, violated 11 C.F.R. § 104.12 and 2 U.S.C. § 434(b)(3), based upon the Committee's failure to disclose the source of its initial cash on hand upon its registration as a federal political committee. The Commission also found reason to believe the Committee violated 2 U.S.C. § 434(a)(4)(A)(i), (iii), and (iv) by non-filing or late filing of several reports during the 89-90 cycle.

II. ANALYSIS

In response to informal requests, the Committee provided this Office with copies of its state reports prior to its registration with the Commission, to address the issue of the initial cash on hand. Furthermore, while this matter was pending, on August 27, 1991, the Commission voted to refer the Committee for a threshold audit pursuant to 2 U.S.C. § 438(b). After completion of the audit fieldwork, this Office has had informal discussions with the field auditors about their findings. The Committee originally disclosed \$26,613.48 as its

original cash on hand. The audit, however, revealed that the correct figure is \$27,282.39. According to the Audit staff, the remaining findings by Audit are remediable by the Committee and if so are not referable to this Office.



I write in an effort to persuade you that no action should be taken in MUR #3348. If, notwithstanding the arguments advanced herein, the Office of General Counsel and the Commission believe that action of some type is warranted, it is my further position that Bernard Flynn should not be a named respondent and that the Committee should pay no civil penalty

1. The History Of The Committee For Quality Hospital Care Demonstrates That It Was Essentially A Massachusetts Multi-Candidate Committee Subject to State Regulation Which In Broad Contours Parallels the Federal Scheme.

The Interim Report of the Audit Division indicates that the Committee for Quality Hospital Care (CQHC) registered with the Federal Election Commission on December 5, 1988. It goes on to observe that the Committee reported an opening cash balance of \$26,613.48.

Attachment "A" to this submission is a copy of Massachusetts Form CPF 102 filed on January 10, 1989 with the Massachusetts Office of Campaign and Political Finance by the Committee for Quality Hospital Care. Line 5 of the form indicates an ending balance of \$26,613.48 - the exact same figure reported as an opening balance by the federal committee. Obviously the "source" of the opening balance was the pre-existing state multi-candidate committee.

This graphic illustration that the federal committee is an outgrowth of the state multi-candidate committee of the same name with no true independent identity is further illustrated elsewhere in the Interim Report and Attachment A. For instance, of the twenty four contributions identified by audit staff as requiring itemization under 11 CFR 104.12, eleven are reflected in the state campaign finance form. All but four<sup>1</sup> of the remaining thirteen were reported to state authorities earlier in calendar 1988. See Attachments B and C. In each instance the name, residential address and amount of money contributed was duly listed on the state form. This information was required by M.G.L. c. 55, §18 and was public record from the moment it was filed. Thus, although the state statute does not require a listing of donors' occupations, the majority of the data required by federal law to be disclosed was disclosed years ago.

An interested person or regulator could draw no conclusion other than that the Committee for Quality Hospital Care organized under federal law with the Commission and the Committee for Quality Hospital Care organized at the state level pursuant to M.G.L. c. 55, §5 were one and the same. They had the same name, the same treasurer and the same bank balance. All of the CQHC's money was raised and expended within the Commonwealth in 1988. If public disclosure of the sources of contributions is the underlying goal of 11 CFR 104.12, that goal was fully realized here. Since virtually all information required by federal law was required as well by state law and then treated as public information, any violation of the federal regulatory scheme concerning the disclosure of source(s) of cash on hand was a matter of form only. In this context, the provisions of 11 C.F.R. 104.7 could conceivably come into play (when a treasurer demonstrates "best efforts" have been used, compliance with the act is assumed).

The essential state nature of the CQHC at the time it registered with the Commission is further illustrated by reference

to the "Expenditures" section of its state form (Attachment A). Twenty-nine "fund-raising" expenditures were listed on it - all reflect contributions to state candidates or committees. Attachment B similarly reflects eight fund-raising transfers to state candidates or committees and Attachment C details thirty contributions to such entities. Of the sixty seven contributions made by CQHC in 1988, not one was to a federal candidate.

Although it ultimately did make contributions to federal candidates, CQHC always remained a state dominated committee. In the first reporting period of its federal existence, CQHC made 27 contributions totalling \$12,200 to Massachusetts candidates and 1 for \$500 to a committee organized for a Congressional candidate. In the second half of 1989, 21 contributions totalling \$12,700 were made to political committees formed for state candidates and 6 contributions amounting to \$2,650 were made to committees organized under federal law. In 1990 all of the CQHC's receipts once again came from in-state sources. The Committee gave \$28,550 to 63 state candidates or committees and \$3,500 to 6 federal candidates or committees that year. In the two years covered by the FEC's audit, CQHC made only eight contributions totalling \$6,650 to federal candidates.

Meanwhile it gave more than \$50,000 to more than 100 state candidates. These numbers demonstrate beyond cavil the fact that CQHC was basically a multi-candidate committee organized under Massachusetts law.

Conceding for present purposes that the reports CQHC should have filed with the FEC in 1989 and 1990 were not timely filed, I submit that is in some part a function of its state committee-like nature. Even as Massachusetts law differs from federal in that it does not require the disclosure of donors' occupations, (compare M.G.L. c. 55, §18 with 2 U.S.C. 434(b) and 11 C.F.R. 104.3) so too does it have a different schedule for reports. That differing state schedule is again set forth in M.G.L. c. 55, §18, and contrasts with that in 2 U.S.C. 434g(a)(2) and 11 C.F.R. 104.5. I recognize that when an entity such as CQHC decides it wants to function as both a federal and a state committee it must comply

with two regulatory regimes. Technical compliance with both schemes, however, would have required a degree of vigilance that a changing leadership could not provide.

At page 2 of the Interim Report of the Audit Division on CQHC under the heading "Key Personnel" it is observed that William Guenther was the treasurer of the Committee from its inception until 2/9/89. It is obvious from this one fact that at the critical earliest stages of its federal existence, CQHC experienced a shift in responsible personnel. The magnitude of the change in leadership is not even intimated by the report. As a factual matter, virtually everyone associated with the initial determination to "go national" left, making it inevitable that the vigilance and attention required by CQHC's hybrid status would not occur.

Mr. Guenther replaced Roger Sullivan as treasurer of the state multi-candidate committee in the fall of 1988. He was himself replaced by Bernard Flynn less than six months later. When Mr. Guenther formed CQHC federally, he was an executive vice president of the Massachusetts Hospital Association.<sup>3</sup> He left in 1989 to form his own consulting business. Patrick Carroll, one of the initial contributors required to be itemized by schedule A of the Interim Report, was the Association's General Counsel at the time CQHC became subject to federal law. He retired in 1989. On the recommendation of one of the Association's legislative agents, Jeanette Orsino (who appears as a contributor on Attachment D), Mr. Carroll sought outside legal counsel for the Committee's start-up effort. That attorney was Alexander G. Gray, former

chief of the elections division in the state Attorney General's office. Mr. Gray's stint with CQHC was short-lived. In 1989 he opted to return to state service. He accepted employment as General Counsel at the State Department of Social Services, where he remains today. Because he was permitted no outside practice, Attorney Gray refunded the bulk of his retainer to CQHC, a fact reflected in the 1989 year-end report recently filed with the FEC. Thus in 1989, its first year of federal existence, all the key personnel associated with CQHC turned over.

With the departure of Messrs. Guenther, Carroll and Gray, the respondent Bernard Flynn was left holding the proverbial bag. Unfamiliar with state and federal campaign finance law, he became responsible to ensure compliance with both statutes. Non-compliance was inevitable not because of any failing on Mr. Flynn's part, but simply because the effort to fit the square peg state committee into the round hole of federal campaign finance law required an attention to detail he could not provide.

3. CQHC Has Now Satisfied The Reporting Requirements Of The Federal Law By Complying With All Of The Recommendations Of The Audit Division.

For the past several months personnel associated with CQHC have worked cooperatively with staff of the Audit Division to reconcile its filings. Working in part from the state forms which have long since been public, they have been able to prepare and file all the reports required of them by federal law and to meet all of the recommendations set forth in the Interim Report of the Audit Division. Specifically they have filed:

1. An amended Detailed Summary page with accompanying memo Schedule A (Itemized Receipts) to disclose the source of beginning cash on hand and confirm that it came through the previously publicly disclosed contributions to the state multi-candidate committee. This filing meets recommendation #1 of the Audit Division's Interim Report.

2. Comprehensive amendments covering the period from December 15, 1988, through June 30, 1989 and for calendar year 1989 correcting reported receipts and disbursements for

both period and cash on hand. These amendments meet recommendations #2 and #4 of the Audit Division's Interim Report.

3. A Year End Report for 1989 including all reportable activity and itemizing receipts/disbursements as suggested in recommendation #3. All of the information on the Report (except occupations of donors) has previously been publicly reported to the Massachusetts Office of Campaign and Political Finance.

Cumulatively these filings also contain the information requested by recommendation #5. That information and more have already been provided to the Audit Division, which has been able to reconcile and reform its report based on the information provided. No further filings are required to bring CQHC into full compliance with the laws enforced by the Commission. If nothing else, this militates against a civil penalty. It is worth noting that a new treasurer has also taken responsibility and that he is the individual who has worked most closely with the Audit Division to bring the CQHC into compliance. If the CQHC is to remain a federally organized body, a matter worth discussing, the designation of Paul Moran as Treasurer should promote future adherence to the letter as well as the spirit of the law.


#### Conclusion

Although federal law may technically have been violated, no action should be taken in MUR #3348. That is because (1) the federal reporting requirements have now been met; (2) the belated nature of CQHC's compliance with federal disclosure requirements is offset by the fact that virtually all of the information required was previously publicly disclosed through Massachusetts' parallel reporting system; and (3) the respondents were not personally responsible for the technical violations of law and have since demonstrated the utmost good faith.





CONCILIATION AGREEMENT

This matter was initiated by the Federal Election Commission ("Commission"), pursuant to information ascertained in the normal course of carrying out its supervisory responsibilities. The Commission found reason to believe that The Committee for Quality Hospital Care and its treasurer ("Respondents") violated 11 C.F.R. § 104.12 and 2 U.S.C. §§ 434(a)(4)(A)(i), (iii), and (iv) and 434(b)(3).

NOW, THEREFORE, the Commission and the Respondents, having participated in informal methods of conciliation, prior to a finding of probable cause to believe, do hereby agree as follows:

I. The Commission has jurisdiction over the Respondents and the subject matter of this proceeding, and this agreement has the effect of an agreement entered pursuant to 2 U.S.C. § 437g(a)(4)(A)(i).

II. Respondents have had a reasonable opportunity to demonstrate that no action should be taken in this matter.

III. Respondents enter voluntarily into this agreement with the Commission.

IV. The pertinent facts in this matter are as follows:

1. The Committee for Quality Hospital Care is a political committee within the meaning of 2 U.S.C. § 431(4). It registered with the Commission in December 1988. Prior to that time it was and remains a Massachusetts multi-candidate committee organized pursuant to M.G.L. c. 55, § 5.

2. Paul Moran is the treasurer of The Committee for Quality Hospital Care. Prior to Mr. Moran serving as treasurer, Bernard Flynn served as treasurer from February 1989 to May 1992. William Guenther served as treasurer at the time of the Committee's federal organization, until February 1989.

3. Pursuant to 2 U.S.C. § 434(b)(3), each report of receipts and disbursements from a political committee shall disclose the identification of each person, political committee, authorized committee, affiliated committee, loan guarantor, refund provider, and dividend payor that makes a contribution, transfer, loan, rebate, refund, or dividend to such a committee. Furthermore, pursuant to 11 C.F.R. § 104.12, political committees which have cash on hand at the time of their registration shall disclose on their first report the source(s) of such funds, including the information required by 11 C.F.R. 104.3(a)(1).

4. Respondents' 1989 Mid-Year Report reflected over \$25,000 in cash on hand as of December 15, 1988. Respondents did not identify to the Commission the source of these funds until March 10, 1992, over two and a half years late.

5. Pursuant to 2 U.S.C. § 434(a)(4)(iv), all political committees other than authorized committees of a candidate shall

file, in any calendar year in which a regularly scheduled election is not held, a report covering the period beginning July 1 and ending December 31, which shall be filed no later than January 31 of the following calendar year.

6. Respondents filed a 1989 Year End Report disclosing \$1,164 in receipts and \$18,691 in disbursements on March 14, 1992, over two years late.

7. Respondents filed a 1990 Year End Report disclosing \$250 in receipts and \$1800 in disbursements on July 15, 1991, 165 days late.

8. Pursuant to 2 U.S.C. § 434(a)(4)(A)(i) and (iii), all political committees other than authorized committees of a candidate shall file quarterly reports, in a calendar year in which a regularly scheduled general election is held, which shall be filed no later than the 15th day after the last day of each calendar quarter: except that a post-general election report, shall be filed no later than the 30th day after the general election and shall be complete as of the 20th day after such general election.

9. Respondents filed a 1990 April Quarterly Report, disclosing approximately \$8,974 in receipts and \$3,700 in disbursements on October 17, 1990, 183 days late.

10. Respondents filed a 1990 July Quarterly Report, disclosing approximately \$32,297.05 in receipts and \$17,450.52 in disbursements October 17, 1990, 92 days late.

11. Respondents filed a 1990 Post-General Report, disclosing

\$510 in receipts and \$2180 in disbursements on December 14, 1990, 8 days late.

12. Respondents contend that the majority of the Committee's activity was on the non-federal level. Respondents further contend that it is the intent of the Committee to cease functioning as a federal political committee and to revert to its status as a Massachusetts multi-candidate committee organized under M.G.L. c. 55, § 5.

V.1. Respondents failed to disclose the source of their initial cash on hand, in violation of 11 C.F.R. § 104.12 and 2 U.S.C. § 434(b)(3).

2. Respondents filed five reports of financial activity late, in violation of 2 U.S.C. § 434(a)(4)(A)(i), (iii), and (iv).

VI. Respondents will pay a civil penalty to the Federal Election Commission in the amount of Seven Thousand Five Hundred Dollars (\$7,500), pursuant to 2 U.S.C. § 437g(a)(5)(A).

VII. The Commission, on request of anyone filing a complaint under 2 U.S.C. § 437g(a)(1) concerning the matters at issue herein or on its own motion, may review compliance with this agreement. If the Commission believes that this agreement or any requirement thereof has been violated, it may institute a civil action for relief in the United States District Court for the District of Columbia.

VIII. This agreement shall become effective as of the date that all parties hereto have executed same and the Commission has approved the entire agreement.

IX. Respondents shall have no more than 60 days from the date this agreement becomes effective to comply with and implement the requirements contained in this agreement and to so notify the Commission.

X. This Conciliation Agreement constitutes the entire agreement between the parties on the matters raised herein, and no other statement, promise, or agreement, either written or oral, made by either party or by agents of either party, that is not contained in this written agreement shall be enforceable.




