
This letter describes the procedures that this committee used to obtain the occupation and name of employer of each contributor required to be itemized on schedule A-P.

Two contributor cards are attached. One is the card used in personal solicitations and the other is an example of a direct mail return card. Notice that both contain requests for occupation and name of employer. This information was keyed into the committee's automated contributor files for disclosure reporting.

Periodically a computer program selected the name and address of contributors who contributed in excess of \$200.00. The program then used the names and addresses to print the attached letter to request the required information. The automated contributor files were updated from the returned forms. A partial listing of the selected contributors is also attached. Additionally, every request for matching fund verification contained lines for occupation and name of employer. A sample is attached.

Finally, we will file amended reports that will demonstrate the success of these efforts.
