SUBJECT: ADMINISTRATIVE FINES FINAL DETERMINATION
RECOMMENDATION FOR THE 2002 YEAR END REPORT

Attached are two lists of political committees and their treasurers against which the Commission has found reason to believe (RTB) and assessed proposed civil money penalties calculated at RTB for failure to file or failure to timely file the 2002 Year End Report. The first list represents committees that have paid the civil money penalty and the second list represents those that have not paid. The committees that have not paid have been given at least forty (40) days from the date of the Commission's RTB finding to remit payment.

In accordance with 11 C.F.R. 111.34 and 11 C.F.R. 111.40, the Commission shall send a final determination notice to those respondents that have either paid or not paid the civil money penalty.

Five committees have filed reports after the RTB finding where the actual level of activity disclosed on the report results in a civil money penalty which is lower than that assessed at RTB. One of the committees, Political Action Committee of Focal Communications Corporation (AF #1033), paid the civil money penalty assessed at RTB; we will therefore issue a refund of the difference between the amount paid and the amount assessed at final determination. Another committee, Bill Martin Congressional Committee (AF #997) made a partial payment of the civil money penalty assessed at RTB; because this payment equals the revised civil money penalty, no refund is

necessary. The remaining committees are
Dub Maines for Congress (AF #1008)

The actual level of activity and receipt date of the
reports, as well as the revised civil money penalties, are reflected on the attached lists.

RAD Recommendation

(1) Make final determinations that the political committees and their treasurers on the
attached lists violated 2 U.S.C. 434(a) and assess the civil money penalties so
indicated.


