SUBJECT: REASON TO BELIEVE RECOMMENDATION - 2006 YEAR  
END REPORT FOR THE ADMINISTRATIVE FINE PROGRAM

Attached is a list of political committees and their treasurers who failed to file or failed to timely file the 2006 Year End Report in accordance with 2 U.S.C. 434(a). The Year End Report was due on January 31, 2007.

The committees listed in the attached RTB Circulation Report either failed to file the report, filed the report more than five (5) days after the due date, or filed the report more than thirty (30) days after the due date (considered a non-filed report). In accordance with the schedule of civil money penalties for reports at 11 C.F.R. 111.43, these committees should be assessed the civil money penalties highlighted on the attached circulation report.

2. Find reason to believe that all other political committees and their treasurers listed on the RTB Circulation Report violated 2 U.S.C. 434(a) and make a preliminary determination that the civil money penalties would be the amounts indicated on the RTB Circulation Report.

Attached are two lists of political committees and their treasurers against which the Commission has found reason to believe (RTB) and assessed proposed civil money penalties calculated at RTB for failure to file or failure to timely file the 2006 Year End Report. The first list represents the committees that have paid the civil money penalty and the second list represents those committees that have not paid. The committees that have not paid have been given at least forty (40) days from the date of the Commission's RTB finding to remit payment.

For your information, one (1) committee submitted double payments, and therefore, will be issued a refund. Eleven (11) committees disclosed a level of activity after the RTB finding which would result in a lowered civil money penalty. Eight (8) committees will be assessed a civil money penalty at FD that has been reduced since the RTB finding, and three (3) committees will be assessed a civil money penalty of \$0 at FD. An overview of each of these cases has been provided for your review.

Compressed Air Free Air Foundation Tunnel Caisson Subway Workers Political Action Fund (AF 1707) submitted two checks, each for the \$125 civil money penalty assessed at RTB. The first payment, dated June 12, 2007, was sent to the Government Lockbox via regular USPS mail. The second payment, dated July 10, 2007, was sent to the Government Lockbox via FedEx Overnight. The payments were received

simultaneously at the FEC on July 16, 2007, and subsequently both have a payment credit date of July 16, 2007. Total payments received equal \$250. The civil money penalty assessed at FD is \$125; we will therefore issue a refund for the difference

Conservative Victory Committee (AF 1708) disclosed a level of activity after the RTB finding which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$4,023 (previously estimated to be \$16,709), thus the fine would be lowered from \$500 to \$250. The committee paid the civil money penalty assessed at RTB; we will therefore issue a refund for the difference.

Kanno for Congress (AF 1716) disclosed a level of activity after the RTB finding which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$7,427 (previously estimated to be \$36,776), thus the fine would be lowered from \$900 to \$300.

Ohio Association of Mortgage Brokers PAC (OAMB PAC) (AF 1724) filed the 2006 Year End Report after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$240 (previously estimated to be \$16,489), thus the fine would be lowered from \$625 to \$312.

Paul R. Nelson for Congress Committee (AF 1726) filed the 2006 Year End Report after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$3,627 (previously estimated to be \$61,545), thus the fine would be lowered from \$2,700 to \$250.

Phillips International Inc. Political Action Committee (AF 1728) filed the 2006 Year End Report after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$2,213 (previously estimated to be \$46,300), thus the fine would be lowered from \$900 to \$250.

Rigger for Congress (AF 1729) disclosed a level of activity after the RTB finding which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$300 (previously estimated to be \$50,928), thus the fine would be lowered from \$2,700 to \$250.

Schwarz for Congress (AF 1731) filed the 2006 Year End Report after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$1,847 (previously estimated to be \$329,677), thus the fine would be lowered from \$8,000 to \$250.

Tan Nguyen for Congress (AF 1734) filed the 2006 Year End Report after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$38,624 (previously estimated to be \$121,690), thus the fine would be lowered from \$4,500 to \$900.

Andy Michaud for Congress (AF 1698) filed the 2006 Year End Report after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$0 (previously estimated to be \$49,989), thus the fine would be lowered from \$900 to \$0.

Mike McGraw for Congress (AF 1720) filed the 2006 Year End Report after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$0 (previously estimated to be \$32,975), thus the fine would be lowered from \$900 to \$0.

Terry Stulce for Congress (AF 1735) filed the 2006 Year End Report after the RTB finding and disclosed a level of activity which would result in a lowered civil money penalty. The committee disclosed total receipts and disbursements of \$0 (previously estimated to be \$23,274), thus the fine would be lowered from \$500 to \$0.

In accordance with 11 CFR 111.34 and 11 CFR 111.40, the Commission shall send a final determination notice to those respondents that have either paid or not paid the civil money penalty.

On 5/15/2007, the Federal Election Commission ("the Commission") found reason to believe ("RTB") that Kanno for Congress and you, as treasurer, violated 2 U.S.C. 434(a) for failing to file the 2006 Year-End Report. By letter dated 5/17/2007, the Commission sent you notification of the RTB finding that included a civil money penalty calculated at the RTB stage of \$900 in accordance with the schedule of penalties at 11 C.F.R. 111.43. Within 40 days of the Commission's RTB finding, you were required to either transmit payment of the calculated civil money penalty or submit a written response challenging either the RTB finding or the calculated civil money penalty. The amount of the civil money penalty has been changed to reflect the actual level of activity of your 2006 Year-End Report.

The Commission did not receive payment of the calculated civil money penalty or your written response within the time permitted. The Commission made a final determination on 7/20/2007 that you, as treasurer, and Kanno for Congress violated 2 U.S.C. 434(a) and assessed a civil money penalty in the amount of \$300 in accordance with 11 C.F.R. 111.43. The civil money penalty is based on these factors:

**To Pay the Civil Money Penalty**

**If You Do Not Pay the Civil Money Penalty**

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA") as amended by the Debt Collection Improvement Act of 1996 ("DCIA"), 31 U.S.C. § 3701 et seq. 
**If You Choose to Appeal the Final Determination or Civil Money Penalty**

Your failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver of the respondent's right to present such argument in a petition to the district court under 2 U.S.C. 437g. 11 C.F.R. 111.38.

The confidentiality provisions at 2 U.S.C. 437g(a)(12) no longer apply and this matter is now public. The file will be made a part of the public record pursuant to 11 C.F.R. 111.42(b). Although the file must be placed on the public record within thirty (30) days from the date of the Commission's notification, this could occur at anytime following certification of the Commission's vote.

3. **Due Process.** The Agency, at a minimum, has made reasonable efforts to obtain payment of the debt, demanded payment, and provided the debtor with the notice and opportunities described below:

A. At least 30 days prior to the date of this certification, the Agency has provided, or made reasonable efforts to provide each debtor with:

- written notification, at the debtor's most current known address, of the nature and the amount of the debt, the intention of the Agency to collect the debt through referral to Treasury, and actions that may be taken by Treasury including referral of the debt to a private collection agency and referral of the debt to the Department of Justice for litigation;
- an opportunity to inspect and copy the records of the Agency with respect to the debt; and
- an opportunity for review within the Agency of the determination of the Agency with respect to the debt, including the opportunity to present evidence that all or part of the debt is not past-due or legally enforceable.

B. The Agency has considered any evidence presented by the debtor and determined that the amount of the debt is past-due and legally enforceable and there are no pending appeals of such determination.

4. ***Interest and Penalties.*** The Agency has complied with all of the provisions of 31 U.S.C. § 3717 and the Federal Claims Collection Standards, as well as other statutes, regulations and policies applicable to the Agency's assessment of interest, penalties and administrative costs. The Agency has mailed a written notice to all debtors explaining the Agency's requirements concerning the charges.

### TREASURY CROSS-SERVICING PROGRAM

#### CERTIFICATION TERMINOLOGY

For purposes of the foregoing Certification Agreement, the following describes how creditor agencies submit debts via Electronic Transmission of computer records to the Cross-Servicing Program:

1. Electronic Transmission. Any transmission from creditor agencies to the Cross-Servicing Program via any form of electronic media (including, but not limited to, tapes, diskettes, and on-line access), as more particularly described in *Step 7; Electronic Format* in the "Crossservicing Implementation Guide", dated November 1998, as may be amended or updated ("Cross Servicing Guide"), is an Electronic Transmission.
2. Add Records. Add Records are electronic records which creditor agencies use to add new debts to Cross-Servicing. Add Records are more particularly described in "Step 7; Agency File Formats" in the Cross Servicing Guide.
3. Update Records. Update Records are electronic records that creditor agencies use to update, change or modify information about debts previously transmitted to Cross-Servicing by creditor agencies. Update Records are more particularly described in "Step 7; Agency File Formats" in the Cross Servicing Guide.
