SUBJECT: Reason to Believe Recommendation -
Failure to File 48-Hour Notices under the Administrative Fine Program

Attached is the name of a principal campaign committee that has failed to file 48-hour notices with the Commission for contributions of \$1,000.00 or more received from the close of books for the Massachusetts 12 Day Pre-General Report up to 48 hours before the November 2, 2010 General Election in accordance with 2 U.S.C. § 434(a)(6) and 11 CFR. § 104.5(f). The committee, Friends of Sean Bielat, represents a candidate who lost the General Election. The committee is being referred for failing to file 48-hour notices for contributions totaling \$37,500.00.

A 48-hour notice is required to report all contributions of a \$1,000.00 or more, to any authorized committee of a candidate, including contributions from the candidate, loans from the candidate and other non-bank sources and endorsements or guarantees of loans from banks, as per, 11 CFR § 104.5(f).

We have attached an information sheet which includes the contributor name, date of receipt and amount of the contributions for which a 48-hour notice was not filed.

In accordance with the schedule of civil money penalties outlined within 11 CFR § 111.44, this committee should be assessed the civil money penalty so indicated.

Dear Mr. Stanley:

The Federal Election Campaign Act of 1971, as amended, 2 U.S.C. § 431, *et seq.* ("the Act"), requires principal campaign committees of candidates for federal office to notify in writing either the Secretary of the Senate or the Federal Election Commission ("FEC"), and the Secretary of State, as appropriate, of any contribution of \$1,000 or more, received by any authorized committee of the candidate after the 20th day, but more than 48 hours before, any election. 2 U.S.C. § 434(a)(6)(A). The Act further requires notification to be made within 48 hours after the receipt of the contribution and to include the name of the candidate and office sought, the date of receipt, the amount of the contribution, and the identification of the contributor. *Id.* These notification requirements are in addition to all other reporting requirements. 2 U.S.C. § 434(a). Our records indicate that Friends of Sean Bielat did not submit 48-Hour Notices for contributions of \$1,000 or more, received between October 14, 2010 and October 30, 2010, totaling \$37,500, as required by 2 U.S.C. § 434(a)(6)(A). Attachment 1.

The Act permits the FEC to impose civil money penalties for violations of the reporting requirements of 2 U.S.C. § 434(a). 2 U.S.C. § 437g(a)(4). On April 26, 2011, the FEC found that there is Reason to Believe ("RTB") that Friends of Sean Bielat and you, in your official capacity as treasurer, violated 2 U.S.C. § 434(a) by failing to file the 48-Hour Notices. Based on the FEC's schedule of civil money penalties at 11 C.F.R. § 111.44, the amount of your civil money penalty calculated at the RTB stage is \$4,630. Please see the attached copy of the Commission's administrative fine regulations at 11 C.F.R. §§ 111.30-111.46. Attachment 2. The Commission's website contains further information about how the administrative fine program works and how the fines are calculated. <http://www.fec.gov/af/af.shtml>. 11 C.F.R. § 111.34. The amount of the civil money penalty is \$110 for each non-filed notice plus 10 percent of the dollar amount of the contributions not timely reported. The civil money penalty increases by 25 percent for each prior violation. Send your payment of \$4,630 within forty (40) days of the finding, or by June 5, 2011.

At this juncture, the following courses of action are available to you:

1. If You Choose to Challenge the RTB Finding and/or Civil Money Penalty

If you should decide to challenge the RTB finding and/or calculated civil money penalty, you must submit a written response, including the AF# found at the top of page 1 under your committee's identification number, to the FEC's Office of Administrative Review, 999 E Street, NW, Washington, DC 20463. Your response must be received within forty (40) days of the Commission's RTB finding, or June 05, 2011. 11 C.F.R. § 111.35(a). Your written response must include the reason(s) why you are challenging the RTB finding and/or calculated civil money penalty, and must include the factual basis supporting the reason(s) and supporting documentation. The FEC strongly encourages that documents be submitted in the form of affidavits or declarations. 11 C.F.R. § 111.36(c).

The FEC will only consider challenges that are based on at least one of three grounds: (1) a factual error in the RTB finding; (2) miscalculation of the calculated civil money penalty by the FEC; or (3) your demonstrated use of best efforts to file in a timely manner when prevented from doing so by reasonably unforeseen circumstances that were beyond your control. 11 C.F.R. § 111.35(b). In order for a challenge to be considered on the basis of best efforts, you must have filed the required report no later than 24 hours after the end of these reasonably unforeseen circumstances. *Id.* Examples of circumstances that will be considered reasonably unforeseen and beyond your control include, but are not limited to, (1) a failure of Commission computers or Commission-provided software despite your seeking technical assistance from Commission personnel and resources; (2) a widespread disruption of information transmissions over the Internet that is not caused by a failure of the Commission's or your computer systems or Internet service provider; and (3) severe weather or other disaster-related incident. 11 C.F.R. § 111.35(c). Examples of circumstances that will not be considered reasonably unforeseen and beyond your control include, but are not limited to, (1) negligence; (2) delays caused by vendors or contractors; (3) treasurer and staff illness, inexperience or unavailability; (4) committee computer, software, or Internet service provider failures; (5) failure to know filing dates; and (6) failure to use filing software properly. 11 C.F.R. § 111.35(d).

The "failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver" of your right to present such argument in a petition to the U.S. district court under 2 U.S.C. § 437g. 11 C.F.R. § 111.38.

If you intend to be represented by counsel, please advise the Office of Administrative Review. You should provide, in writing, the name, address and telephone number of your counsel and authorize counsel to receive notifications and communications relating to this challenge and imposition of the calculated civil money penalty.

2. If You Choose Not to Pay the Civil Money Penalty and Not to Submit a Challenge

If you do not pay the calculated civil money penalty and do not or submit a written response, the FEC will assume that the preceding factual allegations are true and make a final determination that Friends of Sean Bielat and you, in your official capacity as treasurer, violated 2 U.S.C. § 434(a) and assess a civil money penalty.

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA"), as amended by the Debt Collection Improvement Act of 1996, 31 U.S.C. § 3701 *et seq.* The FEC may take any and all appropriate action authorized and required by the DCA, as amended, including transfer to the U.S. Department of the Treasury for collection. 11 C.F.R. § 111.45.

3. If You Choose to Pay the Civil Money Penalty

If you should decide to pay the calculated civil money penalty, send the enclosed remittance form, along with your payment, to the FEC at the address on page 4. Upon receipt of your payment, the FEC will send you a final determination letter.

This matter was generated based on information ascertained by the FEC in the normal course of carrying out its supervisory responsibilities. 2 U.S.C. § 437g(a)(2). It will remain confidential in accordance with 2 U.S.C. § 437g(a)(4)(B) and 437g(a)(12)(A) until it is placed on the public record in accordance with 11 C.F.R. § 111.42, unless you notify the FEC in writing that you wish the matter to be made public.

Ladies and Gentlemen:

With regard to the RTB finding, we believe that there are factual errors in the finding. FEC records, as well as our own, show that of the 18 contributions for which 48-hour notices were allegedly not filed, all but four were filed as required. The four not properly filed were the result of administrative error. We regret our errors; however, it is worth noting that the errors amount to approximately only 2% of the total dollar amount required to be reported under the 48-hour rule.

Enclosure 1 is a document submitted to the FEC on June 2, 2011 that explains in detail why we believe 14 of the alleged violations were in fact reported correctly. For the remaining four alleged violations, totaling \$4,000, please find enclosed a campaign committee check in the amount of \$880. This amount was calculated as follows: $(4 \times \$110 \text{ penalty}) + (\$4,000 \times 10\% \text{ of the total value})$.

Each of the facts cited in this response can be verified in the public records of the Commission; however, please let us know if any additional documentation or materials is needed.





WHO MUST FILE

Principal campaign committees of all 2010 general election congressional candidates ¹ (including unopposed candidates and candidates whose names do not appear on the ballot) must file Pre- and Post-General Election Reports. ²

Campaigns that raise or spend more than \$5,000 for the 2010 election cycle (and thus trigger registration and reporting requirements) must file quarterly reports throughout 2010, even if the candidate plans to retire, withdraws from the race prior to the primary election, loses the primary or drops out of the race prior to the general election. See 11 CFR 104.5(a)(2).

Before a committee can stop filing with the FEC, it must file a termination report with the Commission. See 11 CFR 102.3. Committees must continue to file reports until the Commission notifies them in writing that their termination report has been accepted.

Reports filed electronically must be received and validated by the Commission by 11:59 p.m. Eastern Time on the filing deadline. See 11 CFR 104.5(e).

¹ Generally, an individual becomes a candidate for federal office (and thus triggers registration and reporting obligations) when his or her campaign exceeds \$5,000 in either contributions or expenditures. If the campaign has not crossed the \$5,000 threshold, it is not required to file reports. See 11 CFR 100.3(a).

² If a candidate has more than one authorized committee, the principal campaign committee must also file a consolidated report on Form 3Z [PDF].

A committee whose candidate participates in a 2010 state primary, nominating convention or runoff election -- even if unopposed -- must also file a pre-election report 12 days prior to the primary, nominating convention or runoff. The campaign committee of a candidate who participates in the general election must file pre- and post-general election reports.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 8 item(s):

1. Schedule A of your report discloses one or more contributions that appear to exceed the limits set forth in the Act (see attachment #1). You should examine all of your contributions to check for additional excessive contributions. The Committee's procedures for processing contributions should also be reviewed.

An individual or a political committee other than an authorized committee or qualified multi-candidate committee may not make a contribution to a candidate for federal office in excess of \$2,400 per election. An authorized committee may not make a contribution to a candidate for federal office in excess of \$2,000 per election. A qualified multi-candidate committee and all affiliated committees may not make a contribution(s) to a candidate for federal office in excess of \$5,000 per election. The term "contribution" includes any gift, subscription, loan, advance, or deposit of money or anything of value made by any person for the purpose of influencing any election for federal office. (2 U.S.C. § 441a(a) and (f); 11 CFR § 110.1(b), (e) and (k))

If any apparently excessive contribution in question was incompletely or incorrectly disclosed, you must amend your original report with the clarifying information. If any contribution you received exceeds the limits, you may have to refund the excessive amount.

Excessive contributions may be retained if, within sixty (60) days of receipt, the excessive portions are properly redesignated or reattributed. Guidelines for each option are provided below:

For reattributions, excessive contributions from individuals can be retained, if within sixty (60) days of receipt, the excessive amount is properly reattributed to another person. Please note that reattributions only apply to excessive contributions from individuals. An excessive contribution is considered properly reattributed if (1) the contributors provide the committee with written documentation, signed by each contributor, authorizing a reattribution and indicating the amount of the contribution to be attributed to each contributor, or (2) the committee reattributes, by presumption, the excessive portion of the contribution if the contribution was made on a written instrument from a joint account and was signed by only one of the account holders. In this case, the treasurer must notify the contributors in writing within 60 days of receiving the contribution that the committee intends to reattribute the excessive portion and must give the contributor an opportunity to request a refund. (11 CFR § 110.1(k)(3)(ii)(B))

For redesignations, the funds can be retained if, within sixty (60) days of receipt, the excessive amount is properly redesignated for a different election. An excessive contribution is considered properly redesignated if (1) the committee obtains signed written documentation from the contributor(s) authorizing the redesignation of the contribution for another election, provided that the new designation does not exceed the limitations on contributions made with respect to that election, or (2) your committee redesignates by presumption the excessive portion of the contribution for another election provided that the new designation does not exceed the limitations on contributions made with respect to that election. In this case, the treasurer must notify the contributor of the redesignation in writing within 60 days of the treasurer's receipt of the contribution. The notification must give the contributor an opportunity to request a refund. (11 CFR § 110.1(b)(5)(ii)(B)) Please note that you cannot presumptively redesignate an excessive contribution from a multi-candidate committee. Also, a contribution can only be redesignated to a previous election to the extent that the contribution does not exceed the committee's net debts outstanding for that election. (11 CFR § 110.1(b)(3)(i))

If the foregoing conditions for reattributions or redesignations are not met within 60 days of receipt of the contribution, the excessive amount must be refunded. See 11 CFR § 103.3(b)(1).

The failure to file 48-hour notices may result in civil money penalties or legal enforcement action. If any contribution of \$1,000 or more was incorrectly reported, you must amend your original report with the clarifying information. (11 CFR § 104.5(f))

Please see attachment #4 for employer and occupation entries that appear on your report and are not considered acceptable.

You must provide the missing information or clarify the information provided. If you are unable to do so, you must demonstrate that "best efforts" have been used to obtain the information. To establish "best efforts," you must provide the Commission with a detailed description of your procedures for requesting the information. Establishing "best efforts" is a three-fold process.

Summary of Recommendation

Make a final determination that the respondents violated 2 U.S.C. § 434(a) and assess a \$1,080 civil money penalty.

Reason-to-Believe Background

On April 26, 2011, the Federal Election Commission ("the Commission") found reason to believe ("RTB") that Friends of Sean Bielat and Jason Stanley, in his official capacity as Treasurer ("the respondents"), violated 2 U.S.C. § 434(a) for failing to file 48-Hour Notices for 18 contributions totaling \$37,500 for the 2010 General Election and made a preliminary determination that the civil money penalty was \$4,630 based on the schedule of penalties at 11 C.F.R. § 111.44. A letter, dated April 27, 2011, was sent to the respondents' address of record by the Reports Analysis Division ("RAD") to notify them of the Commission's RTB finding and civil money penalty.

Legal Requirements

The Federal Election Campaign Act ("Act") requires that the principal campaign committee of a candidate must notify the Commission, in writing, of any contribution of \$1,000 or more received after the 20th day but more than 48 hours before an election. The principal campaign committee must notify the Commission within 48 hours of receipt of the contribution. The 48-hour notification shall be in addition to all other reporting requirements under the Act. 2 U.S.C. § 434(a)(6)(A) and 11 C.F.R. § 104.5(f). The treasurer shall be personally responsible for the timely filing of reports. 11 C.F.R. § 104.14(d). The respondents' written response must detail the factual basis supporting its challenge and include supporting documentation. 11 C.F.R. § 111.35(e).

Respondents' Challenge

On June 8, 2011, the Commission received the written response ("challenge") from the Candidate, Sean Bielat challenging the RTB finding based on factual errors. The Candidate states that Commission records show all but four of the 18 48-Hour notices they were cited for not filing, were filed. The four notices not properly filed were the result of administrative error. Based on this, the Candidate calculates the civil money penalty to be \$880 and included a check in this amount with the challenge.

Also included with the challenge is a copy of an electronic miscellaneous document filed by the respondents on June 2, detailing why they believe 14 of the 18 contributions were reported correctly.

Analysis

The 48-Hour Notice reporting period for the 2010 General Election was October 14 through October 30, 2010, which occurred during the 30 Day Post-General Reporting period. According to the miscellaneous document included with the challenge, the respondents amended their reports to correct mistakes made in data entry and the conversion of credit card transactions that were electronically uploaded. Commission records indicate that the respondents filed an amended 12 Day Pre-General Report on May 20, 2011, and an amended 30 Day Post-General Report on May 25.

Contributions with amended receipt dates:

1. William Carey: The respondents state that this contribution was received on 10/14 rather than 10/8. They have amended their 12 Day Pre-General Report to now disclose this 10/8 contribution and their 30 Day Post-General Report to no longer disclose the 10/14 contribution. Because the contribution no longer falls within the 10/14 - 10/30 48-Hour Notice reporting period, they are no longer required to have filed a 48-Hour Notice for the contribution and it should no longer be included in the calculation of their civil money penalty.
2. Free and Strong PAC: The respondents state that this contribution was received on 10/11 rather than 10/14. They have amended their 12 Day Pre-General Report to now disclose this 10/11 contribution and their 30 Day Post-General Report to no longer disclose the 10/14 contribution. Because the contribution no longer falls within the 10/14 - 10/30 48-Hour Notice reporting period, they are no longer required to have filed a 48-Hour Notice for the contribution and it should no longer be included in the calculation of their civil money penalty.

Contributions for which the respondents assert a 48-Hour Notice was filed:

1. Fred Eder: Commission records indicate the respondents' original 30 Day Post-General Report disclosed two contributions from Fred Eder; \$4,800 on 10/14 and \$2,400 on 10/15. The respondents only filed a 48-Hour Notice for the 10/15 contribution and were therefore cited for failing to file a 48-Hour Notice for the 10/14 contribution.

Their amended report no longer discloses a 10/14 contribution from Fred Eder. The respondents, therefore, are no longer required to have filed a 48-Hour notice for this contribution and it should no longer be included in the calculation of their civil money penalty.

2. Kurt Krastinski: The respondents' original 30 Day Post-General Report disclosed two \$2,400 contributions from this contributor. One on 10/14 and one on 10/15. The respondents only filed a 48-Hour Notice for the 10/15 contribution and were therefore cited for failing to file a 48-Hour Notice for the 10/14 contribution.

Their amended report no longer discloses the 10/14 contribution, therefore the respondents are no longer required to have filed a 48-Hour notice for this contribution and it should no longer be included in the calculation of their civil money penalty.

3. Gary Lewis: The respondents' original 30 Day Post-General Report disclosed two \$2,400 contributions from this contributor. One on 10/14 and one on 10/15. The respondents only filed a 48-Hour Notice for the 10/15 contribution and were therefore cited for failing to file a 48-Hour Notice for the 10/14 contribution.

Their amended report no longer discloses the 10/14 contribution, therefore the respondents are no longer required to have filed a 48-Hour Notice for this contribution and it should no longer be included in the calculation of their civil money penalty.

4. Steve Torcise: The respondents' original 30 Day Post-General Report disclosed two \$1,000 contributions from this contributor. One on 10/14 and one on 10/15. The respondents only filed a 48-Hour Notice for the 10/15 contribution and were therefore cited for failing to file a 48-Hour Notice for the 10/14 contribution.

Their amended report no longer discloses the 10/14 contribution, therefore the respondents are no longer required to have filed a 48-Hour Notice for this contribution and it should no longer be included in the calculation of their civil money penalty.

5. Julian Whitaker: The respondents' original 30 Day Post-General Report disclosed two \$1,000 contributions from this contributor. One on 10/14 and one on 10/15. The respondents only filed a 48-Hour Notice for the 10/15 contribution and were therefore cited for failing to file a 48-Hour Notice for the 10/14 contribution.

Their amended report no longer discloses the 10/14 contribution, therefore the respondents are no longer required to have filed a 48-Hour Notice for this contribution and it should no longer be included in the calculation of their civil money penalty.

6. Jay Williams: The respondents' original 30 Day Post-General Report disclosed two \$1,000 contributions from this contributor. One on 10/14 and one on 10/15. The respondents only filed a 48-Hour Notice for the 10/15 contribution and were therefore cited for failing to file a 48-Hour Notice for the 10/14 contribution.

Their amended report no longer discloses the 10/14 contribution, therefore the respondents are no longer required to have filed a 48-Hour notice for this contribution and it should no longer be included in the calculation of their civil money penalty.

7. Joshua Levine: The respondents' original 30 Day Post-General Report disclosed two \$2,400 contributions from this contributor. One on 10/15 and one on 10/18. The respondents only filed a 48-Hour Notice for the 10/18 contribution and were therefore cited for failing to file a 48-Hour Notice for the 10/15 contribution.

Their amended report no longer discloses the 10/15 contribution, therefore the respondents are no longer required to have filed a 48-Hour Notice for this contribution and it should no longer be included in the calculation of their civil money penalty.

8. Joseph V. Shields, Jr.: The respondents' original 30 Day Post-General Report disclosed two contributions from this contributor; \$4,800 on 10/15 and \$2,400 on 10/18. The respondents only filed a 48-Hour Notice for the 10/18 contribution and were therefore cited for failing to file a 48-Hour Notice for the 10/15 contribution.

Their amended report no longer discloses the 10/15 contribution, therefore the respondents are no longer required to have filed a 48-Hour Notice for this contribution and it should no longer be included in the calculation of their civil money penalty.

9. Kenneth Brody: The challenge contends that the \$4,800 contribution from Kenneth Brody was divided between he and Mary Shields, and that two corresponding 48-Hour Notices were filed. However, the respondents' original 30 Day Post-General Report disclosed two contributions from Kenneth Brody; \$4,800 on 10/18 and \$2,400 on 10/19. While there was no contributor named "Mary" Shields on the report, the original report also disclosed a \$2,400 contribution from Maury Shields on 10/18. The respondents only filed 48-Hour Notices for the 10/18 contributions from Kenneth Brody and Maury Shields, and were therefore cited for failing to file a 48-Hour Notice for the 10/19 contribution from Kenneth Brody.

Their amended report no longer discloses the 10/18 \$4,800 contribution or the 10/19 \$2,400 contribution from Kenneth Brody. The report now discloses two \$2,400 contributions for Kenneth Brody, each received on 10/18; one for the primary and one for the general. The respondents only filed one 10/18 48-Hour Notice for Kenneth Brody and, therefore, failed to file a 48-Hour Notice for the second 10/18 \$2,400 contribution. This missing notice should continue to be included in the calculation of their civil money penalty, though the amount is reduced from \$4,800 to \$2,400.

The amended report continues to disclose one contribution from Maury Shields as on the original report, therefore the respondents did not attribute a portion of the Kenneth Brody's original \$4,800 contribution to Maury Shields, as contended in the challenge.

10. Gail Golden-Icahn: The respondents' original 30 Day Post-General Report disclosed a \$4,800 contribution from Gail Golden-Icahn on 10/18 and a \$2,400 contribution from Gail Icahn on 10/20. The respondents only filed a 48-Hour Notice for the 10/20 contribution and were therefore cited for failing to file a 48-Hour Notice for the 10/18 contribution.

Their amended report no longer discloses the 10/18 contribution from Gail Golden-Icahn, therefore the respondents are no longer required to have filed a 48-Hour notice for this contribution and it should no longer be included in the calculation of their civil money penalty.

11. Kurt Jagers: The respondents' original 30 Day Post-General Report disclosed two \$2,000 contributions from this contributor. One on 10/19 and one on 10/20. The respondents only filed a 48-Hour Notice for the 10/20 contribution and were therefore cited for failing to file a 48-Hour Notice for the 10/19 contribution.

Their amended report no longer discloses the 10/19, therefore the respondents are no longer required to have filed a 48-Hour notice for this contribution and it should no longer be included in the calculation of their civil money penalty.

12. Matthew Sidman: The respondents' original 30 Day Post-General Report disclosed a \$1,000 contribution from this contributor on 10/26. The challenge contends a 48-Hour Notice was filed for this contributor; however, the last name was misspelled as "Skidman."

Their amended report now discloses the \$1,000 contribution from Matthew Sidman as having been received on 10/28. According to the Commission's records, a 48-Hour Notice was timely filed for a 10/28 \$1,000 contribution from Matthew "Skidman;" therefore, this contribution should no longer be included in the calculation of their civil money penalty.

At the time of the RTB finding, it appeared that the respondents failed to file 48-Hour Notices for 18 contributions totaling \$37,500 which were received on 8 days (October 14, 15, 18, 19, 26, 28, 29, and 30, 2010). Based on the challenge and amended 12 Day Pre-General and 30 Day Post-General Reports, they were not required to file 48-Hour notices for 13 contributions totaling \$31,100. The Reviewing Officer has, therefore, determined that they did not file 48-Hour Notices for five (5) contributions totaling \$6,400 received on 4 days (October 18, 28, 29, and 30, 2010). Under the administrative fine regulations, the civil money penalty is \$110 plus 10% of the amount of the contributions not reported on a 48-Hour Notice. 11 C.F.R. § 111.44. The amount of the civil money penalty would be $\$440 + (.10 \times \$6,400)$ or \$1,080 (reduced from the RTB civil money penalty of \$4,630).

The Reviewing Officer, therefore, recommends that the Commission make a final determination that the respondents violated 2 U.S.C. § 434(a) and assess a civil money penalty of \$1,080 (reduced from the RTB civil money penalty of \$4,630).

OAR Recommendations

- (1) Adopt the Reviewing Officer recommendation for AF# 2474 involving Friends of Sean Bielat and Norm Fay, in his official capacity as Treasurer, in making the final determination;
- (2) Make a final determination in AF# 2474 that Friends of Sean Bielat and Norm Fay, in his official capacity as Treasurer, violated 2 U.S.C. § 434(a) and assess a civil money penalty of \$1,080 (reduced from the RTB civil money penalty of \$4,630); and
- (3) Send the appropriate letter.

On April 15, 2011, the Federal Election Commission ("Commission") found reason to believe ("RTB") that Friends of Sean Bielat and Jason Stanley, in his official capacity as Treasurer ("respondents"), violated 2 U.S.C. § 434(a) for failing to file 48-Hour Notices for 18 contributions totaling \$37,500 for the General Election. The Commission also made a preliminary determination that the civil money penalty was \$4,630 based on the schedule of penalties at 11 C.F.R. § 111.44.

After reviewing the written response and any supplemental information submitted by you and Commission staff, the Reviewing Officer has recommended that the Commission make a final determination in this matter. A copy of the Reviewing Officer's recommendation is attached.

You may file with the Commission Secretary a written response to the recommendation within 10 days of the date of this letter. Your written response should be sent to the Commission Secretary, 999 E Street, NW, Washington, DC 20463. Subject: Final Determination Recommendation in AF# 2474 – Friends of Sean Bielat and Norm Fay, in his official capacity as Treasurer (C00476598)

On April 26, 2011, the Commission found reason to believe ("RTB") that the respondents violated 2 U.S.C. § 434(a) for failing to file 48-Hour Notices for 18 contributions, totaling \$37,500, for the 2010 General Election and also made a preliminary determination that the civil money penalty was \$4,630 based on the schedule of penalties at 11 C.F.R. § 111.44.

On June 8, 2011, the Commission received their written response ("challenge"). After reviewing the challenge, the Reviewing Officer's recommendation ("ROR") dated August 5, 2011 was forwarded to the Commission, a copy was forwarded to the respondents, and is hereby incorporated by reference. The Reviewing Officer recommended that the Commission make a final determination that they violated 2 U.S.C. § 434(a) and assess a \$1,080 civil money penalty because they submitted no evidence that a factual error was made in the RTB finding, that the penalty was miscalculated at RTB or that they used best efforts to file on time. 11 C.F.R. § 111.35(b).

Within 10 days of transmittal of the recommendation, they may file a written response with the Commission Secretary which may not raise any arguments not raised in their challenge or not directly responsive to the ROR. 11 C.F.R. § 111.36(f). As of this date, a written response has not been received.

Please note that on June 10, 2011, the respondents made an \$880 payment toward their penalty, based on their calculation of the penalty after amending their reports. Should the Commission adopt OAR's recommendations, the remaining balance due from the respondents would be \$200.

Dear Mr. Fay:

On April 26, 2011, the Federal Election Commission ("the Commission") found reason to believe ("RTB") that Friends of Sean Bielat and you, in your official capacity as Treasurer, violated 2 U.S.C. § 434(a) for failing to file 48-Hour Notices for 18 contributions totaling \$37,500 for the 2010 General Election. By letter dated April 27, 2011, the Commission sent you notification of the RTB finding that included a civil money penalty calculated at RTB of \$4,630 in accordance with the schedule of penalties at 11 C.F.R. § 111.44. On June 8, 2011, the Office of Administrative Review received the written response from you challenging the RTB finding and penalty.

On June 10, 2011, the Commission received your \$880 payment.

The Reviewing Officer reviewed the Commission's RTB finding with its supporting documentation and your written response. Based on this review, it was determined that the respondents were not required to file 48-Hour Notices for 13 contributions totaling \$31,100. Therefore, the Reviewing Officer recommended that the Commission make a final determination that Friends of Sean Bielat and you, in your official capacity as Treasurer, violated 2 U.S.C. § 434(a) for failing to file 48-Hour Notices for five contributions totaling \$6,400 received between October 14 and 30, 2010, and assess a civil money penalty in the amount of \$1,080 in accordance with 11 C.F.R. § 111.44. The basis for the Reviewing Officer's recommendation was included in the Final Determination Report, a copy of which was sent to you on August 8, 2011.

On September 8, 2011, the Commission adopted the Reviewing Officer's recommendation and made a final determination that Friends of Sean Bielat and you, in your official capacity as Treasurer, violated 2 U.S.C. § 434(a) and assessed a civil money penalty of \$1,080 (reduced from

the RTB civil money penalty of \$4,630). A copy of the final determination recommendation is attached.

If You Choose to Appeal the Final Determination and/or Civil Money Penalty

If you choose to appeal the final determination, you should submit a written petition, within 30 days of receipt of this letter, to the district court of the United States for the district in which the committee or treasurer reside, or transact business, requesting that the final determination be modified or set aside. See 2 U.S.C. § 437g(a)(4)(C)(iii). The failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver of the respondents' right to present such argument in a petition to the district court under 2 U.S.C. § 437g. 11 C.F.R. § 111.38.

If You Choose Not to Pay the Civil Money Penalty and Not to Appeal

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA") as amended by the Debt Collection Improvement Act of 1996 ("DCIA"), 31 U.S.C. § 3701 et seq. If you do not pay this debt within 30 days (or file a written petition to a federal district court - see below), the Commission will transfer the debt to the U.S. Department of the Treasury ("Treasury") for collection. Within 5 days of the transfer to Treasury, Treasury will contact the debtor and request payment. Treasury currently charges a fee of 28% of the civil money penalty amount for its collection services. The fee will be added to the amount of the civil money penalty that you owe. Should Treasury's attempts fail, Treasury will refer the debt to a private collection agency ("PCA"). If the debt remains unpaid, Treasury may recommend that the Commission refer the matter to the Department of Justice for litigation.

If You Choose to Pay the Civil Money Penalty

If you should decide to pay the civil money penalty, send the enclosed form and payment to the address on page 3 within 30 days of receipt of this letter.

The confidentiality provisions at 2 U.S.C. § 437g(a)(12) no longer apply and this matter is now public. The file will be made a part of the public record pursuant to 11 C.F.R. § 111.42(b). Although the file must be placed on the public record within 30 days from the date of the Commission's notification, this could occur at any time following certification of the Commission's vote.

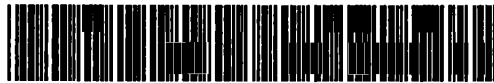
