SUBJECT: Reason To Believe Recommendation -2017 April Quarterly Report for the  
Administrative Fine Program

Attached is a list of political committees and their treasurers who failed to file the 2017 April Quarterly Report in accordance with 52 U.S.C. § 30104(a). The April Quarterly Report was due on April 15, 2017.

The committees listed in the attached RTB Circulation Report failed to file the report. In accordance with the schedule of civil money penalties for reports at 11 C.F.R. 111.43, these committees should be assessed the civil money penalties highlighted on the attached circulation report.

**Recommendation**

1. Find reason to believe that the political committees and their treasurers, in their official capacity, listed on the RTB Circulation Report violated 52 U.S.C. § 30104(a) and make a preliminary determination that the civil money penalties would be the amounts indicated on the RTB Circulation Report.
2. Send the appropriate letters.

Dear Mr. Crane:

The Federal Election Campaign Act of 1971, as amended ("the Act"), requires that your committee file an April Quarterly Report of Receipts and Disbursements every calendar year. This report, covering the period January 1, 2017 through March 31, 2017, shall be filed no later than April 15, 2017. 52 U.S.C. § 30104(a). Because records at the Federal Election Commission ("FEC") indicate that you did not file this report within thirty (30) days of the due date, the report is considered not filed for the purpose of calculating the civil money penalty. You should file this report if you have not already done so.

The Act permits the FEC to impose civil money penalties for violations of the reporting requirements of 52 U.S.C. § 30104(a). 52 U.S.C. § 30109(a)(4). On June 14, 2017, the FEC found that there is reason to believe ("RTB") that Crane for Congress Inc. and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) by failing to file timely this report on or before April 15, 2017. Based on the FEC's schedules of civil money penalties at 11 CFR § 111.43, the amount of your civil money penalty calculated at the RTB stage is \$9,030. Please see the attached copy of the Commission's administrative fine regulations at 11 CFR §§ 111.30-111.55. Attachment 1. The Commission's website contains further information about how the administrative fine program works and how the fines are calculated. See <http://www.fec.gov/af/af.shtml>. 11 CFR § 111.34. Your payment of \$9,030 is due within forty (40) days of the finding, or by July 24, 2017, and is based on these factors:

Sensitivity of Report: Not Election Sensitive  
Level of Activity: \$210,786  
Number of Days Late: Not Filed  
Number of Previous Civil Money Penalties Assessed: 0

At this juncture, the following courses of action are available to you:

**1. If You Choose to Challenge the RTB Finding and/or Civil Money Penalty**

If you should decide to challenge the RTB finding and/or calculated civil money penalty, you must submit a written response to the FEC's Office of Administrative Review, 999 E Street,

NW, Washington, DC 20463. Your response must include the AF# (found at the top of page 1 under your committee's identification number) and be received within forty (40) days of the Commission's RTB finding, or July 24, 2017. 11 CFR § 111.35(a). Your written response must include the reason(s) why you are challenging the RTB finding and/or calculated civil money penalty, and must include the factual basis supporting the reason(s) and supporting documentation. The FEC strongly encourages that documents be submitted in the form of affidavits or declarations. 11 CFR § 111.36(c).

The FEC will only consider challenges that are based on at least one of three grounds: (1) a factual error in the RTB finding; (2) miscalculation of the calculated civil money penalty by the FEC; or (3) your demonstrated use of best efforts to file in a timely manner when prevented from doing so by reasonably unforeseen circumstances that were beyond your control. 11 CFR § 111.35(b). In order for a challenge to be considered on the basis of best efforts, you must have filed the required report no later than 24 hours after the end of these reasonably unforeseen circumstances. *Id.* Examples of circumstances that will be considered reasonably unforeseen and beyond your control include, but are not limited to: (1) a failure of Commission computers or Commission-provided software despite your seeking technical assistance from Commission personnel and resources; (2) a widespread disruption of information transmissions over the Internet that is not caused by a failure of the Commission's or your computer systems or Internet service provider; and (3) severe weather or other disaster-related incident. 11 CFR § 111.35(c). Examples of circumstances that will not be considered reasonably unforeseen and beyond your control include, but are not limited to: (1) negligence; (2) delays caused by vendors or contractors; (3) treasurer and staff illness, inexperience or unavailability; (4) committee computer, software, or Internet service provider failures; (5) failure to know filing dates; and (6) failure to use filing software properly. 11 CFR § 111.35(d).

The "failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver" of your right to present such argument in a petition to the U.S. District Court under 52 U.S.C. § 30109. 11 CFR § 111.38.

If you intend to be represented by counsel, please advise the Office of Administrative Review. You should provide, in writing, the name, address and telephone number of your counsel and authorize counsel to receive notifications and communications relating to this challenge and imposition of the calculated civil money penalty.

## **2. If You Choose Not to Pay the Civil Money Penalty and Not to Submit a Challenge**

If you do not pay the calculated civil money penalty and do not submit a written response, the FEC will assume that the preceding factual allegations are true and make a final determination that Crane for Congress Inc. and you, in your official capacity as treasurer, violated 52 U.S.C. § 30104(a) and assess a civil money penalty.

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA"), as amended by the Debt Collection Improvement Act of 1996, 31 U.S.C. § 3701 *et seq.* The FEC may take any and all appropriate action authorized and required by the DCA, as amended, including transfer to the U.S. Department of the Treasury for collection. 11 CFR § 111.51(a)(2).

**3. If You Choose to Pay the Civil Money Penalty**

If you should decide to pay the calculated civil money penalty, follow the payment instructions on page 4 of this letter. Upon receipt of your payment, the FEC will send you a final determination letter.

**NOTICE REGARDING PARTIAL PAYMENTS AND SETTLEMENT OFFERS**

**4. Partial Payments**

If you make a payment in an amount less than the calculated civil money penalty, the amount of your partial payment will be credited towards the full civil money penalty that the Commission assesses upon making a final determination.

**5. Settlement Offers**

Any offer to settle or compromise a debt owed to the Commission, including making a payment in an amount less than the calculated civil money penalty assessed or any restrictive endorsements contained on your check or money order or proposed in correspondence transmitted with your check or money order, will be rejected. Acceptance and deposit or cashing of such a restricted payment does not constitute acceptance of the settlement offer. Payments containing restrictive endorsements will be deposited and treated as a partial payment towards the civil money penalty that the Commission assesses upon making a final determination. All unpaid civil money penalty amounts remaining will be subject to the debt collection procedures set forth in Section 2, above.

This matter was generated based on information ascertained by the FEC in the normal course of carrying out its supervisory responsibilities. 52 U.S.C. § 30109(a)(2). Unless you notify the FEC in writing that you wish the matter to be made public, it will remain confidential in accordance with 52 U.S.C. § 30109(a)(4)(B) and 30109(a)(12)(A) until it is placed on the public record at the conclusion of this matter in accordance with 11 CFR § 111.42.

To Whom It May Concern:

The 1<sup>st</sup> Quarter FEC filing for Crane for Congress, Inc. was completed by myself, Crystal Folmar, and was closed on 04/24/2017. I currently handle the business affairs of Michael Crane's construction business. Mr. Crane forwarded me the task to complete and introduced me to the FEC software downloaded on his computer. I visited the FEC website and read the directions on how to fill out the FEC Form 3 Quarterly report. I was given the sign on information and was told nothing had changed from the prior entries. Because of that information given to me, I did not change anything that was already in the system. The only thing I changed was the date on the FEC software to show the 1<sup>st</sup> Quarter for 2017.

After looking through the columns and familiarizing myself with the setup of the FEC file, I then validated the report and was given a notice that the validation passed with a warning message that the employer and occupation lines were missing conditionally required information. I looked back on prior FEC forms and saw they had not been filled in before. At that time, I closed the report, chose the date,, clicked on the green upload arrow button and uploaded the report. Once completed, I clicked on the printer button and printed a copy for our records and saved the file to the computer.

After filing away our copy, I went back to the reports column and the April 15 Quarterly line stated that it had been closed. I spoke with Michael Crane and we both were under the impression everything had been filed correctly. It was not until later that we received a letter that the Quarterly report was never received. Mr. Crane searched through his E-Mail and could not find a confirmation E-Mail from the Federal Election Commission regarding the 1<sup>st</sup> Quarter filing.


When we realized what had happened, we then forwarded this information to the company who had handled the filings before and they could not find it listed on the FEC website. They completed the form again and went ahead and filed the 1<sup>st</sup> and 2<sup>nd</sup> Quarter for us at that time. When they reviewed the account, they did find a \$50.00 difference in Operating Expenditures, (Line 7. (a)), and accounted for that change in the 1<sup>st</sup> Quarter that was filed by them. That finding also affected the Cash on Hand at Close of reporting, (Line 8).

It has taken us a little longer getting this information to you because I moved out of state in June and was not able to access the file and FEC software to verify what steps I had taken in order to send you this letter. I have attached my supporting documents of the file I had saved to our computer on 4/24/2017 and the picture of the closed file on the FEC software.

We were sent a letter from the Federal Election Commission that Crane for Congress, Inc. owed a civil money penalty of \$9,030.00. We believe this amount is based off a prior filing and not the current level of activity for that time period. If you would, please reevaluate the Level of Activity for this time period for Crane for Congress, Inc. based on the amounts of the 1<sup>st</sup> Quarter form that was filed again on July 31, 2017. We would appreciate notification of your findings. We greatly appreciate your time in this matter and hope to be able to clear this up very soon.

AF# 3328 – Crane for Congress, Inc. and Michael Crane, in his official capacity as Treasurer (C00476457)

**Summary of Recommendation**

Make a final determination that the respondents violated 52 U.S.C. § 30104(a) and assess a \$326 civil money penalty.

**Reason-to-Believe Background**

The 2017 April Quarterly Report was due on April 15, 2017. The respondents filed the report on July 31, 2017, 107 days late. The report is not election sensitive and was not filed within 30 days of the due date; therefore, the report is considered not filed. 11 C.F.R. §§ 111.43(d)(1) and (e)(1).

On June 14, 2017, the Commission found reason to believe ("RTB") that the respondents violated 52 U.S.C. § 30104(a) for failing to timely file the 2017 April Quarterly Report and made a preliminary determination that the civil money penalty was \$9,030 based on the schedule of penalties at 11 C.F.R. § 111.43. A letter was mailed to the respondents' address of record from the Reports Analysis Division ("RAD") on June 15, 2017 to notify them of the Commission's RTB finding and civil money penalty.

**Legal Requirements**

The Federal Election Campaign Act ("Act") states that the treasurer of a principal campaign committee shall file a report for the quarter ending March 31 no later than April 15. 52 U.S.C. § 30104(a) and 11 C.F.R. § 104.5(a)(1)(i). Reports electronically filed must be received and validated at or before 11:59 pm Eastern Standard/Daylight Time on the filing deadline to be timely filed. 11 C.F.R. §§ 100.19(c) and 104.5(e). The treasurer shall be personally responsible for the timely filing of reports. 11 C.F.R. § 104.14(d).

**Summary of Respondents' Challenge**

On September 5, 2017, the Commission received the written response ("challenge") from the Committee's bookkeeper. She explains that the Committee believed it properly closed and

uploaded the 2017 April Quarterly Report on April 24, 2017. The Committee did not realize the Commission never received the report but acknowledges they did not receive a filing confirmation email from the Commission. The bookkeeper requests that the Commission recalculate the penalty based on the actual level of activity disclosed on the 2017 April Quarterly Report.

### Analysis

The respondents contend they attempted to file the 2017 April Quarterly Report on April 24, 2017, but the report did not successfully upload to the Commission. They indicate they were not aware of the missing report until much later. However, the respondents should have been alerted to the upload error after not receiving the filing confirmation email. Further, on May 1, 2017, RAD sent a non-filer notification via email to "mcsenate28@gmail.com," the email address listed on the Committee's Statement of Organization, because the 2017 April Quarterly Report had not yet been filed. The Committee did not file the 2017 April Quarterly Report until July 31, 2017, 107 days late.

The Reviewing Officer recognizes the respondents' failure to file the 2017 April Quarterly Report may have been a mistake. However, failure to use filing software properly is included at 11 C.F.R. § 111.35(d) as an example of a circumstance that will not be considered reasonably unforeseen and beyond the respondents' control. The respondents' challenge fails to address any of the three valid grounds at 11 C.F.R. § 111.35(b). These are: (i) the RTB finding is based on factual errors; and/or (ii) the improper calculation of the civil money penalty; and/or (iii) they used best efforts to file on time but were prevented from doing so by reasonably unforeseen circumstances that were beyond their control and they filed the report no later than 24 hours after the end of these circumstances. Therefore, the Reviewing Officer recommends that the Commission make a final determination that the respondents violated 52 U.S.C. § 30104(a).

At the time of the RTB finding, the Commission used an estimated level of activity (\$210,786) to calculate the penalty because the 2017 April Quarterly Report had not yet been filed. 11 C.F.R. § 111.43(d)(2)(i). The Committee successfully electronically filed the 2017 April Quarterly Report on July 31, 2017, 107 days late. The report discloses \$1,000 in total receipts and \$3,538 in total disbursements. Therefore, the actual level of activity of the 2017 April Quarterly Report is \$4,538. Using the schedule of penalties at 11 C.F.R. § 111.43(a) for the level of activity bracket of \$1 - \$4,999.99, the civil money penalty is  $\$326 \times [1 + (.25 \times 0 \text{ previous violations})]$  or \$326. Therefore, the Reviewing Officer recommends that the Commission assess a \$326 civil money penalty, reduced from the RTB civil money penalty of \$9,030.



### **OAR Recommendations**

1. Adopt the Reviewing Officer recommendation for AF# 3328 involving Crane for Congress, Inc. and Michael Crane, in his official capacity as Treasurer, in making the final determination;
2. Make a final determination in AF# 3328 that Crane for Congress, Inc. and Michael Crane, in his official capacity as Treasurer, violated 52 U.S.C. § 30104(a) and assess a \$326 civil money penalty (reduced from the RTB civil money penalty of \$9,030); and
3. Send the appropriate letter.

Dear Mr. Crane:

On June 14, 2017, the Commission found reason to believe ("RTB") that Crane for Congress, Inc. and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a) for failing to timely file the 2017 April Quarterly Report and made a preliminary determination that the civil money penalty was \$9,030 based on the schedule of penalties at 11 C.F.R. § 111.43. On September 5, 2017, the Office of Administrative Review received your written response challenging the RTB finding.

The Reviewing Officer reviewed the Commission's RTB finding with its supporting documentation and your written response. Based on this review, the Reviewing Officer recommended that the Commission reduce the RTB civil money penalty because it was calculated using an estimated level of activity, make a final determination that Crane for Congress, Inc. and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a), and based on the actual level of activity disclosed on the 2017 April Quarterly Report filed July 31, 2017, assess a civil money penalty in the amount of \$326 in accordance with 11 C.F.R. § 111.43. The Reviewing Officer Recommendation was sent to you on October 25, 2017.

On November 9, 2017, the Commission adopted the Reviewing Officer's recommendation and made a final determination that Crane for Congress, Inc. and you, in your official capacity as Treasurer, violated 52 U.S.C. § 30104(a), and based on the level of activity disclosed on the 2017 April Quarterly Report (\$4,538), assessed a civil money penalty in the amount of \$326 (reduced from the RTB civil money penalty of \$9,030). It is based on the same factors used to calculate the civil money penalty at RTB except that the actual rather than the estimated level of activity was used. A copy of the Final Determination Recommendation is attached.

At this juncture, the following courses of action are available to you:

**1. If You Choose to Appeal the Final Determination and/or Civil Money Penalty**

If you choose to appeal the final determination, you should submit a written petition, within 30 days of receipt of this letter, to the U.S. District Court for the district in which the committee or you reside, or transact business, requesting that the final determination be modified or set aside. See 52 U.S.C. § 30109(a)(4)(C)(iii). Your failure to raise an argument in a timely fashion during the administrative process shall be deemed a waiver of the respondents' right to present such argument in a petition to the district court under 52 U.S.C. § 30109. 11 CFR § 111.38.

**2. If You Choose Not to Pay the Civil Money Penalty and Not to Appeal**

Unpaid civil money penalties assessed through the Administrative Fine regulations will be subject to the Debt Collection Act of 1982 ("DCA") as amended by the Debt Collection Improvement Act of 1996 ("DCIA"), 31 U.S.C. § 3701 *et seq.* If you do not pay this debt within 30 days (or file a written petition to a federal district court - see below), the Commission will transfer the debt to the U.S. Department of the Treasury ("Treasury") for collection. Within 5 days of the transfer to Treasury, Treasury will contact you to request payment. Treasury currently charges a fee of 30% of the civil money penalty amount for its collection services. If the age of the debt is greater than or equal to two years old, Treasury will charge a fee of 32% of the civil money penalty amount for its collection services. The fee will be added to the amount of the civil money penalty that you owe. Should Treasury's attempts fail, Treasury will refer the debt to a private collection agency ("PCA"). If the debt remains unpaid, Treasury may recommend that the Commission refer the matter to the Department of Justice for litigation.

Actions which may be taken to enforce recovery of a delinquent debt by Treasury may also include: (1) offset of any payments, which the debtor is due, including tax refunds and salary; (2) referral of the debt to agency counsel for litigation; (3) reporting of the debt to a credit bureau; (4) administrative wage garnishment; and (5) reporting of the debt, if discharged, to the IRS as potential taxable income. In addition, under the provisions of DCIA and other statutes applicable to the FEC, the debtor may be subject to the assessment of other statutory interest, penalties, and administrative costs.

In accordance with the DCIA, at your request, the agency will offer you the opportunity to inspect and copy records relating to the debt, the opportunity for a review of the debt, and the opportunity to enter into a written repayment agreement.

**3. If You Choose to Pay the Civil Money Penalty**

If you should decide to pay the civil money penalty, follow the payment instructions on page 4 of this letter. You should make payment within thirty (30) days of receipt of this letter.

## **NOTICE REGARDING PARTIAL PAYMENTS AND SETTLEMENT OFFERS**

### **4. Partial Payments**

If you make a payment in an amount less than the civil money penalty, the amount of your partial payment will be credited towards the full civil money penalty that the Commission assessed upon making a final determination.

### **5. Settlement Offers**

Any offer to settle or compromise a debt owed to the Commission, including a payment in an amount less than the civil money penalty assessed or any restrictive endorsements contained on your check or money order or proposed in correspondence transmitted with your check or money order, will be rejected. Acceptance and deposit or cashing of such a restricted payment does not constitute acceptance of the settlement offer. Payments containing restrictive endorsements will be deposited and treated as a partial payment towards the civil money penalty that the Commission assessed upon making a final determination. All unpaid civil money penalty amounts remaining will be subject to the debt collection procedures set forth in Section 2, above.

The confidentiality provisions at 52 U.S.C. § 30109(a)(12) no longer apply and this matter is now public. Pursuant to 11 C.F.R. §§ 111.42(b) and 111.20(c), the file will be placed on the public record within 30 days from the date of this notification.
