Attached is a list of political committees and their treasurers who failed to file or timely file the 2000 September Monthly Report in accordance with 2 U.S.C. 434(a). On January 27, 2000, Prior Notice was sent to all political committees and their treasurers, informing them that the September Monthly Report was due on September 20, 2000. The report should cover from August 1, 2000 (or the closing date of the last report filed or, if the committee is newly registered, all activity that occurred before registration) through August 31, 2000.

The committees listed in the attached RTB Circulation Report either filed the report more than five (5) days after the due date, failed to file the report or filed the report more than 30 days after the due date (considered a non-filed report). In accordance with the schedule of civil money penalties for reports at 11 CFR 111.43, these committees should be assessed the civil money penalties included on the report provided.

I Andrea L. Engler, being duly sworn upon oath, depose and state as follows:

2. I am employed by Northwest Airlines, Inc. ("Northwest") as an Executive Assistant to John O. Klinkenberg, Treasurer, Northwest Political Action Committee. I have been employed by Northwest since August 15, 1994.

3. As part of my duties as Executive Assistant, I was responsible for filing Northwest's September 2000 Monthly Report covering the period from 08/01/00-08/31/00.

4. On September 19, 2000, in preparation for filing the September Monthly Report, I completed a Northwest Federal Express Request Form. I delivered the package and the form to the Northwest mail room where the package was assigned a Federal Express tracking number. The tracking number assigned to Northwest's package was 4641 7429 1912. The tracking number appears at the top right-hand corner of the form. A true and correct copy of Northwest's Federal Express Request Form with the package number affixed is attached hereto as Exhibit A. In addition, the tracking number and the addressee information were recorded on Northwest's Shipped to Detail Report. A true and correct photocopy of the report is attached hereto as Exhibit B.

5. On September 19, 2000, I filed Northwest's September Monthly Report by forwarding it via Federal Express to the Federal Election Committee, 999 E. Street, NW, Washington, DC 20463. A true and correct photocopy of Northwest's September 19, 2000 filing is attached hereto as Exhibit C.

6. In response to correspondence dated October 10, 2000, from the Federal Election Commission ("FEC") indicating that Northwest failed to file its September Monthly Report in a timely manner, I reviewed tracking information from the Federal Express Web Site regarding package # 4641 7429 1912. A true and correct photocopy of the October 10, 2000 FEC letter is attached hereto as Exhibit D.

7. The Federal Express tracking information that I retrieved and printed from the Federal Express Web Site indicated that package # 4641 7429 1912 was delivered to the FEC at 9:26 a.m. on September 20, 2000. The Federal Express record that I retrieved and printed indicated that the package was signed for by R. Watts. A true and correct photocopy of the applicable Federal Express Web Site tracking page regarding package # 4641 7429 1912 is attached hereto as Exhibit E.

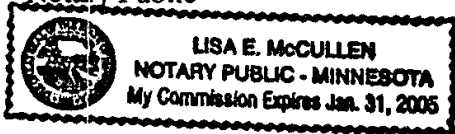





Committees wishing to change their reporting schedule (for example, from monthly to quarterly) must notify the Commission in writing when they file their next report due under their current reporting schedule. Committees may change their filing frequencies no more than once per calendar year.

LABEL

Committees should affix the peel-off label from the envelope to Line 1 of the report. Corrections should be made on the label.

ELECTRONIC FILING

Political committees have the option of filing their reports electronically. If you are interested in this option, review the enclosed handout entitled "Electronic Filing," and call the Data Division at (800) 424-9530 or (202) 694-1306.

COMPLIANCE

Treasurers of political committees are responsible for the accuracy of all reports and for filing all reports on time. Treasurers may be subject to enforcement action if reports are not filed timely or reports are inaccurate. Committees filing illegible reports or using non-FEC forms (except for FEC approved computer generated forms) will be required to refile.

AF# 92 - Northwest Airlines PAC and John O. Klinkenberg, as Treasurer

On October 30, 2000, the Federal Election Commission ("the Commission") found reason to believe ("RTB") that Northwest Airlines PAC and John O. Klinkenberg, as Treasurer ("the respondents"), violated 2 U.S.C. § 434(a) for failing to file the 2000 September Monthly Report in a timely manner and made a preliminary determination that the civil money penalty was \$825.00 based on the schedule of penalties at 11 C.F.R. § 111.43. Respondents were notified by the Reports Analysis Division via mailgram on November 1, 2000 of the Commission's finding and civil money penalty calculated at RTB.

Respondents' Response

On December 8, 2000, the Commission received the written response ("challenge") from the respondents challenging the RTB finding. Respondents state that "the Commission's finding is in error. Northwest's September Monthly Report was filed within the prescribed time period." Andrea L. Engler, Executive Assistant to the Treasurer, states in her affidavit that she forwarded the report via Federal Express on September 19 and the "Federal Express tracking information that I retrieved and printed from the Federal Express Web Site indicated that package #4641 7429 1912 was delivered to the FEC at 9:26 a.m. on September 20, 2000." Respondents request that "the Commission withdraw the proposed RTB Finding and the Civil Money Penalty."

Analysis of Challenge

The September Monthly Report was sent via Federal Express on September 19, 2000 and received on September 20, 2000. It was filed in a timely manner. Based on a review of the Commission's records, the report was received on September 20, 2000 and placed in respondents' file folder prior to being microfilmed and entered into the Commission's database.

Respondents' challenge presented evidence that a factual error was made and the Reviewing Officer determined that the report had been received in a timely manner. The Reviewing Officer, therefore, recommends that the Commission take no further action and close the file.



YOUR FAILURE TO RAISE AN ARGUMENT IN A TIMELY FASHION DURING THE ADMINISTRATIVE PROCESS SHALL BE DEEMED A WAIVER OF THE RESPONDENT'S RIGHT TO PRESENT SUCH ARGUMENT IN A PETITION TO THE DISTRICT COURT UNDER 2 U.S.C. 437G. 11 C.F.R. 111.38.

THE CONFIDENTIALITY PROVISIONS AT 2 U.S.C. 437G(A)(12) NO LONGER APPLY AND THIS MATTER IS NOW PUBLIC. THE FILE WILL BE MADE A PART OF THE PUBLIC RECORD PURSUANT TO 11 C.F.R. 111.4219). ALTHOUGH THE COMPLETE FILE MUST BE PLACED ON THE PUBLIC RECORD WITHIN 30 DAYS FROM THE DATE OF THE COMMISSION'S NOTIFICATION, THIS MAY OCCUR AT ANY TIME FOLLOWING CERTIFICATION OF THE COMMISSION'S VOTE.
