III. BACKGROUND:

Failure to Provide Supporting Schedules (Failure to Timely File 48-Hour Reports)

Rural Colorado United (“the Committee”) failed to timely file two (2) 48-Hour Reports totaling \$76,401.99 to support seventeen (17) independent expenditures disclosed in the 2020 October Quarterly Report, made up to and including the 20th day before the 2020 General Election (Attachment 2).

On October 15, 2020, the Committee filed its 2020 October Quarterly Report, covering the period from July 1, 2020 through September 30, 2020. The report included a Schedule E (Itemized Independent Expenditures) disclosing twenty-one (21) independent expenditures totaling \$80,486.33 made in opposition to one (1) Federal candidate (Images 202010159294409020-30).

On December 10, 2020, a Request for Additional Information (RAFI) was sent to the Committee referencing the 2020 October Quarterly Report. Among other items, the

RFAI noted that the Committee may have failed to file one (1) or more of the required 48-Hour Reports regarding independent expenditures. A chart was included with the RFAI identifying seventeen (17) independent expenditures, totaling \$76,401.99, for which a 48-Hour Report had not been filed (Images 202012100300095320-23, Attachment 2).¹

On December 15, 2020, Bobbie Kuns, a representative of the Committee, called the Reports Analysis Division (RAD) Analyst with questions regarding the RFAI referencing the 2020 October Quarterly Report. Ms. Kuns explained she did not believe that 48-Hour Reports needed to be filed until the 20th day before a given election. The Analyst explained that 48-Hour Reports were required for independent expenditures made up to and including the 20th day before the day of a given election each time independent expenditures for that election aggregated to \$10,000.00 or more. Ms. Kuns said she would file the missing 48-Hour Reports. The Analyst encouraged her to do so and informed her the reports would still be considered not timely filed (Attachment 3).

On December 18, 2020, the Committee filed one (1) 24-Hour Report to support twenty-eight (28) independent expenditures, totaling \$82,977.61, disseminated on September 1, 2020, September 3, 2020, September 9, 2020, September 14, 2020, September 18, 2020, September 24, 2020, September 28, 2020, September 29, 2020, October 17, 2020, October 24, 2020, October 31, 2020, and November 18, 2020 (Images 202012189393370015-28).²

On January 14, 2021, the Committee filed an Amended 2020 October Quarterly Report. The report disclosed no changes to Schedule E from the original report (Images 202101149404571945-91, Attachment 2).

On April 8, 2021, the RAD Analyst called George Autobee, the Committee's Treasurer, to discuss the outstanding issues noted on the RFAI referencing the 2020 October Quarterly Report. The Analyst explained that the Committee could be referred to another Commission office for potential further action. Mr. Autobee asked if the Commission had received the 48-Hour Report filed on December 18, 2020. The Analyst confirmed receipt of the 48-Hour Report; however, explained that the outstanding matter remained unresolved because the Report had not been timely filed. The Analyst encouraged Mr. Autobee to provide any additional information he had regarding the circumstances surrounding the report not being timely filed (Attachment 3).

Also, on April 8, 2021, Ms. Kuns called the RAD Analyst several times to discuss the outstanding issues from the RFAI referencing the 2020 October Quarterly Report. Ms. Kuns explained that she believed that the matter was resolved when the Committee filed the missing 48-Hour Report on December 18, 2020. The Analyst explained the outstanding matter was not resolved because the report was not timely filed. The Analyst encouraged Ms. Kuns to file any additional information she had detailing the circumstances

surrounding the report not being timely filed via an FEC Form 99 (Miscellaneous Electronic Submission). She said that she would file a response as soon as possible (Attachment 3).

On April 9, 2021, the RAD Analyst called Ms. Kuns. Among other matters, the Analyst and Ms. Kuns continued to discuss the outstanding matter noted on the RFAI referencing the 2020 October Quarterly Report. Ms. Kuns indicated that she would file an FEC Form 99 in response to the RFAI later that day (Attachment 3).

Also, on April 9, 2021, Ms. Kuns called the RAD Analyst with a reporting question concerning how the Committee may file an FEC Form 99 in response to the RFAI referencing the 2020 October Quarterly Report. The Analyst directed her to the FEC Online Webforms and provided step-by-step instructions detailing how to provide a narrative statement on the public record (Attachment 3).

On April 12, 2021, the RAD Analyst called Ms. Kuns to discuss the outstanding issue noted on the RFAI referencing the 2020 October Quarterly Report. The Analyst explained that the Commission had not received the Committee's FEC Form 99 in response to the RFAI. Ms. Kuns stated that she would file the FEC Form 99 response that day (Attachment 3).

On that same day, the Committee filed an FEC Form 99 in response to the RFAI referencing the 2020 October Quarterly Report. The Committee stated, in part:

“One or more of the 24 hour reports were not filed in a timely manner. As soon as we realized we were required to file 24 hour reports, we began filing them. We now are aware and understand the reporting requirements, and have strived to stay in compliance since” (Image 202104129443213594).

To date, no further communication has been received from the Committee regarding this matter.
