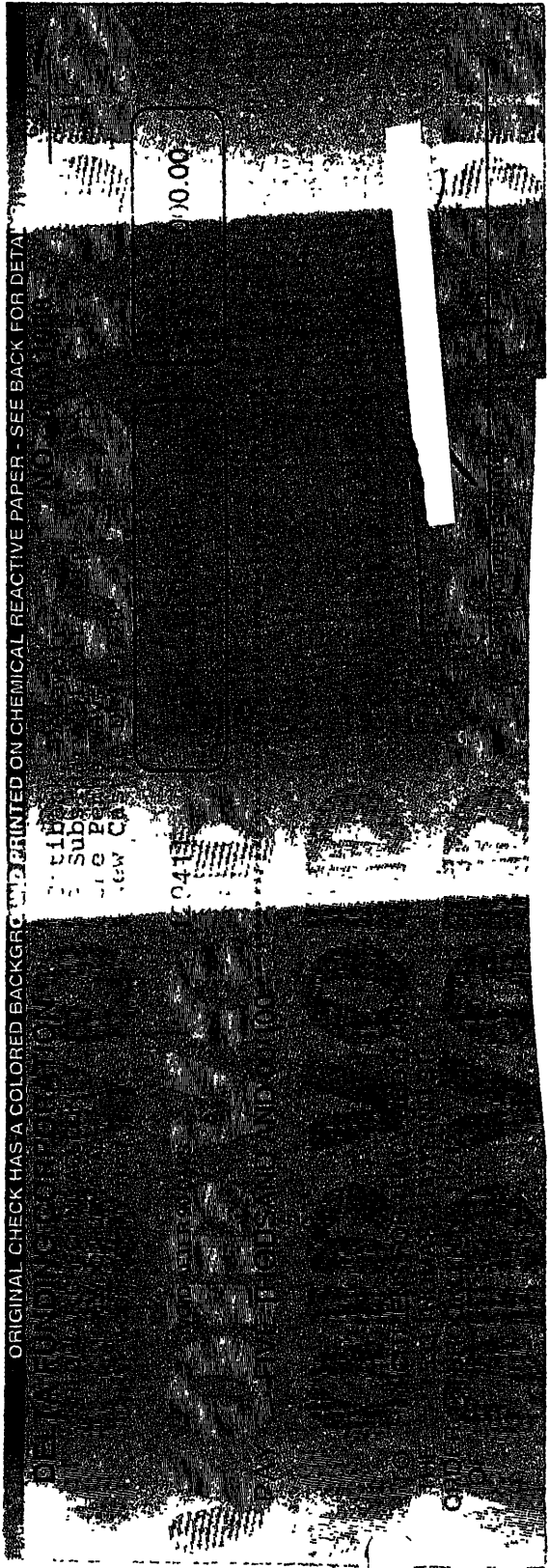





Dear Mr. Jordan:

Pursuant to the Statement of Designation of Counsel previously filed by my client, Shinda Management Corporation, and on their behalf, I will state that the corporation has received a reimbursement check in the amount of \$500.00 dated March 19, 2004; from "Citizens for Tracy L. Boyland". That is the amount my client contributed to the "Citizens for Tracy L. Boyland" Committee.

My client did not realize at the time the contribution was made by the corporation that it was not allowed, and in fact, did not know that the contribution was for a Federal position as opposed to a State or City elective position.


