Dear Ms. Fraser:

Thank you for forwarding the Reports Analysis Referral to me. The initial RFAs from the Audit Division inquired about numerous printings of pamphlets and leaflets, many of which do not appear to be at issue in the referral.

The FEC chart attached to the referral concerns a variety of leaflets and pamphlets which are the publications at issue in the three failures to file 48 hour notices and the five failures to file 24 hour notices cited in the referral. After review of the FEC chart and in conjunction with preparing the Committee's responses, I felt it prudent to confirm which specific leaflets and pamphlets are at issue.

I also note what appears to be an error in the FEC chart. The chart annexed to this letter reproduces the FEC chart attached to the referral with two exceptions -- it replaces the column indicating the candidate opposed, which in all instances was George Bush, with the description of the purpose of the expenditure set forth in the Committee's reports. This allows confirmation that the FEC and the Committee are addressing the same publications as we proceed in this matter. It also corrects an error on the first page of the FEC chart.

Could you confirm that the annexed chart correctly sets forth the specific publications which are at issue? Could you also confirm that the fifth item down on the first page of the
