
Dear Mr. Jordan.

My letter to you, dated August 22, 2006, was a response to your letter to me, dated August 18, 2006, regarding MUR 5794. This letter gives additional information and discloses actions that I may take.

I have found on your web site the applicable amended FEC Form 3 filled by Emily Cummins on July 16, 2006. A copy of the page reporting my contributions is enclosed. My initial contribution of \$500 is shown as being for the general election; however, the check was written and mailed from Raleigh on May 1, 2006 at which time Mr. Robinson was not a general election candidate. The Form 3 shows that they received the check in Winston Salem on May 3, 2006, the day after the election. It is possible that on that day some people in Mr. Robinson's office were suffering from the after effects of a victory celebration. Obviously, the solicitation material to which I was responding applied to the primary election. I think it follows that I intended to contribute to the primary election. Unfortunately, it is likely that the memo field of my check said "political contribution" and not "primary election." It is clear from Mr Robinson's letter, dated May 22, 2006 and furnished to you, that he believed my \$500 contribution was made to his primary election campaign. The Form 3 error may be innocent, but it could also be sabotage by someone in his office. I will probably ask the Robinson campaign to correct this reporting error. I expect to tell them that their carelessness has resulted in MUR 5794, however, I do not intend to tell them anything else. I may also contact Senator Richard Burr with some FEC suggestions based on my experience.

I do not understand your statement regarding confidentiality in your August 18, 2006 letter. I am trained as an engineer not an attorney. I do not intend to disclose to Senator Burr anything about MUR 5794 that involves other targets of your investigation. If my intended actions require that I notify the Commission in writing that I wish the matter to be made public, then this letter is my notification to the Commission.
