On 06/07/11 Ferndale Mayor Gary S. Jensen recorded a deposit of \$700.00, with the Washington Public Disclosure Commission, from FLEETWOOD INTL DEVELOPMENT CORP. (FIDC), located at 2690 Thornton Rd Ferndale WA 98248. Upon further investigation it is clear that FIDC is a Canadian firm located at 13847 33 AVE SURREY BC V4P 2B4.

Attached are:

- 1) The PDC C-3 Form showing the receipt of money from FIDC to Gary S. Jensen.
- 2) Property details from the Whatcom County Assessor & Treasurer for year 2010-2011, demonstrating FIDC has 100% ownership of the property used to register the \$700.00 contribution.
- 3) Canadian corporate documents for FIDC showing that the company is in fact located in Canada, and thus a foreign corporation.

These documents show that in fact Gary S. Jensen has taken foreign money, which is a violation of federal election law. Please do not hesitate to contact me at (518) 926-8900 with any further questions.

**Note:** This is the third letter our campaign has sent in an attempt to meet the FEC compliance standards for illegal campaign contributions complaint filing. The individual handling this paperwork has, in her possession, all the evidence listed in the above paragraphs.
