Dear Messrs Elias and Berkon:

The Federal Election Commission (FEC or Commission) requested the Office of General Counsel (OGC) refer Pre-MUR 534, RR 12L-18, RR 12L-43 to the ADR Office. The ADR Office designated the referrals as ADR 683, ADR 685 and ADR 687 respectively. The sua sponte submission and the referrals by the Reports Analysis Division (RAD) were based on the potential misuse of campaign funds by the Committees' former Treasurer, which reflect a possible failure to comply with the Federal Election Campaign Act of 1971, as amended. These three ADR matters will be consolidated for the purpose of settlement absent Respondents' objection.

The FEC established the ADR Program to provide an informal means for resolving matters that come before the Commission and to facilitate negotiations directly with the Committee. The ADR Program provides Respondents with an opportunity to negotiate settlement of a matter that is mutually agreeable. If negotiations are successful, the resulting settlement concludes the matter.

The Commission, in referring the matter to the ADR Office, determined that the case is eligible for processing in the ADR program. If Respondents decide to participate in the ADR Program, you must: 1) indicate in writing a willingness to have your case submitted for ADR processing; 2) agree to participate in the bilateral interest based negotiations; and 3) waive the statute of limitations while the matter is being processed under the FEC's ADR program.

The issues referred to the ADRO, and the focus of our subsequent negotiations, are those identified in the correspondence the Committee received from OGC.

If after reviewing this letter and the enclosed ADR Frequently Asked Questions, which describe the ADR program, Respondents would like to participate in ADR processing, you need to affirmatively indicate that on the enclosed Commitment to Submit Matter to ADR form. **Failure to respond affirmatively within fifteen (15) business days of receipt of this letter will be taken as a notice of disinterest in the program and your case will be dropped from further consideration for ADR.** In that event, your case will be sent to the FEC's Office of General Counsel for further processing, and the likelihood that the Committee will be audited during the next election cycle will increase.
