To Whom it May Concern:

This letter serves as an official complaint against the committee "Sharon Sund for Congress" (FEC ID# C00499137), and its associated representatives, Ms. Sharon Sund (Candidate), and Mr. Eugene Roberson (Treasurer). This committee is registered with the FEC as a congressional campaign in Minnesota's 3rd Congressional District for the 2014 cycle.

My name is Nicholas A. Passanante, founder and principal consultant of BoulderStrategies LLC, a general consulting firm based in Boulder, Colorado. My address is 780 Utica Avenue, Boulder CO 80304-0755.

This complaint is based on the October quarterly filing of Oct. 15, 2014 (FILING FEC-959671). As of that filing, the respondent committee has an outstanding debt to BoulderStrategies LLC of \$14,840.82. This account is now 75 days past due and has been referred to our collections agency, Stevens & Ricci Inc. Associated invoices, correspondence and contract has been enclosed with this letter for review.

Despite being in receipt of these invoices and having had multiple interactions with our collections agency, the respondent committee has failed to report the outstanding debt on their Schedule D of the October quarterly filing, as required under 11 CFR 104.3(d), 104.11 and 11 CFR 116.1(d).

We ask that the committee be reprimanded and immediately held accountable to standard reporting requirements, including an accurate accounting of their outstanding debts to vendors. We request that the respondent file an amended October quarterly reflecting a debt of \$14,840.82 to BoulderStrategies LLC.

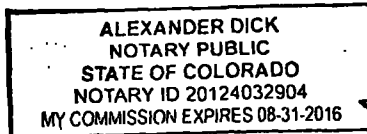
