1) There may be a secretary at the event, handing out name tags, and maybe a waiter or other incidental catering personnel, but that would be the extent of attendance by Hawaiian employees outside the restricted class involved in the proposed events. No employees outside the restricted class will be invited.

2) While the actual makeup of the attendees is unknown at this time, the invitee list will comprise slightly more than half outside travel and tourism industry people who are not Hawaiian stockholders and slightly less than half

employees within Hawaiian's restricted class.

3) Hawaiian will extend invitations to all general election candidates for the U.S. Senate seat from Hawaii.
