This matter was initiated by a signed, sworn, and notarized complaint by James Schoener. An investigation has been conducted, and the Commission has found probable cause to believe that the Congressional Majority Committee and Ralph J. Galliano, as treasurer, ("Respondent") violated 2 U.S.C. § 434(a)(4)(B) by failing to file in a timely manner the 1983 February, March, April, July, August, October, November and December Monthly Reports; the 1983 Year End Report; and the 1984 February Monthly Report.

NOW THEREFORE, the Commission and Respondent, having duly entered into conciliation pursuant to 2 U.S.C. § 437g(a)(4)(A)(i) do hereby agree as follows:

I. The Commission has jurisdiction over Respondent, and the subject matter of this proceeding.

II. Respondent has had a reasonable opportunity to demonstrate that no action should be taken in this matter.

III. Respondent enters voluntarily into this agreement with the Commission.

IV. The pertinent facts in this matter are as follows:





GENERAL COUNSEL'S REPORT FEB 05 1985

I. BACKGROUND

On November 27, 1984, the Commission found probable cause to believe that the Congressional Majority Committee ("CMC") and Ralph J. Galliano, as treasurer, violated 2 U.S.C. § 434(a)(4)(B) for failing to file in a timely manner ten reports during the 1984 election cycle. The reports were filed between 7 and 37 days late.

On December 18, 1984, Mr. Galliano responded to the Commission's probable cause to believe notification and proposed conciliation agreement (Attachment I).



This letter is in response to your letter dated December 3, 1984 regarding the Commission's determination that there is probable cause to believe the Congressional Majority Committee (CMC) violated 2 U.S.C. Section 434(a)(4)(B).

Although not in a timely manner, our reports were filed prior to the filing of Mr. Schoener's complaint and therefore prior to the notification. In fact, CMC's February 1984 Monthly Report was filed on February 23, 1984 not on February 27, 1984 as alleged in your December 3, 1984 letter. (See attached). The complaint which precipitated MUR 1635 was filed on February 24, 1984. Moreover, substantial compliance has been achieved.


In MUR 1483 the Commission found reason to believe yet took no further action and closed the file. The First General Counsel's Report dated November 18, 1984 clearly stated:

"Although not in a timely fashion, the contributions were reported prior to the filing of the complaint or notification by the Commission and substantial compliance has been achieved. Therefore, it is recommended that the Commission find reason to believe, take no further action and close the file."


On November 27, 1984, the Commission determined that there is probable cause to believe the Congressional Majority Committee and you, as treasurer, committed a violation of 2 U.S.C. § 434(a)(4)(B), a provision of the Federal Election Campaign Act of 1971, as amended in connection with the Committee's failure to file in a timely manner ten reports during the 1984 election cycle.

The Commission has a duty to attempt to correct such violations for a period of thirty to ninety days by informal methods of conference, conciliation and persuasion, and by entering into a conciliation agreement. If we are unable to reach an agreement during that period, the Commission may institute civil suit in United States District Court and seek payment of a civil penalty.

We enclose a conciliation agreement that this office is prepared to recommend to the Commission in settlement of this matter. I. BACKGROUND

A complaint was filed against the Congressional Majority Committee ("CMC") by James Schoener on February 23, 1984, alleging CMC's violation of 2 U.S.C. § 434(a)(4)(B) by failing to file its February 1984 Monthly Report.

Upon review of CMC's disclosure documents for the current election cycle, the Office of General Counsel has determined that in addition to the 1984 February Monthly Report, CMC failed to file in a timely manner nine additional reports. On April 11, 1984, the Commission determined there was reason to believe that CMC and its treasurer, John Gizzi, violated 2 U.S.C.

§ 434(a)(4)(B) by failing to file in a timely manner the following reports:



On , 1984, the Commission determined that there is probable cause to believe the Congressional Majority Committee and you, as treasurer, committed a violation of 2 U.S.C. § 434(a)(4)(B), a provision of the Federal Election Campaign Act of 1971, as amended in connection with the Committee's failure to file in a timely manner ten reports during the 1984 election cycle.

The Commission has a duty to attempt to correct such violations for a period of thirty to ninety days by informal methods of conference, conciliation and persuasion, and by entering into a conciliation agreement. If we are unable to reach an agreement during that period, the Commission may institute civil suit in United States District Court and seek payment of a civil penalty.

We enclose a conciliation agreement that this office is prepared to recommend to the Commission in settlement of this matter. If you agree with the provisions of the enclosed agreement, please sign and return it along with the civil penalty to the Commission within ten days. I will then recommend that the Commission approve the agreement.

This letter hereby constitutes the Congressional Majority Committee's (CMC) brief as requested by your letter dated August 2, 1984 alleging a violation of 2 U.S.C. 434(a)(4)(B) for failing to file monthly reports in a timely manner.

In as much as several complaints have been filed by the same source, CMC would like to clarify the filing of this particular complaint.

In the General Council's brief accompanying the August 2, 1984 letter, it is stated that a complaint was filed in March 6, 1984 against the Congressional Majority Committee by James Schoener. CMC's records show that this complaint was filed on February 24, 1984 rather than March 6th. Please clarify.

Furthermore, it is important to point out that James Schoener in the course of his complaint while appearing to act independently at the time was actually acting on behalf of the "Friends of Phil Gramm" (FPG) campaign committee against the Congressional Majority Committee. This came as a result of a campaign dispute between CMC and FPG due to CMC's independent expenditure campaign called "Americans for Phil Gramm in '84". Clearly, James Schoener was not simply acting in his capacity as a good citizen informing the FEC of a possible violation. Instead, he acted in a manner meant to punish and harass CMC.

This dispute between CMC and FPG has since been settled. See attached letter.

Surely, there are numerous uncounted violations of 2 U.S.C. 434(a)(4)(B) which the Commission has bypassed for one reason or another as was the case with CMC until Mr. Schoener filed his complaint. Perhaps in certain instances violations are not brought not to the Commission's attention and therefore are never acted upon. In this particular case, (MUR 1635) the General Council's Brief lists alleged violations of 2 U.S.C. 434(a)(4)(B) spanning one entire year from February 1983 through February 1984 before the matter prompted by James Schoener was acted upon in this manner by the Commission.

Surely, the public interest has not been harmed by these minor delays in as much as CMC is not a candidate committee from which the voters have a right to expect timely disclosures to see where the candidate's money is coming from.

For the most part, these late filings were in 1983 which was not an election year. Since it was a non-election year a number of late filings CMC elected to file was as a monthly filer. If CMC had not done so, it would have been required to file quarterly and therefore delays would have not occurred.

As indicated in my letter to you dated April 30, 1984, CMC had experienced serious staff problems with respect to bookkeeping assistance. This led to CMC's inability to file its monthly reports in a timely manner. Yet, it should be pointed out that CMC did not attempt to shirk its responsibility but always filed a complete monthly report as required.

In view of the above arguments, it is hereby requested that the Commission take no further action in this case.



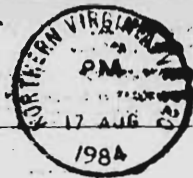

On April 11, 1984, the Commission determined that there was reason to believe that the Congressional Majority Committee and its treasurer, John Gizzi, violated 2 U.S.C. § 434(a)(4)(B) for failing to file in a timely manner the 1983 February, March, April, July, August, October, November, and December Monthly Reports; the 1983 Year End Report; and the 1984 February Monthly Report. The reason to believe notification was mailed on April 13, 1984.

LEGAL ANALYSIS

Pursuant to 2 U.S.C. § 434(a)(4)(B) all political committees other than authorized committees of a candidate shall file monthly reports in all calendar years no later than the 20th day after the last of the month and shall be complete as of the last day of the month, and a year end report which shall be filed no later than January 31 of the following calendar year.

CMC was required to file its monthly reports no later than the 20th day of each month. Nine Monthly Reports and a Year End Report were filed by CMC between 7 and 37 days late. CMC's failure to comply with the reporting requirements is a violation of 2 U.S.C. § 434(a)(4)(B). Thus, it is the recommendation of

the General Counsel that the Commission find probable cause to believe that CMC violated 2 U.S.C. § 434(a)(4)(B).

RECOMMENDATION

The Office of General Counsel recommends that the Commission find probable cause to believe that the Congressional Majority Committee and Ralph Galliano, as treasurer, violated 2 U.S.C. § 434(a)(4)(B).
