
Dear Mr. Sabatine:

The Federal Election Commission has received a notification, which does not qualify as a complaint under our interim complaint procedure guideline, concerning an alleged unlawful political contribution to the OCAW Political and Legislative League. The person making the allegation states that the contribution was given by him, an hourly paid employee, to another hourly paid employee during normal working hours, and is thus an unlawful transaction.

Please be advised that the Commission can find no apparent violation of the Federal Election Campaign Act either on the part of the complainant or on the part of the OCAW Political and Legislative League.

In this case, no further action is contemplated by this office. OCAW need take no further action in this matter unless it chooses to do so.



Dear Mr. Baer:

This is in response to your recent letter, received in this office on July 21, 1975, concerning your belief that you have made an illegal political contribution to the OCAW Political and Legislative League.

The Federal Election Campaign Act Amendments of 1971, which became effective January 1, 1975, established a Federal Election Commission. While this office is continuing to receive reports from Senate candidates and their co-writers, civil jurisdiction over the Act lies with the Commission. Specifically, Title 2, Section 437g(a)(1)(A), United States Code, provides that:

"Any person who believes a violation of this Act or of Section 300, 609, 611, 613, 614, 615, 616 or 617 of Title 18, United States Code, has occurred may file a complaint with the Commission."

Accordingly, I have referred your letter to the Commission for their consideration and response.



A duplicate copy of this contribution is enclosed for your information.


