Dear Mr. Edwards:

This letter is in response to the letter received by Peter G. Velasco on November 5, 1984, from Lee Ann Elliott regarding the above-referenced case. After speaking with you by telephone yesterday, I believe it may be helpful for the following information to be made part of the public record:

1. While the Delano Fundraising Committee may not have been a committee registered with the FEC, it was definitely not connected with the United Farm Workers Union (UFW), the National UFW Political Action Committee (the UFW's non-federal committee) or the National UFW Volunteer Political Action Committee (the federal committee). The Delano Fundraising Committee, to the best of our knowledge, was simply an ad hoc group that formed for the sole purpose of organizing one fundraiser. The workers in the Delano area, solely on their own, decided to hold a large fiesta and sold food and beverages to raise the money.

These funds were not solicited by the Union nor did the Union or its PAC's contribute any amounts to the fundraiser. All funds came from individuals, in small amounts, totalling \$5,360.86.


2. In the fall of 1983, the FEC (RAD) requested information about the committee and how the contribution was reported. At the suggestion of the FEC staff person with whom we spoke, the \$5,360.86 was transferred from the UFW's federal committee to its state committee, NUFWPAC. It was intended that the transfer take place immediately. We have since learned that it took some time to be done -- according to your letter the transfer was made one month later, on October 25, 1983.



I hope this clarifies what took place. We are sure that no violation occurred and apologize for any confusion that we may have caused by our reporting. In the future we will report all monies received from fundraisers as just that, not as being received from an unregistered fundraising committee.



SUMMARY OF ALLEGATIONS

The National UFW Volunteer Political Action Committee (hereinafter "UFW-PAC") received and accepted funds from the Delano Fundraising Committee (hereinafter "the Delano Committee"), an unregistered political organization.

FACTUAL BASIS AND LEGAL ANALYSIS

According to RAD, UFW-PAC may have received and accepted prohibited funds in violation of 2 U.S.C. § 441b through a \$5,360.86 transfer-in from the Delano Committee, an unregistered political entity.

UFW-PAC's 1982 30 Day Post-General Election Report discloses that on October 6, 1982, it received a transfer-in of \$5,360.86 from the Delano Committee; this Committee is not registered with the Commission. This was the only receipt disclosed by UFW-PAC during the reporting period in question.

On August 24, 1983, RAD requested clarification from UFW-PAC concerning the receipt from the Delano Committee. On September 6, 1983, a representative of UFW-PAC responded by phone to RAD's inquiry and stated that the funds from the Delano Committee were proceeds from an event sponsored by local UFW members.

On September 28, 1983, UFW-PAC responded to RAD's request for additional information by stating that the \$5,360.86 received

from the Delano Committee had been transferred to a non-federal account. It is not clear from the letter, however, whether the funds were transferred to a non-federal account maintained by UFW-PAC or a non-federal account maintained by another entity affiliated with UFW-PAC.

The UFW-PAC's 1983 Year End Report discloses that on October 25, 1983, \$5,360.86 was transferred to the UFW National Political Action Committee to correct an error in deposit. There is no indication whether this transfer was made to a non-federal account. Moreover, the report contradicts an earlier written statement made by UFW-PAC which indicated that the \$5,360.86 had been transferred on or before September 28, 1983.

2 U.S.C. § 441b expressly prohibits the receipt and expenditure of any funds or proceeds in connection with any federal election that were solicited from corporate and/or labor entities.

Based on the above, a compliance action should be instituted since it appears that UFW-PAC and Peter G. Velasco, as treasurer of UFW-PAC, violated 2 U.S.C. § 441b by receiving and accepting funds from a source that may include funds from corporate and/or labor entities. Therefore, the Office of General Counsel recommends that reason to believe be found against the National UFW Volunteer Political Action Committee and Peter G. Velasco as treasurer of the National UFW Volunteer Political Action Committee but take no further action and close the file in this matter.

According to RAD, UFW-PAC may have received and accepted prohibited funds in violation of 2 U.S.C. § 441b through a \$5,360.86 transfer-in from the Delano Committee, an unregistered political entity.

2 U.S.C. § 441b expressly prohibits the receipt and expenditure of any funds or proceeds in connection with any federal election that were solicited from corporate and/or labor entities. Additionally, 2 U.S.C. § 433 requires that all political committees shall file a statement of organization no later than ten (10) days after establishment, and 2 U.S.C. § 434 requires each treasurer of a political committee to file certain reports of receipts and disbursements.

Based on the above, a compliance action should be instituted since it appears that the Delano Committee and its treasurer violated 2 U.S.C. §§ 433 and 434 by failing to register and file certain reports of receipts and disbursements with the Commission, and 2 U.S.C. § 441b by contributing funds to be used in a federal campaign that may have contained funds from corporate and/or labor entities. Therefore, the Office of General Counsel recommends that reason to believe be found against the Delano Committee and its treasurer but take no further action and close the file in this matter.





It appears that UFW-PAC received prohibited funds in violation of 2 U.S.C. 441b through a \$5,360.86 transfer-in from an unregistered organization.* To remedy the matter, UFW-PAC has transferred-out the full amount to its non-Federal account. According to the RAD Review and Referral Procedures (Standard 6, formerly Standard 4), further examination is required by your office.

The 1982 30 Day Post-General Election Report filed by the National UFW Volunteer PAC (aka United Farm Workers of America, AFL-CIO Federal PAC, hereafter referred to as "UFW-PAC") disclosed a \$5,360.86 receipt from the Delano Fundraising Committee on October 6, 1982 (Attachment 2a).^{*/} The Delano Fundraising Committee is not registered with the Federal Election Commission.

On August 24, 1983, a Request for Additional Information was sent to UFW-PAC requesting clarification of this receipt. The notice also included instructions concerning the proper reporting of proceeds from joint fundraisers (Attachment 3).

A UFW-PAC spokesman contacted a Reports Analysis Division ("RAD") analyst by phone on September 6, 1983 (Attachment 4). The spokesman stated that the funds from the Delano Fundraising Committee were proceeds from an event held by local UFW members. The RAD analyst explained the Act and the regulations to the spokesman and requested that a written response be submitted.

^{*/} As noted on the report, no other funds were received during the period (Attachment 2b). On October 19, 1982, UFW-PAC made a \$3,000 contribution to the Philip Burton Campaign Committee (Attachment 2c).

On September 15, 1983, a Second Notice was sent to UFW-PAC for failure to respond to the initial notice (Attachment 5). The treasurer phoned on September 16, 1983, however, the RAD analyst was not available (Attachment 6). After several attempts, the RAD analyst finally reached the treasurer on September 19, 1983. The treasurer stated that he was confused about several reporting requirements, and requested copies of the Commission's Campaign Guide for Corporations and Labor Organizations. There was no discussion of the outstanding Request for Additional Information (Attachment 7).

UFW-PAC responded on October 4, 1983, by stating that the entire amount received from the Delano Fundraising Committee had been transferred to its non-Federal account (Attachment 8).

The 1983 Year End Report discloses that the disbursement was made on October 25, 1983, and noted as a "transfer to correct error in deposit" (Attachment 9).

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Please clarify the nature of the receipt from the Delano Fund Raising Committee. If the receipt be a transfer in from an account maintained by your committee for non-Federal activity, be advised that 11 CFR 102.5(a)(1)(i) prohibits such a transfer, and the full amount must be returned to the non-Federal account.

If the receipt represents proceeds raised through joint fundraising through a collection agent, it should be properly reported as receipts from individuals are reported (itemization required for an individual whose aggregate contribution(s) exceeds \$200 in a calendar year).

As the Delano Fund Raising Committee is not registered with the Federal Election Commission, a contribution from the former may contain funds prohibited under 2 U.S.C. 441b, and must be returned. If the funds be from permissible sources, a contribution to your committee may trigger a registration and reporting obligation on the part of the donor.

Finally, as a separate segregated fund of a labor organization, your committee may only solicit those persons belonging to your "restricted class" (see 11 CFR 114.5(g)(2)), which is limited to your members and their families. If your committee has improperly solicited outside of your "restricted class", the full amount of the receipt must be refunded.

Mr. Hartmire called in response to the RFAIs. In particular, we discussed the Delano Fundraising Committee, which he said was an event held by local UFW members. I explained the following information to him:

1. By making a contribution to their committee, the Delano Fundraising Committee (DFC) had triggered a registration and reporting requirement, unless DFC acted as a collecting agent for UFW.
2. UFW had the option of refunding the money to a non-federal account, rather than refunding to the donor.
3. How a separate segregated fund differed from other political committees-no \$ threshold.
4. The event sponsored by DFC may have contained funds not permitted under the Act-commingling.
5. The event may have obtained money from beyond the permissible class of UFW.
6. How UFW should file an amended Form 1 to reflect the name of the connected organization in the committee name.

SUMMARY OF ALLEGATIONS

The National UFW Volunteer Political Action Committee (hereinafter "UFW-PAC") received and accepted funds from the Delano Fundraising Committee (hereinafter "the Delano Committee"), an unregistered political organization.

FACTUAL BASIS AND LEGAL ANALYSIS

According to RAD, UFW-PAC may have received and accepted prohibited funds in violation of 2 U.S.C. § 441b through a \$5,360.86 transfer-in from the Delano Committee, an unregistered political entity.

UFW-PAC's 1982 30 Day Post-General Election Report discloses that on October 6, 1982, it received a transfer-in of \$5,360.86 from the Delano Committee; this Committee is not registered with the Commission. This was the only receipt disclosed by UFW-PAC during the reporting period in question.

On August 24, 1983, RAD requested clarification from UFW-PAC concerning the receipt from the Delano Committee. On September 6, 1983, a representative of UFW-PAC responded by phone to RAD's inquiry and stated that the funds from the Delano Committee were proceeds from an event sponsored by local UFW members.

On September 28, 1983, UFW-PAC responded to RAD's request for additional information by stating that the \$5,360.86 received

from the Delano Committee had been transferred to a non-federal account. It is not clear from the letter, however, whether the funds were transferred to a non-federal account maintained by UFW-PAC or a non-federal account maintained by another entity affiliated with UFW-PAC.

The UFW-PAC's 1983 Year End Report discloses that on October 25, 1983, \$5,360.86 was transferred to the UFW National Political Action Committee to correct an error in deposit. There is no indication whether this transfer was made to a non-federal account. Moreover, the report contradicts an earlier written statement made by UFW-PAC which indicated that the \$5,360.86 had been transferred on or before September 28, 1983.

2 U.S.C. § 441b expressly prohibits the receipt and expenditure of any funds or proceeds in connection with any federal election that were solicited from corporate and/or labor entities.

Based on the above, a compliance action should be instituted since it appears that UFW-PAC and Peter G. Velasco, as treasurer of UFW-PAC, violated 2 U.S.C. § 441b by receiving and accepting funds from a source that may include funds from corporate and/or labor entities. Therefore, the Office of General Counsel recommends that reason to believe be found against the National UFW Volunteer Political Action Committee and Peter G. Velasco as treasurer of the National UFW Volunteer Political Action Committee.

Additionally, 2 U.S.C. § 433 requires that all political committees shall file a statement of organization no later than ten (10) days after establishment, and 2 U.S.C. § 434 requires each treasurer of a political committee to file certain reports of receipts and disbursements.

The 1982 30 Day Post-General Election Report filed by the National UFW Volunteer PAC (aka United Farm Workers of America, AFL-CIO Federal PAC, hereafter referred to as "UFW-PAC") disclosed a \$5,360.86 receipt from the Delano Fundraising Committee on October 6, 1982 (Attachment 2a).^{*/} The Delano Fundraising Committee is not registered with the Federal Election Commission.

On August 24, 1983, a Request for Additional Information was sent to UFW-PAC requesting clarification of this receipt. The notice also included instructions concerning the proper reporting of proceeds from joint fundraisers (Attachment 3).

A UFW-PAC spokesman contacted a Reports Analysis Division ("RAD") analyst by phone on September 6, 1983 (Attachment 4). The spokesman stated that the funds from the Delano Fundraising Committee were proceeds from an event held by local UFW members. The RAD analyst explained the Act and the regulations to the spokesman and requested that a written response be submitted.

^{*/} As noted on the report, no other funds were received during the period (Attachment 2b). On October 19, 1982, UFW-PAC made a \$3,000 contribution to the Philip Burton Campaign Committee (Attachment 2c).

On September 15, 1983, a Second Notice was sent to UFW-PAC for failure to respond to the initial notice (Attachment 5). The treasurer phoned on September 16, 1983, however, the RAD analyst was not available (Attachment 6). After several attempts, the RAD analyst finally reached the treasurer on September 19, 1983. The treasurer stated that he was confused about several reporting requirements, and requested copies of the Commission's Campaign Guide for Corporations and Labor Organizations. There was no discussion of the outstanding Request for Additional Information (Attachment 7).

UFW-PAC responded on October 4, 1983, by stating that the entire amount received from the Delano Fundraising Committee had been transferred to its non-Federal account (Attachment 8).

The 1983 Year End Report discloses that the disbursement was made on October 25, 1983, and noted as a "transfer to correct error in deposit" (Attachment 9).

If the receipt be a transfer in from an account maintained by your committee for non-Federal activity, be advised that 11 CFR 102.5(a)(1)(i) prohibits such a transfer, and the full amount must be returned to the non-Federal account.

If the receipt represents proceeds raised through joint fundraising through a collection agent, it should be properly reported as receipts from individuals are reported (itemization required for an individual whose aggregate contribution(s) exceeds \$200 in a calendar year).


As the Delano Fund Raising Committee is not registered with the Federal Election Commission, a contribution from the former may contain funds prohibited under 2 U.S.C. 441b, and must be returned. If the funds be from permissible sources, a contribution to your committee may trigger a registration and reporting obligation on the part of the donor.

Finally, as a separate segregated fund of a labor organization, your committee may only solicit those persons belonging to your "restricted class" (see 11 CFR 114.5(g)(2)), which is limited to your members and their families. 1. By making a contribution to their committee, the Delano Fundraising Committee (DFC) had triggered a registration and reporting requirement, unless DFC acted as a collecting agent for UFW.
 2. UFW had the option of refunding the money to a non-federal account, rather than refunding to the donor.
 3. How a separate segregated fund differed from other political committees-no \$ threshold.
 4. The event sponsored by DFC may have contained funds not permitted under the Act-commingling.
 5. The event may have obtained money from beyond the permissible class of UFW.
 6. How UFW should file an amended Form 1 to reflect the name of the connected organization in the committee name.

Statement of the Case

On March 16, 1984, the Reports Analysis Division (hereinafter "RAD") referred the above-referenced matter to this Office for review.

According to RAD, the National UFW Voluntary Political Action Committee (hereinafter "UFW-PAC") received and accepted a \$5,360.86 transfer-in from the Delano Fundraising Committee, an unregistered political organization.

Based on the above it appears that the UFW-PAC may have violated 2 U.S.C. § 441b(a) by receiving and accepting funds from a source that may have solicited contributions from corporate and/or labor entities.

Statement of Preliminary Discovery Plan

In order to establish that a violation of 2 U.S.C. § 441b(a) has occurred, it must first be determined that UFW-PAC received and accepted for its federal account a transfer-in from a non-registered political entity, and that the funds were tainted with prohibited contributions. We believe, however, that RAD has

provided sufficient evidence to proceed to a reason to believe finding in this matter.

Additionally, interrogatories will be designed to determine the relationship of the two committees. It is possible that the Delano Fundraising Committee is an ad hoc committee established by the UFW-PAC for the sole purpose of organizing events to finance the UFW-PAC.

The 1982 30 Day Post-General Election Report filed by the National UFW Volunteer PAC (aka United Farm Workers of America, AFL-CIO Federal PAC, hereafter referred to as "UFW-PAC") disclosed a \$5,360.86 receipt from the Delano Fundraising Committee on October 6, 1982 (Attachment 2a).^{*/} The Delano Fundraising Committee is not registered with the Federal Election Commission.

On August 24, 1983, a Request for Additional Information was sent to UFW-PAC requesting clarification of this receipt. The notice also included instructions concerning the proper reporting of proceeds from joint fundraisers (Attachment 3).

A UFW-PAC spokesman contacted a Reports Analysis Division ("RAD") analyst by phone on September 6, 1983 (Attachment 4). The spokesman stated that the funds from the Delano Fundraising Committee were proceeds from an event held by local UFW members. The RAD analyst explained the Act and the regulations to the spokesman and requested that a written response be submitted.

^{*/} As noted on the report, no other funds were received during the period (Attachment 2b). On October 19, 1982, UFW-PAC made a \$3,000 contribution to the Philip Burton Campaign Committee (Attachment 2c).

On September 15, 1983, a Second Notice was sent to UFW-PAC for failure to respond to the initial notice (Attachment 5). The treasurer phoned on September 16, 1983, however, the RAD analyst was not available (Attachment 6). After several attempts, the RAD analyst finally reached the treasurer on September 19, 1983. The treasurer stated that he was confused about several reporting requirements, and requested copies of the Commission's Campaign Guide for Corporations and Labor Organizations. There was no discussion of the outstanding Request for Additional Information (Attachment 7).

UFW-PAC responded on October 4, 1983, by stating that the entire amount received from the Delano Fundraising Committee had been transferred to its non-Federal account (Attachment 8).

The 1983 Year End Report discloses that the disbursement was made on October 25, 1983, and noted as a "transfer to correct error in deposit" (Attachment 9).

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Please clarify the nature of the receipt from the Delano Fund Raising Committee. If the receipt be a transfer in from an account maintained by your committee for non-Federal activity, be advised that 11 CFR 102.5(a)(1)(i) prohibits such a transfer, and the full amount must be returned to the non-Federal account.

If the receipt represents proceeds raised through joint fundraising through a collection agent, it should be properly reported as receipts from individuals are reported (itemization required for an individual whose aggregate contribution(s) exceeds \$200 in a calendar year).

As the Delano Fund Raising Committee is not registered with the Federal Election Commission, a contribution from the former may contain funds prohibited under 2 U.S.C. 441b, and must be returned. If the funds be from permissible sources, a contribution to your committee may trigger a registration and reporting obligation on the part of the donor.

Finally, as a separate segregated fund of a labor organization, your committee may only solicit those persons belonging to your "restricted class" (see 11 CFR 114.5(g)(2)), which is limited to your members and their families. If your committee has improperly solicited outside of your "restricted class", the full amount of the receipt must be refunded.

Mr. Hartmire called in response to the RFAIs. In particular, we discussed the Delano Fundraising Committee, which he said was an event held by local UFW members. I explained the following information to him:

1. By making a contribution to their committee, the Delano Fundraising Committee (DFC) had triggered a registration and reporting requirement, unless DFC acted as a collecting agent for UFW.
2. UFW had the option of refunding the money to a non-federal account, rather than refunding to the donor.
3. How a separate segregated fund differed from other political committees-no \$ threshold.
4. The event sponsored by DFC may have contained funds not permitted under the Act-commingling.
5. The event may have obtained money from beyond the permissible class of UFW.
6. How UFW should file an amended Form 1 to reflect the name of the connected organization in the committee name.

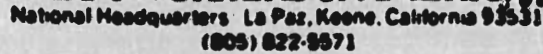
