Each committee which failed to submit either a 12 Day Pre-General Report or a November Monthly Report was sent a Non-Filer Notice on November 14, 1986 (Attachment 36). The following six (6) committees were not sent Non-Filer Notices because a report covering the pre-election period was indexed by November 14, 1986:

referenced committees failed to file the 1986 Pre-General Election Report by the required deadline. Therefore, though the Commission is in receipt of report(s) disclosing financial activity covering the pre-general election period, such report(s) were not filed in a timely manner.

With regard to thirty-two non-filers listed below, the Office of General Counsel recommends that the Commission open MURs and find reason to believe these committees and their treasurers violated 2 U.S.C. § 434(a)(4)(B).



Dear Mr. Wachino:

On May 21, 1987, the Federal Election Commission determined there is reason to believe Grunman Political Action Committee and you, as treasurer, violated 2 U.S.C. § 434(a)(4)(B), a provision of the Federal Election Campaign Act of 1971, as amended ("the Act"). The factual and legal analysis, which formed a basis for the Commission's finding, is attached for your information.

Under the Act, you have an opportunity to demonstrate that no action should be taken against you and the committee. You may submit any factual or legal materials which you believe are relevant to the Commission's consideration of this matter. Please submit any such materials within fifteen days of your receipt of this letter.

In the absence of any additional information which demonstrates that no further action should be taken against you, the Commission may find probable cause to believe that a violation has occurred and proceed with conciliation.

If you are interested in pursuing pre-probable cause conciliation, you should so request in writing. See 11 C.F.R. § 111.18(d). Upon receipt of the request, the Office of General Counsel will make recommendations to the Commission either proposing an agreement in settlement of the matter or

recommending declining that pre-probable cause conciliation be pursued. The Office of General Counsel may recommend that pre-probable cause conciliation not be entered into at this time so that it may complete its investigation of the matter. Further, requests for pre-probable cause conciliation will not be entertained after briefs on probable cause have been mailed to the respondent.

Requests for extensions of time will not be routinely granted. Requests must be made in writing at least five days prior to the due date of the response and specific good cause must be demonstrated. In addition, the Office of General Counsel is not authorized to give extensions beyond 20 days.

If you intend to be represented by counsel in this matter, please advise the Commission by completing the enclosed form stating the name, address and telephone number of such counsel, and a statement authorizing such counsel to receive any notifications and other communications from the Commission.

The investigation now being conducted will be confidential in accordance with 2 U.S.C. §§ 437g(a)(4)(B) and 437g(a)(12)(A), unless you notify the Commission in writing that you wish the investigation to be made public.

For your information, we have attached a brief description of the Commission's procedures for handling possible violations of the Act. If you have any questions, please contact Phillip Wise, the attorney assigned to this matter, at (202) 376-8200.

Gentlemen:

The Commission, in the above-captioned letter received by the Grumman Political Action Committee on June 15, 1987, indicated that it had determined "reason to believe Grumman Political Action Committee and [William Wachino, Jr.], as Treasurer violated 2USC §434 (a)(4)(B)...."

I have been asked to represent the Grumman Political Action Committee and Mr. Wachino in this matter, and the completed Statement of Designation of Counsel form is enclosed.

I have conducted a review of the facts and circumstances involved in the matter described in the Factual and Legal Analysis enclosed with the above letter. In such review I examined such documents or copies of documents and interviewed such personnel, as I deemed relevant and appropriate to form the basis for the following explanation, which it is respectfully submitted should demonstrate that no further action need be taken by the Commission in this matter.

I.

The Grumman Political Action Committee ("PAC") is a "separate segregated fund" under the Federal Election Campaign Act of 1971, as amended (the "Act"). The PAC files reports on a monthly basis and to the best of our information has filed on a timely basis, with the exception of the aberration referred to in connection with the Pre-General Election Report due October 23, 1986.

II.

The PAC receives contributions from participating eligible employees through payroll withholdings from salary checks, as well as by direct one-time contributions. Since 1985, Grumman's manufacturing and marketing activities have been conducted through operating "divisions" that in most, but not all, cases are distinct corporate subsidiaries. Prior to the conversion to operating "divisions," the corporate subsidiaries were the operating entities, with separate payrolls and checking accounts. PAC participants'

salary withholdings were paid to the PAC by check on a regular periodic basis by each subsidiary other than those with employees represented by collective bargaining units.

III.

During 1984, before divisionalization had been implemented and payrolls were rearranged, the PAC accounting system was placed on a fully computerized basis. Assistants to Mr. Wachino worked with a systems analyst-programmer from Grumman Data Systems Corporation to design and implement a computerized system to audit the raw data on contribution amounts and accumulate information. This system was designed to produce all reports on a timely basis. The system worked flawlessly from mid-1984 through the date on which the 1986 Pre-General Election Report should have been delivered to Mr. Wachino for signature and submission to the Commission. When Mr. Wachino's staff (the person to whom the responsibility for monitoring the flow of PAC reports was on her honeymoon during the mid-October 1986 period) realized the 12-day Pre-Election Report report was late, calls were made to the computer center where the data were accumulated. At that point, an additional pay cycle had passed, and the system had a cumulative figure exceeding the figure for the fifteen day period October 1-15. Those persons interviewed have indicated that additional delay was encountered in re-tracking the system to the previous pay cycle in order to assure that the report would cover the period October 1-15 as literally required by the Form. Under the series of instructions directed to the system during this period, the receipts information required by section 11(a) was not forthcoming until a day or two before the November 6, 1986 mailing of the 1986 Pre-Election Report for the period October 1-15. Because of this series of miscues and a literal reading of the reporting period requirement by his staff, Mr. Wachino was unable to sign the Certification on the Summary Page of the report that "to the best of [his] knowledge and belief [the Report] is true and complete" until the supporting schedule for line 11(a) was produced and printed by the system.

It is respectfully submitted that the late filing of the 1986 Pre-General Election Report was not the result of a willful or negligent disregard of the filing time requirements of the Act, but was the result of problems encountered with the system instituted in a good faith attempt to comply with those requirements. The problem of cueing the system to produce special reports such as the Pre-Election Report has been corrected, and steps have been taken to assure that more than one member of Mr. Wachino's staff will be monitoring the preparation of the reports to the Commission at all times in the future. No similar difficulties are anticipated





CONCILIATION AGREEMENT

This matter was initiated by the Federal Election Commission ("the Commission"), pursuant to information ascertained in the normal course of carrying out its supervisory responsibilities. The Commission found reason to believe that the Grumman Political Action Committee and William Wachino, Jr., as treasurer, ("Respondents") violated 2 U.S.C. § 434(a)(4)(B).

NOW, THEREFORE, the Commission and the Respondents, having participated in informal methods of conciliation, prior to a finding of probable cause to believe, do hereby agree as follows:

I. The Commission has jurisdiction over the Respondents and the subject matter of this proceeding, and this agreement has the effect of an agreement entered pursuant to 2 U.S.C. § 437g(a)(4)(A)(i).

II. Respondents have had a reasonable opportunity to demonstrate that no action should be taken in this matter.

III. Respondents enter voluntarily into this agreement with the Commission.

IV. The pertinent facts in this matter are as follows:

1. Respondent, Grumman Political Action Committee, is a political committee within the meaning of 2 U.S.C. § 431(4).

2. Respondent, William Wachino, Jr., is the treasurer of Grumman Political Action Committee.

3. Respondents were required to file their 1986 12 Day Pre-General Election Report by October 23, 1986. This report was filed on November 12, 1986, 19 days late.

V. Respondents failed to file their 1986 12 Day Pre-General Election Report in a timely manner in violation of 2 U.S.C. § 434(a)(4)(B).

VI. Respondents will pay a civil penalty to the Federal Election Commission in the amount of Six Hundred Twenty-Five dollars (\$625.00), pursuant to 2 U.S.C. § 437g(a)(5)(A).

VII. The Commission, on request of anyone filing a complaint under 2 U.S.C. § 437g(a)(1) concerning the matters at issue herein or on its own motion, may review compliance with this agreement. If the Commission believes that this agreement or any requirement thereof has been violated, it may institute a civil action for relief in the United States District Court for the District of Columbia.

VIII. This agreement shall become effective as of the date that all parties hereto have executed same and the Commission has approved the entire agreement.

IX. Respondents shall have no more than thirty (30) days from the date this agreement becomes effective to comply with and implement the requirements contained in this agreement and to so notify the Commission.


X. This Conciliation Agreement constitutes the entire agreement between the parties on the matters raised herein, and


no other statement, promise, or agreement, either written or oral, made by either party or by agents of either party, that is not contained in this written agreement shall be enforceable.
