GENERAL COUNSEL'S REPORT

I. Allegation

John H. Glover as a candidate for the U.S. Senate in Minnesota has; 1) failed to file the 10 day pre-election reports required by 2 U.S.C §434(a)(1) and 2) failed to designate a principal campaign committee required by 2 U.S.C. §432(e)(1).

II. Evidence

Mr. Glover's name appeared on the Minnesota primary election ballot September 14, 1976, as a candidate for the U.S. Senate. His name appears on the index from the Secretary of Senate.

The candidate received a prior notice August 7, 1976, informing him of the filing obligations of a federal candidate. Failing to file the ten day pre-election report due September 4, 1976, the candidate was sent a

reason to believe letter for non-filers from the Commission. The letter was sent September 8, 1976 and refused by the candidate. Having not received any response from the candidate, the Commission sent him a reasonable cause to believe letter for non-filers September 10, 1976. This letter was also refused.

The candidate failed to designate a principal campaign committee and received a special notice August 13, 1976. The Commission did not receive any response from the special notice and sent a reason to believe letter for no principal campaign committee to Mr. Glover. The reason to believe letter for no principal campaign committee was received by the candidate September 4, 1976.

The candidate lost the primary election receiving 13,014 votes in comparison to the winning candidate receiving 76,183 votes. Mr. Glover's name was published on the non-filers list September 23, 1976.

A follow up letter has been sent to Mr. Glover from the General Counsel informing him of his name publication and the General Counsel's intention to recommend to the Commission that appropriate civil penalties be sought. On September 27, 1976, Mr. Glover filed a termination report with the Secretary of the Senate. This is the only report he has filed and shows no contributions or expenditures.


III. Analysis

The candidate has failed to file the ten day pre-election report due September 4, 1976. The Commission contacted the candidate informing him of his filing requirements.

The candidate did not respond adequately to these efforts to correct or prevent a violation. The Commission has attempted through various communications to conciliate the case; but the candidate has not used his statutory right to implement informal methods of conference, conciliation, and persuasion.

IV. Recommendation

It is recommended that the Commission find probable cause to believe a violation has been committed of 2 U.S.C. §434(a)(1) and §433(e)(1).

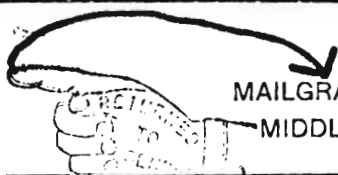


Dear Mr. Glover:

FEC PUBLISHES LIST OF "NON-FILERS"

WASHINGTON - September 23 - The FEC today published the names of House and Senate candidates and their "principal campaign committees" which failed to file the required "ten-day pre-election report" of their campaign finances in the August 3 and the September 14 primaries.

In these primaries, the following candidates and/or their "principal campaign committees" failed to file "ten-day pre-election reports":

Starting September 1, 1976, the Commission began publishing "non-filers" for primary elections.

The Federal Election Campaign Act of 1971, as amended in 1974 and 1976, states that "It shall be the duty of the Commission to ... prepare and publish from time to time official reports listing those candidates ... for whom reports were not filed as so required."

Federal candidates and committees must file a "pre-election" report 10 days before

long each election, covering their financial transactions up to 15 days before the election. Under FCC procedures, these notices are sent to the candidates and committees, reminding them of their reporting obligations, and the filing dates. If a report is not filed following these notices, the names of all "non filers" are made public.

"Prior notice" is the first reminder, sent on a routine basis 21 days before the primary date, to all candidates whose names are on the ballot in their respective states, as certified by their Secretary of State, and confirmed by lists with the Clerk of the House and the Secretary of the Senate. This notice simply reminds candidates and committees of their required 10-day pre-election, and 30-day post election reports, and the appropriate filing dates.

The second notice is sent, by mailgram, only to candidates and committees whose reports have not been received 8 days before the primary, and states that this "apparent failure...gives the Commission "reason to believe" that the candidate or committee is in violation of the reporting requirements.

The third notice is sent, by mailgram, only to candidates and committees whose reports are not filed 6 days before the primary, and states that "continued failure to file has given the Commission "reasonable cause to believe" that they are in violation, and that "failure to respond may subject the candidate or committee to...publication of the candidate's or committee's name on a list of non-filers."

When a candidate or committee continues to fail to file after receiving the "prior notice" reminder, and the "reason to believe" and reasonable cause to believe" notices, the Commission publishes the names of the candidates and/or his committee on a list of non-filers.

In addition to these "expedited" procedures for 10-day pre-election reports, the Commission will notify candidates and/or their committees on a routine basis with regard to monthly, quarterly, and post-primary reports.
