DESCRIPTION OF EXHIBITS

EXHIBIT A

This is an Excel spreadsheet detailing a list of all persons employed by MDS Communications Corp. in the pay period of November 10, 1994, the only pay period in which there was any call activity for National Right to Life or its subsidiaries. This information was gathered from multiple sources, including obsolete databases and personnel records. This is in hard copy and on disk.

EXHIBIT B

These are the contracts and addenda in force for the time period in question. They include separate contracts and addenda for donor and prospect programs. These contracts don't explicitly cover Get-Out-The-Vote programs, but we ran these programs with verbal understandings with our client. This is in hard copy and on disk.

EXHIBIT C

This contains all existing copies of the call dialer printouts for the three Get-Out-The-Vote programs conducted for National Right to Life Political Action Committee for the time frame in question. The front two pages are copies of the reports sent to the client on Monday November 7, 1994 and Tuesday November 8, 1994. These printouts and reports no longer exist on computer.

EXHIBIT D

This contains the invoices that MDS Communications Corp. prepared and sent to the National Right to Life Political Action Committee requesting payment for services rendered for the three Get-Out-The-Vote programs conducted in November 1994. This is in hard copy and on disk.

NOTE:

Despite extensive searches through files, disks, and computer hard drives, we have been unable to find any copies of the scripts used for these campaigns, or any copies of checks sent to MDS as payment for the invoices detailed. The records being sent are the sum total of all data we have been able to find relating to these campaigns.

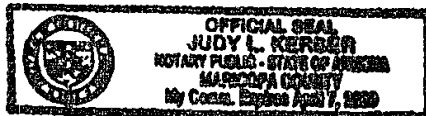
