I write to notify you of my formal complaint against Mr. Lee A. Solomon, the Solomon for Congress Committee (FEC # C00266890), and Mr. John A. Bruno, Jr., for failure to comply with the established deadlines for the following reports: April 15, 1992 Quarterly Report (Filed at FEC on April 30, 1992); October 15, 1992 Quarterly Report (Filed at FEC on October 19, 1992); and the Twelfth Day Report preceding the 1992 General Election (Filed at FEC on January 8, 1993). These violations were brought to my attention after speaking with representatives from the FEC's Public Records Department.

More importantly, Mr. Solomon, Mr. Bruno, and the Solomon for Congress Committee failed to provide the Federal Election Commission the 1992 Post-General Report, the January 31, 1993 Year-End Report, and the July 31, 1993 Mid-Year Report. It is also my understanding that Mr. Solomon hosted a debt retirement fundraiser this Spring, but obviously failed to report the names of his contributors, if there were any at all.

I respectfully request that the Commission review this complaint accordingly so as to determine the proper punishment for this blatant disrespect for the law.

Dear Mr. Kenny:

This is to acknowledge receipt on October 15, 1993, of your letter dated October 11, 1993. The Federal Election Campaign Act of 1971, as amended ("the Act") and Commission Regulations require that the contents of a complaint meet certain specific requirements. One of these requirements is that a complaint be sworn to and signed in the presence of a notary public and notarized. Your letter did not contain a notarization on your signature and was not properly sworn to.

In order to file a legally sufficient complaint, you must swear before a notary that the contents of your complaint are true to the best of your knowledge and the notary must represent as part of the jurat that such swearing occurred. The preferred form is "Subscribed and sworn to before me on this _____ day of _____, 19__." A statement by the notary that the complaint was sworn to and subscribed before him/her also will be sufficient. We are sorry for the inconvenience that these requirements may cause you, but we are not statutorily empowered to proceed with the handling of a compliance action unless all the statutory requirements are fulfilled. See 2 U.S.C. § 437g.

Enclosed is a Commission brochure entitled "Filing a Complaint." I hope this material will be helpful to you should you wish to file a legally sufficient complaint with the Commission.





In response to the complaint of David W.M. Kenny, I have been advised by Mr. Solomon that the 1992 post general report and January 31, 1993, year end report were forwarded for filing on October 21, 1993; copies are enclosed for your records.

Because no transactions occurred after March 30, 1993, and the account has been closed, the final and mid-year reports are due. Those reports will be identical. Unfortunately, we are attempting to obtain documentation from the bank to finalize those reports and they will be forwarded to you upon receipt of that documentation.

Finally, it was my understanding and belief that all reports and documentation were in the possession of and filed by the campaign manager when they were due. The candidate and I were not aware that the reports had not been filed timely until a copy of Mr. Kenny's complaint was received. Unfortunately, the campaign manager has been unable to locate the reports or supporting documentation, or to confirm whether they were filed or lost. Finally, total receipts and disbursements from the account for the period beginning January 1, 1993, and ending March 31, 1993, were \$6,543.63.

Enclosed with this cover letter please find Federal Election Commission reports filed on behalf of the *Solomon for Congress Committee*. These reports cover the period 10-1-92 to 10-25-93, the date that said account was closed. Several of these reports are amendments to previously filed reports. Please disregard all prior reports and retain the enclosed for your files.

Based on a letter dated November 5, 1993 from Mary L. Taksar, of the Central Enforcement Docket (enclosed), it was brought to our attention that several reports as required by the Federal Election Campaign Act of 1971 were not properly filed with your office. Two of these missing reports, specifically the thirtieth-day report following the General Election of November 3, 1992 and the subsequent year-end report for 1992, were filed with the Clerk of the House of Representatives on or before October 27, 1993.

A subsequent letter from Mr. Todd Schumacher, Reports Analyst (enclosed), indicated that an error may have occurred in either the thirtieth-day report or the year-end report. A careful accounting of the above-mentioned reports indicated that the error actually appeared in the previously filed twelfth-day report preceeding the November 3, 1992 General Election which covered the period 10-1-92 to 10-15-92. It appears that improper date parameters were used on our campaign management software to produce the twelfth-day report, which caused these errors.

As a result of the above-mentioned correspondence from Ms. Taksar and Mr. Schumacher I conducted an extensive review of the *Solomon for Congress Committee*. Based on my findings I have enclosed the following items in this package:

ITEM 1: An amended twelfth-day report preceeding the General Election of November 3, 1992 covering the period from 10-1-92 to 10-15-92.

ITEM 4: A mid-year report covering the period 1-1-93 to 6-30-93 which, according to Ms. Tasker's correspondence, was never properly filed with the Clerk of the House of Representatives.

ITEM 5: A year-end report covering the period 7-1-93 to 10-25-93 which will indicate that there has been no activity conducted by or on behalf of the *Solomon for Congress Committee* over the past four (4) months. This report is a Termination Report, which will also indicate that all business with regard to the *Solomon for Congress Committee* has been concluded and that said account was properly closed on 10-25-93.

Mr. Schumacher's letter of November 26, 1993 also indicated that the *Solomon for Congress Committee* may have failed to file the required 48 hour notices regarding "last minute" contributions. A check of our records does not indicate whether, in fact, these reports were properly filed. A review of contributions to the *Solomon for Congress Committee* indicates that only three (3) contributions should have been reported under the 48 hour requirement. GENERAL COUNSEL'S MONTHLY REPORT

I. INTRODUCTION

This report is the General Counsel's Monthly Report to recommend that the Commission no longer pursue the identified lower priority and stale cases under the Enforcement Priority System.

II. CASES RECOMMENDED FOR CLOSING

A. Cases Not Warranting Further Pursuit Relative to Other Cases Pending Before the Commission

A critical component of the Priority System is identifying those pending cases that do not warrant the further expenditure of resources. Each incoming matter is evaluated using Commission-approved criteria and cases that, based on their rating, do not warrant pursuit relative to other pending cases are placed in this category. By closing such cases, the Commission is able to use its limited resources to focus on more important cases.

Having evaluated incoming matters, this Office has identified 22 cases which do not warrant further pursuit relative to the other pending cases.¹ A short description of

each case and the factors leading to assignment of a relatively low priority and consequent recommendation not to pursue each case is attached to this report. See Attachments 1-22. For the Commission's convenience, the responses to the complaints for the externally-generated matters and the referral for the internally-generated matter are available in the Commission Secretary's office.

B. Stale Cases

Investigations are severely impeded and require relatively more resources when the activity and evidence are old. Consequently, the Office of General Counsel recommends that the Commission focus its efforts on cases involving more recent activity. Such efforts will also generate more impact on the current electoral process and are a more efficient allocation of our limited resources. To this end, this Office has identified 9 cases that have remained inactive and assigned to the Central Enforcement Docket for one year and which it believes do not warrant further investment of significant Commission resources.² Since the recommendation not to pursue the identified cases is based on staleness, this Office has not prepared separate narratives for these cases. However, for the Commission's convenience, the responses to the complaints for the externally-generated matters and the referrals for the internally-generated matters are also available in the


