**COMPLAINT OF CENTER FOR RESPONSIVE POLITICS**

1. This complaint charges that the respondent has violated the Federal Election Campaign Act, 2 U.S.C. § 431 et seq., as amended ("FECA"), by making aggregate contributions in excess of the limits permitted by the FECA.

**PARTIES**

2. The complainant, the Center for Responsive Politics, is a nonprofit, nonpartisan research group incorporated in the State of Iowa and headquartered in Washington, D.C., that studies Congress and related issues. Founded in 1983, it was designed to research matters concerning the organization and operation of Congress as an institution and to examine potential reforms that could improve both its internal operation and its responsiveness to the American public. The patterns of contributions of money to federal candidates has been one of its chief areas of study.

3. The respondent is an individual contributor to various candidates and political committees.

### APPLICABLE STATUTES AND REGULATIONS

4. The FECA limits contributions by any one individual to an aggregate total of \$25,000 per calendar year. Contributions to a candidate or the candidate's authorized committee made in a year other than the calendar year of the election with respect to which the contribution is made are considered to be made during the calendar year in which such election is held. 2 U.S.C. § 441a(a)(3); 11 C.F.R. § 110.5.

### GROUND FOR COMPLAINT


5. According to FEC records, respondent John K. Funk made contributions subject to FECA in the amounts and to the persons identified in the list attached to this complaint as Exhibit 1. Attached as Exhibit 2 are copies of the FEC records for each contribution listed in Exhibit 1. All exhibits reflect the records on file at the FEC as of December 15, 1993.

6. On information and belief, respondent John K. Funk made contributions attributed to the 1992 calendar year in the amount of \$34,860. These contributions exceeded by \$9,860 the \$25,000 contribution limit imposed by the FECA and Commission regulations on all contributions by any individual in a calendar year.

### RELIEF

7. The Center for Responsive Politics respectfully urges the Commission to conduct a prompt and thorough investigation into the allegations in this Complaint, and to declare that the Respondent has violated the FECA and Commission regulations.



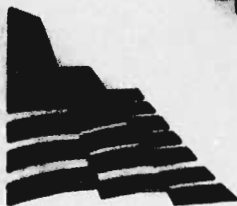

GENERAL COUNSEL'S MONTHLY REPORT

I. INTRODUCTION

This report is the second Enforcement Priority System Monthly Report. The purpose of this September Monthly Report is to recommend that the Commission no longer pursue the identified lower priority and stale cases.

II. CASES RECOMMENDED FOR CLOSING

A. Cases Not Warranting Further Pursuit Relative to Other Cases Pending Before the Commission

A critical component of the Priority System is identifying those pending cases that do not warrant the further expenditure of resources. Each incoming matter is evaluated using Commission-approved criteria and cases that, based on their rating, do not warrant pursuit relative to other pending cases are placed in this category. By closing such cases, the Commission is able to use its limited resources to focus on more important cases.

Having evaluated incoming matters, this Office has identified 44 cases which do not warrant further pursuit

relative to the other pending cases.<sup>1</sup> A short description of each case and the factors leading to assignment of a relatively low priority and consequent recommendation not to pursue each case is attached to this report. See Attachments 1-44. For the Commission's convenience, the narratives for the externally-generated matters are immediately followed by the complaint and response(s) and the narrative for the internally-generated matter is immediately followed by the referral.

#### B. Stale Cases

Investigations are severely impeded and require relatively more resources when the activity and evidence are old. Consequently, the Office of General Counsel recommends that the Commission focus its efforts on cases involving more recent activity. Such efforts will also generate more impact on the current electoral process and are a more efficient allocation of our limited resources. To this end, this Office has identified 2 cases that have remained inactive and assigned to the Central Enforcement Docket for one year and which it believes do not warrant further investment of significant Commission resources.<sup>2</sup> Since the recommendation not to pursue the identified cases is

The Center for Responsive Politics filed a complaint alleging that John Funk exceeded his 1992 \$25,000 annual contribution limit by \$9,860 because the contributions which he made during 1992 totaled \$34,860. The contributions identified in the complaint raised the issue of whether some of the recipient committees, the Bush-Quayle '92 Primary Committee, the John McCain Re-Election Committee, and the Dornan for Congress Committee, accepted contributions which exceeded FECA limits.

In response to the complaint, Mr. Funk states that due to inadvertence, he exceeded his \$25,000 annual limit for 1992. Mr. Funk also states that he has taken steps to maintain adequate records which will prevent reoccurrence in the future.

The Bush-Quayle '92 Primary Committee responds that Mr. Funk made a \$400 contribution to the Committee on December 20, 1991, a \$500 contribution on February 26, 1992 and a \$600 contribution on November 16, 1992. The Committee states that on December 18, 1992, the Committee received Mr. Funk's written authorization to redesignate \$500 from his November 16, 1992, contribution to the Compliance Committee. The Committee states that it therefore did not accept excessive contributions from Mr. Funk. In response to the complaint, the John McCain Re-Election Committee states that Mr. Funk made a \$400 contribution to the Committee on May 15, 1991, a \$600 contribution on July 5, 1991, and a \$400 contribution on January 2, 1992 for the primary election. The Committee indicates that on April 15, 1992, it refunded \$400 to Mr. Funk. The Dornan for Congress Committee states in its response that it reviewed the complaint and the contributions made to the Committee by Mr. Funk in 1991 and 1992 and concludes that the contributions are in compliance with FECA.

This matter involves less significant issues relative to other matters pending before the Commission and a limited amount of money.
