COMPLAINT OF CENTER FOR RESPONSIVE POLITICS

1. This complaint charges that the respondent has violated the Federal Election Campaign Act, 2 U.S.C. § 431 et seq., as amended ("FECA"), by making aggregate contributions in excess of the limits permitted by the FECA.

PARTIES

2. The complainant, the Center for Responsive Politics, is a nonprofit, nonpartisan research group incorporated in the State of Iowa and headquartered in Washington, D.C., that studies Congress and related issues. Founded in 1983, it was designed to research matters concerning the organization and operation of Congress as an institution and to examine potential reforms that could improve both its internal operation and its responsiveness to the American public. The patterns of contributions of money to federal candidates has been one of its chief areas of study.

3. The respondent is an individual contributor to various candidates and political committees.

APPLICABLE STATUTES AND REGULATIONS

4. The FECA limits contributions by any one individual to an aggregate total of \$25,000 per calendar year. Contributions to a candidate or the candidate's authorized committee made in a year other than the calendar year of the election with respect to which the contribution is made are considered to be made during the calendar year in which such election is held. 2 U.S.C. § 441a(a)(3); 11 C.F.R. § 110.5.

GROUND FOR COMPLAINT

5. According to FEC records, respondent Don Henley made contributions subject to FECA in the amounts and to the persons identified in the list attached to this complaint as Exhibit 1. Attached as Exhibit 2 are copies of the FEC records for each contribution listed in Exhibit 1. All exhibits reflect the records on file at the FEC as of December 15, 1993.

6. On information and belief, respondent Don Henley made contributions attributed to the 1992 calendar year in the amount of \$42,850. These contributions exceeded by \$17,850 the \$25,000 contribution limit imposed by the FECA and Commission regulations on all contributions by any individual in a calendar year.

RELIEF

7. The Center for Responsive Politics respectfully urges the Commission to conduct a prompt and thorough investigation into the allegations in this Complaint, and to declare that the Respondent has violated the FECA and Commission regulations.

I am writing in response to your letter dated February 15, concerning MUR 3875. We just received your letter, apparently because it was sent to an old address. Please note our current address on this letterhead.

Your letter offers us the opportunity to demonstrate "that no action should be taken against our committee." I am pleased to do so.

Our committee appears six times on page 2 of Exhibit 1 of the summary of FEC Data relating to contributions by Don Henley. Here is our accounting of those six entries; I will refer to them in chronological order:

1. \$-1000 7/16/91 92SEN/004/4134. This was not a contribution at all, of course, as noted by the minus sign. This was a refund made by the Lonsdale for Senate Committee (1990) to Mr. Henley for a contribution he made to the "Lonsdale for Senate" (1990) campaign, as noted on p.2, Schedule B, Itemized Disbursements, Lonsdale for Senate Committee.
2. \$1000 11/5/91 91SEN/010/3395. This was a totally valid \$1000 contribution by Mr Henley to the Lonsdale for Senate '92 primary campaign.
3. \$1000 5/19/92 92 SEN/016/2305.

and 4. \$1000 5/19/92 92SEN/016/2316.
In fact, only one of these two was an actual contribution by Mr. Henley to the Lonsdale for Senate '92 campaign. We believe that a double entry has been made in error (by the complainant?) because of a mis-

reading of the information on p. 17 of Schedule A for that reporting period.

There are 3 entries on p. 17, two of them within the box labeled "A". The first is the \$1000 contribution to the primary campaign, first noted on p. 6 (see 3. above). The second entry in that box ("5/27/92 (1000.00 Memo") is a deletion of that \$1000. The reason the 5/19 date appears in that box is to note which \$1000 contribution is being deleted. And the third entry on page 17, in the box labeled "B", is a Redesignation of that \$1000 to the Recount Committee (see 5. and 6. below).

5. \$1000 5/27/92 92SEN/016/2316

and 6. \$-1000 5/27/92 92SEN/016/2316

As noted in 4. above, No. 5 was a contribution to the Recount Committee. The '92 Senate Primary election in Oregon was exceedingly close and a recount was mandated by Oregon election law. Mr. Henley's \$1000 contribution, originally intended for the '92 General election was made, instead, to the Recount Committee, which is entirely within FEC regulations.

And No. 6, "\$-1000 5/27/92", is simply a record of this redesignation.

Thus, Mr Henley made only two \$1000 contributions to the Lonsdale for Senate '92 campaign, one for the Primary election and a second used for the recount.

I hope that this answers any questions you may have.

The purpose of this letter is to request an additional thirty day extension of time up to April 10, 1994, to respond to the allegations of the complaint.

As indicated in our correspondence of February 10, 1994, extensive investigation is required in order to adequately respond to the allegations. At the present time, we have been able to verify a majority of the contributions identified in the complaint but have had difficulty determining the purpose of the contributions. Correspondence has been directed to a number of candidate committees and we are still waiting for responses.

From the responses that we have received, we have discovered that mistakes were made in calculating the aggregate contributions by Mr. Henley for 1992, and refunds are in the process of being made. For example, the Democratic Congressional Campaign Committee and the Democratic Senatorial Campaign Committee have refunded \$10,000 in contributions made in October 1992. Other candidates are in the process of reviewing their records to determine whether refunds are appropriate because of similar mistakes.

We expect that we will be able to complete all investigative work during the thirty day extension period. Given the fact that only a short period of time has elapsed since our client first received notice of the issues raised in the complaint, coupled with the fact that no prejudice would result to the Commission if additional time was granted, we believe that the extension of time requested herein is reasonable.



Pursuant to your request, the purpose of this letter is to confirm our request for an additional twenty (20) day extension of time to respond to the Complaint.

To summarize the status of these proceedings, our client received the Complaint and first notice of the allegations that his 1991 and 1992 contributions as aggregated and attributed to 1992 primary and general campaigns exceeded FECA limits. On February 18, 1994, the FEC granted our request for a twenty (20) day extension of time to close of business on March 10, 1994 to respond. On March 8, 1994, we requested an additional thirty (30) day extension of time to respond for reasons stated in that correspondence, a copy of which is attached. In response, you granted us a ten (10) day extension with the request that we re-confirm our request for a thirty (30) day extension (twenty additional days), if necessary.

As previously indicated, our client, Don Henley, is a well known entertainer and philanthropist who provides support to numerous public programs and political campaigns. His contributions and support are made personally and through the offices of a business manager. Mr. Henley was never aware of any aggregate limitations or attribution rules with respect to his contributions and relied on individual candidates and their committees for compliance with federal election laws. Indeed, it should be noted that the allegations of the Complaint do not involve any allegations that Mr. Henley's contributions exceeded the amount that could be given to any one candidate.

Since Mr. Henley became apprised of the allegations of the Complaint, this firm has undertaken an investigation to determine whether the contributions alleged to have been made were indeed made to the candidates and committees identified, and the purpose

for these contributions, e.g., primary election, general election, or debt repayment. Since there is no centralized system maintained by federal candidates or committees for tracking aggregate contributions, we have been required to review each committee report of receipts and disbursements to determine the nature of the contributions. We have completed this task and have written to a number of candidates and committees for the purpose of requesting refunds because of the apparent mistake made to accept contributions exceeding the FECA limits.

Based upon responses received to date, Mr. Henley has received and been promised refunds from the following sources:

The Complaint alleges that \$42,850 in total contributions were attributed to 1992 primary and general campaigns. Accordingly, it is respectfully requested that an additional twenty (20) day extension of time be granted to confirm the above as well as other refunds which are expected.

We have not received any response to our March 21, 1994 request for a twenty (20) day extension of time to respond to the Complaint. Accordingly, we can only assume that an extension has not been granted and a response is necessary at this time. The purpose of this letter is to respond to the allegations of the Complaint with the hope that upon reviewing all the facts and circumstances in this matter, no further action will be brought against our client.

The Complaint charges that Mr. Henley's 1992 contributions exceeded by \$17,850 the \$25,000 contribution limit imposed under the FECA (see Paragraph 6 of the Complaint). The Complaint does not allege any intent to violate federal election law. Indeed, the allegations of the Complaint are based upon attribution rules promulgated by the Commission which require an individual to aggregate contributions in two or more years (1991 and 1992 in the present context) for the purpose of determining his or her total contributions in one particular year. Similarly the Complaint does not allege any facts suggesting that Mr. Henley, or any candidate or committee, had any knowledge of potential violations of Commission regulations at the time any contributions were made.

As indicated in our March 21, 1994 correspondence, since first becoming apprised of the allegations, this firm, on behalf of Mr. Henley, has sought to determine whether contributions alleged to have been made were made to the candidates and committees identified in the Complaint, and has requested refunds in those instances where candidates and committees accepted contributions from Mr. Henley in excess of \$25,000.

Since there is no centralized system maintained by federal candidates or committees for tracking aggregate contributions, the task has been difficult. Nevertheless, I am pleased to report that we have as of this writing received refunds from the following candidates/committees:


*The \$1,000 contribution made by Mr. Henley to George Brown in August 20, 1992, was refunded prior to the filing of the Complaint.

As noted by the Commission in its numerous publications, one of the primary purposes of federal election laws is to encourage citizens to take an active part in the federal election process. In keeping with this spirit, Mr. Henley has contributed to numerous candidates throughout the United States and has fully complied with federal election laws limiting the amount that can be contributed to a candidate in each election. While we are unclear as to the purpose of aggregate limits and the resultant restriction on how many candidates one can support, there is nothing in the Complaint to suggest that Mr. Henley had knowledge or belief that some of his 1991 contributions, when aggregated with his 1992 contributions, would exceed the \$25,000 threshold. Upon discovery, the above federal candidates and committees promptly refunded sufficient amounts to reduce the amount of Mr. Henley's contributions by more than the \$17,850 alleged in the Complaint.

Based upon all of the foregoing, we believe that no public purpose would be served by charging Mr. Henley with any violation of federal election law. Although mistakes may have been made by Mr. Henley, candidates, committees, and other persons assisting in connection with the subject contributions, there was no attempt to evade the law, nor was there any attempt to conceal any contributions that were made. Indeed, all contributions were reported, and based upon refunds received, Mr. Henley's 1992 contributions were \$23,350.

GENERAL COUNSEL'S MONTHLY REPORT

SENSITIVE

I. INTRODUCTION

This report is the second Enforcement Priority System Monthly Report. The purpose of this September Monthly Report is to recommend that the Commission no longer pursue the identified lower priority and stale cases.

II. CASES RECOMMENDED FOR CLOSING

A. Cases Not Warranting Further Pursuit Relative to Other Cases Pending Before the Commission

A critical component of the Priority System is identifying those pending cases that do not warrant the further expenditure of resources. Each incoming matter is evaluated using Commission-approved criteria and cases that, based on their rating, do not warrant pursuit relative to other pending cases are placed in this category. By closing such cases, the Commission is able to use its limited resources to focus on more important cases.

Having evaluated incoming matters, this Office has identified 44 cases which do not warrant further pursuit

relative to the other pending cases.¹ A short description of each case and the factors leading to assignment of a relatively low priority and consequent recommendation not to pursue each case is attached to this report. See Attachments 1-44. For the Commission's convenience, the narratives for the externally-generated matters are immediately followed by the complaint and response(s) and the narrative for the internally-generated matter is immediately followed by the referral.

B. Stale Cases

Investigations are severely impeded and require relatively more resources when the activity and evidence are old. Consequently, the Office of General Counsel recommends that the Commission focus its efforts on cases involving more recent activity. Such efforts will also generate more impact on the current electoral process and are a more efficient allocation of our limited resources. To this end, this Office has identified 2 cases that have remained inactive and assigned to the Central Enforcement Docket for one year and which it believes do not warrant further investment of significant Commission resources.² Since the recommendation not to pursue the identified cases is
