COMPLAINT

MUR 3881

COMPLAINT OF CENTER FOR RESPONSIVE POLITICS

1. This complaint charges that the respondent has violated the Federal Election Campaign Act, 2 U.S.C. § 431 et seq., as amended ("FECA"), by making aggregate contributions in excess of the limits permitted by the FECA.

PARTIES

2. The complainant, the Center for Responsive Politics, is a nonprofit, nonpartisan research group incorporated in the State of Iowa and headquartered in Washington, D.C., that studies Congress and related issues. Founded in 1983, it was designed to research matters concerning the organization and operation of Congress as an institution and to examine potential reforms that could improve both its internal operation and its responsiveness to the American public. The patterns of contributions of money to federal candidates has been one of its chief areas of study.

3. The respondent is an individual contributor to various candidates and political committees.

APPLICABLE STATUTES AND REGULATIONS

4. The FECA limits contributions by any one individual to an aggregate total of \$25,000 per calendar year. Contributions to a candidate or the candidate's authorized committee made in a year other than the calendar year of the election with respect to which the contribution is made are considered to be made during the calendar year in which such election is held. 2 U.S.C. § 441a(a)(3); 11 C.F.R. § 110.5.

GROUND FOR COMPLAINT


5. According to FEC records, respondent John Manning made contributions subject to FECA in the amounts and to the persons identified in the list attached to this complaint as Exhibit 1. Attached as Exhibit 2 are copies of the FEC records for each contribution listed in Exhibit 1. All exhibits reflect the records on file at the FEC as of December 15, 1993.

6. On information and belief, respondent John Manning made contributions attributed to the 1992 calendar year in the amount of \$43,300. These contributions exceeded by \$18,300 the \$25,000 contribution limit imposed by the FECA and Commission regulations on all contributions by any individual in a calendar year.

RELIEF

7. The Center for Responsive Politics respectfully urges the Commission to conduct a prompt and thorough investigation into the allegations in this Complaint, and to declare that the Respondent has violated the FECA and Commission regulations.



This is in response to the Commission's letter dated January 28, 1994 which notified Mr. Manning that a complaint had been filed against him.

The complaint charges that Mr. Manning exceeded the \$25,000 annual individual contribution limit during calendar year 1992 and attaches a list of contributions purportedly made by Mr. Manning during that year.

Mr. Manning acknowledges that he made the contributions in question. The contributions were not made, however, with any intent to exceed the annual contribution limit, but rather were the result of a series of misunderstandings about the workings of the federal campaign laws. Mr. Manning was not familiar with the limit and the way it is applied to contributions made in connection with federal elections.

Mr. Manning was unaware, for example, that contributions made to candidates during a non-election year (e.g., 1992), counted against his annual contribution limit during the year in which the candidate was seeking election. He further mistakenly understood that some of the contributions, those made on a joint checking account, would be attributed equally to him and his wife. If both of these understandings had been correct, Mr. Manning's contributions for 1992 would not have exceeded the \$25,000 limit.



In addition, the Citizens for Wofford Committee has acknowledged that the \$1,000 contribution received from Mr. Manning on January 7, 1992 was attributed to Senator Wofford's 1994 primary election. Exhibit 3. It should not, therefore, have counted toward his 1992 annual limit. The refunds and adjustments will put Mr. Manning's contributions below the \$25,000 limit for 1992. We will submit copies of the refund checks to you as they are received.

Mr. Manning has retained this law firm to advise him on future contributions and compliance with the federal campaign laws. We are in the process of establishing a system for tracking all contributions made for contribution limits purposes -- this includes not only the \$25,000 limit, but also the relevant limits for contributions to candidates and committees.

Mr. Manning had no intention of violating the federal campaign laws and has made every effort now that the law is clear to bring himself into compliance and to ensure no future violations. Given these mitigating circumstances, we ask that the Commission take no action on this complaint.

GENERAL COUNSEL'S MONTHLY REPORT

SENSITIVE

I. INTRODUCTION

This report is the second Enforcement Priority System Monthly Report. The purpose of this September Monthly Report is to recommend that the Commission no longer pursue the identified lower priority and stale cases.

II. CASES RECOMMENDED FOR CLOSING

A. Cases Not Warranting Further Pursuit Relative to Other Cases Pending Before the Commission

A critical component of the Priority System is identifying those pending cases that do not warrant the further expenditure of resources. Each incoming matter is evaluated using Commission-approved criteria and cases that, based on their rating, do not warrant pursuit relative to other pending cases are placed in this category. By closing such cases, the Commission is able to use its limited resources to focus on more important cases.

Having evaluated incoming matters, this Office has identified 44 cases which do not warrant further pursuit

relative to the other pending cases.¹ A short description of each case and the factors leading to assignment of a relatively low priority and consequent recommendation not to pursue each case is attached to this report. See Attachments 1-44. For the Commission's convenience, the narratives for the externally-generated matters are immediately followed by the complaint and response(s) and the narrative for the internally-generated matter is immediately followed by the referral.

B. Stale Cases

Investigations are severely impeded and require relatively more resources when the activity and evidence are old. Consequently, the Office of General Counsel recommends that the Commission focus its efforts on cases involving more recent activity. Such efforts will also generate more impact on the current electoral process and are a more efficient allocation of our limited resources. To this end, this Office has identified 2 cases that have remained inactive and assigned to the Central Enforcement Docket for one year and which it believes do not warrant further investment of significant Commission resources.² Since the recommendation not to pursue the identified cases is
