**COMPLAINT OF CENTER FOR RESPONSIVE POLITICS**

1. This complaint charges that the respondent has violated the Federal Election Campaign Act, 2 U.S.C. § 431 et seq., as amended ("FECA"), by making aggregate contributions in excess of the limits permitted by the FECA.

**PARTIES**

2. The complainant, the Center for Responsive Politics, is a nonprofit, nonpartisan research group incorporated in the State of Iowa and headquartered in Washington, D.C., that studies Congress and related issues. Founded in 1983, it was designed to research matters concerning the organization and operation of Congress as an institution and to examine potential reforms that could improve both its internal operation and its responsiveness to the American public. The patterns of contributions of money to federal candidates has been one of its chief areas of study.

3. The respondent is an individual contributor to various candidates and political committees.

### APPLICABLE STATUTES AND REGULATIONS

4. The FECA limits contributions by any one individual to an aggregate total of \$25,000 per calendar year. Contributions to a candidate or the candidate's authorized committee made in a year other than the calendar year of the election with respect to which the contribution is made are considered to be made during the calendar year in which such election is held. 2 U.S.C. § 441a(a)(3); 11 C.F.R. § 110.5.

### GROUND FOR COMPLAINT


5. According to FEC records, respondent Thomas A. Kershaw made contributions subject to FECA in the amounts and to the persons identified in the list attached to this complaint as Exhibit 1. Attached as Exhibit 2 are copies of the FEC records for each contribution listed in Exhibit 1. All exhibits reflect the records on file at the FEC as of December 15, 1993.

6. On information and belief, respondent Thomas A. Kershaw made contributions attributed to the 1992 calendar year in the amount of \$49,144. These contributions exceeded by \$24,144 the \$25,000 contribution limit imposed by the FECA and Commission regulations on all contributions by any individual in a calendar year.

### RELIEF

7. The Center for Responsive Politics respectfully urges the Commission to conduct a prompt and thorough investigation into the allegations in this Complaint, and to declare that the Respondent has violated the FECA and Commission regulations.

This is to formally reply on behalf of Thomas A. Kershaw in connection with the above-referenced matter. A "Statement of Designation of Counsel" is enclosed.

The complaint filed with the Commission (the "Complaint") alleges that Mr. Kershaw exceeded the permissible limits on individual contributions and federal elections during the 1992 campaign by contributing \$49,144 to various campaigns and organizations. This office has reviewed the complaint and Mr. Kershaw's records and determined that the amounts allegedly contributed in excess of the applicable \$25,000 limit include:

1. One Thousand Dollars (\$1,000) which was sent to the Friends of Bill Zeliff Committee on April 26, 1992 and reported to your office as received on May 17, 1992.

This amount was designated to be for retirement of debt from the 1990 campaign, as shown in the report filed with your office for that period by Mr. Zeliff's campaign (on Schedule A, page 10 of 25, Item B) which is an Exhibit to Complaint. It is my understanding that as such this amount is not included as a 1992 contribution, and the alleged total amount of 1992 federal campaign contributions is thus reduced to \$48,144. Of that amount:

2. Six Thousand Two Hundred Eighty Dollars (\$6,280) was actually contributed during 1991. These were simply not included in Mr. Kershaw's calculations of the amounts permitted to be contributed for the 1992 campaign because he was improperly advised as to the effect of "1991" contributions on the 1992 \$25,000 limit.
3. Fifteen Thousand Dollars (\$15,000) was sent to the Republican National Committee early in 1992, but was intended as a contribution to the account maintained by the Republican National Committee to fund non-federal activity (the Republican National State Elections Committee, the "RNSEC").

The total of these 3 listed items is \$22,280, which, if properly dealt with, would have resulted in "1992" contributions of \$26,994, an amount which, although exceeding \$25,000 due to poor record-keeping, clearly does not demonstrate willful intent to violate the law.

When Mr. Kershaw discovered last October that the \$15,000 had been credited to the Republican National Committee's general account to fund general political activities, and thus would be included in the amounts calculated against the \$25,000 individual limitation, he immediately contacted the Committee and had his staff review all of his records and contact other donees. As a result of these efforts, the following was done to rectify the situation:


- A. The Republican National Committee returned \$17,000 by check dated October 14, 1993, which amount was deposited by Mr. Kershaw into his personal account on October 15, 1993 (Mr. Kershaw then contributed \$17,000 to the RNSEC).
- B. The National Restaurant Association Political Action Committee [C00003764] returned \$5,000 by check dated October 18, 1993, which was deposited by Mr. Kershaw into his personal account on October 22, 1993. See Schedule B of FEC Form 3X filed by the National Restaurant Association Political Action Committee dated November 19, 1993 for October 1993.
- C. Representative Newt Gingrich returned \$650.00, which was deposited by Mr. Kershaw into his personal account on November 8, 1993.
- D. The Committee to Reelect Cunningham '92 [C00244646] returned \$500 by check dated October 26, 1993, which was deposited by Mr. Kershaw into his personal account on November 2, 1993.

The result of these transactions was to reverse \$23,150 of contributions, which reduced the net effective 1992 contributions from \$48,144 to \$24,994. Available documentation regarding each of these transactions is attached as Exhibits A, B, C and D.

Under these circumstances I suggest that there is no purpose served by requesting that the Commission authorize a further investigation or processing of this matter, **SINCE MR. KERSHAW VOLUNTARILY TOOK APPROPRIATE CORRECTIVE ACTION MONTHS PRIOR TO THE COMMENCEMENT OF THE COMMISSION'S INQUIRY.**



GENERAL COUNSEL'S MONTHLY REPORT

**SENSITIVE**

I. INTRODUCTION

This report is the second Enforcement Priority System Monthly Report. The purpose of this September Monthly Report is to recommend that the Commission no longer pursue the identified lower priority and stale cases.

II. CASES RECOMMENDED FOR CLOSING

A. Cases Not Warranting Further Pursuit Relative to Other Cases Pending Before the Commission

A critical component of the Priority System is identifying those pending cases that do not warrant the further expenditure of resources. Each incoming matter is evaluated using Commission-approved criteria and cases that, based on their rating, do not warrant pursuit relative to other pending cases are placed in this category. By closing such cases, the Commission is able to use its limited resources to focus on more important cases.

Having evaluated incoming matters, this Office has identified 44 cases which do not warrant further pursuit

relative to the other pending cases.<sup>1</sup> A short description of each case and the factors leading to assignment of a relatively low priority and consequent recommendation not to pursue each case is attached to this report. See Attachments 1-44. For the Commission's convenience, the narratives for the externally-generated matters are immediately followed by the complaint and response(s) and the narrative for the internally-generated matter is immediately followed by the referral.

#### B. Stale Cases

Investigations are severely impeded and require relatively more resources when the activity and evidence are old. Consequently, the Office of General Counsel recommends that the Commission focus its efforts on cases involving more recent activity. Such efforts will also generate more impact on the current electoral process and are a more efficient allocation of our limited resources. To this end, this Office has identified 2 cases that have remained inactive and assigned to the Central Enforcement Docket for one year and which it believes do not warrant further investment of significant Commission resources.<sup>2</sup> Since the recommendation not to pursue the identified cases is

After considering the circumstances of this matter, the Commission has determined to exercise its prosecutorial discretion and to take no action against your clients. See attached narrative. Accordingly, the Commission closed its file in this matter on November 14, 1994.

The confidentiality provisions of 2 U.S.C. § 437g(a)(12) no longer apply and this matter is now public. In addition, although the complete file must be placed on the public record within 30 days, this could occur at any time following certification of the Commission's vote. The Center for Responsive Politics filed a complaint alleging that Thomas Kershaw exceeded his 1992 \$25,000 annual limit by \$24,144 because his contributions attributable to 1992 total \$49,144. The contributions identified in the complaint raised the issue of whether some of the recipient committees, the Committee to Elect "Duke" Cunningham and the Friends of Bill Zeliff Committee, accepted contributions which exceeded the \$1,000 per election limit.

In response to the complaint, Mr. Kershaw indicates that a \$1,000 contribution to Friends of Bill Zeliff was to retire 1990 debt and should not be attributed to 1992. In regard to contributions attributable to 1992, Mr. Kershaw states that when he learned in October 1993 that a contribution he made to the Republican National Committee for non-federal activities had been deposited into the federal account, he requested and received a \$17,000 refund. Mr. Kershaw indicates that at that time, all his contributions were reviewed and as a result of the review, he requested and received a \$5,000 refund from the National Restaurant Association Political Action Committee, a \$650 refund from Friends of Newt Gingrich, and a \$500 refund from the Committee to Re-Elect Cunningham '92. Mr. Kershaw states that after these corrective actions were taken, his 1992 contributions totaled \$24,994. Mr. Kershaw attached to his response copies of the refund checks and his deposit slips.

The Friends of Cunningham Committee responds that on October 26, 1993, the Committee refunded a \$500 excessive contribution to Mr. Kershaw and that the refund was reported in its December 31, 1993 Report. The Friends of Bill Zeliff responds that the Committee did not receive excessive contributions from Mr. Kershaw because the May 17, 1992, contribution was designated for 1990 primary debt reduction.
