III. BACKGROUND:

Failure to Timely File a Report and Chronic Late Filing of Reports

The Tulsa County Republican Committee ("the Committee") failed to file seven (7) reports in a timely manner for the 1991-1992 election cycle (see Late Filing History chart). The reports were filed between fourteen (14) and one-hundred and forty-three (143) calendar days late.

A prior notice was sent to the Committee on December 27, 1991 to remind the Committee that the 1991 Year End filing deadline was January 31, 1992 (Attachment 4). A Non-Filer Notice was sent to the Committee on May 8, 1992 for failing to file the 1991 Year End Report (Attachment 7). On June 22, 1992, the Committee filed the 1991 Year End Report (Attachment 9).

On July 6, 1992, a Chronic Late Filer Notice ("the Notice") was sent to the Committee for failure to file the 1991 Mid-Year, 1991 Year End, and the 1992 April Quarterly Reports in a timely manner. The Notice advised the Committee that any additional late filing of report could result in legal enforcement action (Attachment 11).

On July 27, 1992, Joyce Pehanek of the Committee called the Reports Analysis Division ("RAD") analyst regarding errors on the 1991 Mid-Year and Year End Reports and the 1992 April Quarterly Report. At that time, the analyst also discussed the importance of filing reports in a timely manner (Attachment 12).

Subsequent to the sending of the Notice and the telephone conversation, the Committee failed to file the 1992 July Quarterly, October Quarterly, 30 Day Post-General and the Year End Reports in a timely manner.

On March 22, 1994, the Federal Election Commission ("the Commission") found that there is reason to believe that the Tulsa County Republican Committee ("the Committee") and you, as treasurer, violated 2 U.S.C. §§ 434(a)(4)(A)(i), (iii) and (iv), provisions of the Federal Election Campaign Act of 1971, as amended ("the Act"). The Factual and Legal Analysis, which formed a basis for the Commission's finding, is attached for your information.

The Commission notes that during this 1993-1994 election cycle, the Committee appears to have continuing problems with filing timely and complete reports. You may wish to contact your Reports Analyst to clarify these issues and to possibly avoid further legal action.

You may submit any factual or legal materials that you believe are relevant to the Commission's consideration of this matter. Please submit such materials to the General Counsel's Office within 15 days of your receipt of this letter. Where appropriate, statements should be submitted under oath. In the absence of additional information, the Commission may find probable cause to believe that a violation has occurred and proceed with conciliation.

In order to expedite the resolution of this matter, the Commission has also decided to offer to enter into negotiations directed towards reaching a conciliation agreement in settlement of this matter prior to a finding of probable cause to believe. Enclosed is a conciliation agreement that the Commission has approved.

If you are interested in expediting the resolution of this matter by pursuing preprobable cause conciliation and if you agree with the provisions of the enclosed agreement, please sign and return the agreement, along with the civil penalty, to the Commission. In light of the fact that conciliation negotiations, prior to a finding of probable cause to believe, are limited to a maximum of 30 days, you should respond to this notification as soon as possible.


Requests for extensions of time will not be routinely granted. Requests must be made in writing at least five days prior to the due date of the response and specific good cause must be demonstrated. In addition, the Office of the General Counsel ordinarily will not give extensions beyond 20 days.

If you intend to be represented by counsel in this matter, please advise the Commission by completing the enclosed form stating the name, address, and telephone number of such counsel, and authorizing such counsel to receive any notifications and other communications from the Commission.

This matter will remain confidential in accordance with 2 U.S.C. §§ 437g(a)(4)(B) and 437g(a)(12)(A), unless you notify the Commission in writing that you wish the investigation to be made public.

This matter was generated based on information ascertained by the Federal Election Commission ("the Commission") in the normal course of carrying out its supervisory responsibilities. See 2 U.S.C. § 437g(a)(2).

The Federal Election Campaign Act of 1971, as amended, ("the Act") requires treasurers of political committees other than authorized committees of a candidate to file periodic reports of receipts and disbursements. In any calendar year in which a regularly scheduled general election is held, all political committees that choose not to file on a monthly basis shall file quarterly reports which shall be filed no later than the 15th day after the last day of each calendar quarter, except that the report for the quarter ending on December 31 of such calendar year shall be filed no later than January 31 of the following calendar year. 2 U.S.C. § 434(a)(4)(A)(i).

Furthermore, political committees shall file a post-general election report no later than the 30th day after the general election, which shall be complete as of the 20th day after such general election. 2 U.S.C. § 434(a)(4)(A)(iii). Finally, in a non-election year, political committees must file a report covering the period beginning January 1 and ending June 30, which shall be filed no later than July 31, and a

report covering the period beginning July 1 and ending December 31, which report is due no later than January 31 of the following calendar year. 2 U.S.C. § 434(a)(4)(A)(iv).

The Tulsa County Republican Committee ("the Committee") is a political committee not authorized by any candidate. It has elected to report on a quarterly basis. Jesse Clayton-Aguirre is the current treasurer.

The Committee's 1991 Mid-Year Report was due on July 31, 1991. 2 U.S.C. § 434(a)(4)(A)(iv). On July 5, 1991, the Committee was notified in writing of that deadline. On September 30, 1991, the Committee filed the 1991 Mid-Year Report, 61 days late, disclosing receipts totaling \$19,701.73 and disbursements totaling \$13,532.28.

The Committee's 1991 Year-End Report was due on January 31, 1992. 2 U.S.C. § 434(a)(4)(A)(iv). On December 27, 1991, the Committee was notified in writing of that deadline, and a Non-Filer Notice was sent on May 8, 1992, advising the Committee of its failure to file the Year-End Report. On June 22, 1992, the Committee filed the 1991 Year-End Report, 143 days late, disclosing receipts totaling \$10,220.64 and disbursements totaling \$10,262.62.

Next, the 1992 April Quarterly Report was due on April 15, 1992. 2 U.S.C. § 434(a)(4)(A)(i). On March 20, 1992, the Committee was notified in writing of that deadline, and a Non-Filer Notice was sent on May 7, 1992, advising the Committee of its failure to file the April Quarterly Report. On June 22, 1992, the Committee filed the 1992 April Quarterly Report, 68 days late, disclosing receipts totaling \$5,640.82 and disbursements totaling \$9,037.85.

On July 6, 1992, the Committee was sent a Chronic Late Filer Notice which noted that the 1991 Mid-Year, 1991 Year-End, and 1992 April Quarterly Reports had been filed late. The Notice further advised that additional late filings could result in the Commission's initiation of legal action.

The 1992 July Quarterly Report was due on July 15, 1992. 2 U.S.C. § 434(a)(4)(A)(i). On June 19, 1992, a Prior Notice was sent reminding the Committee of the upcoming deadline.¹ On August 6, 1992, the Committee filed the 1992 July Quarterly Report, 22 days late, disclosing receipts totaling \$3,545.90 and disbursements totaling \$4,119.86.

1. On July 27, 1992, the Reports Analysis Division ("RAD") analyst received a call from Joyce Pehanek of the Committee, regarding errors in the 1991 Mid-Year, 1991 Year-End, and 1992 April Quarterly Reports. At that time, the analyst also discussed the importance of filing reports in a timely manner.

The 1992 October Quarterly Report was due on October 15, 1992. 2 U.S.C. § 434(a)(4)(A)(i). On September 21, 1992, the Committee was notified in writing of the applicable deadline. On October 29, 1992, the Committee filed the 1992 October Quarterly Report, 14 days late, disclosing receipts totaling \$3,071.27 and disbursements totaling \$4,501.17.

The 1992 30-Day Post-General Election Report was due on December 3, 1992. 2 U.S.C. § 434(a)(4)(A)(iii). On September 28, 1992, the Committee was notified in writing of the applicable deadline. On December 28, 1992, the Committee filed the 1992 30-Day Post-General Election Report, 25 days late, disclosing receipts totaling \$8,326.82 and disbursements totaling \$6,836.08.

Finally, the 1992 Year-End Report was due on January 31, 1993. 2 U.S.C. § 434(a)(4)(A)(i). On December 28, 1992, the Committee was sent a Prior Notice reminding it of the applicable deadline, and a Non-Filer Notice concerning the report was sent on February 18, 1993. On March 3, 1993, the Committee filed the 1992 Year-End Report, 31 days late, disclosing receipts totaling \$158.59 and disbursements totaling \$2,198.29.

Therefore, there is reason to believe that the Tulsa County Republican Committee and Jesse Clayton-Aguirre, as treasurer, violated 2 U.S.C. § 434(a)(4)(A)(iv) by failing to file timely the 1991 mid-year and 1991 year-end reports; violated 2 U.S.C. § 434(a)(4)(i) by failing to file timely the 1992 quarterly and year-end reports; and violated 2 U.S.C. § 434(a)(4)(A)(iii) by failing to file timely the 1992 30-Day Post-General Report.

Dear Ms. Dillenseger:

On April 5, 1994, I received the information regarding the Federal Election Commission's factual and legal analysis regarding reporting requirements for the Tulsa County Republican Committee. You may recall, that on April 6, 1994, I contacted your office to discuss these matters and to determine my most appropriate response. It was my understanding from you at that time that I had fifteen (15) days in which to respond to the allegations and to present any other information which I thought pertinent in the consideration of this matter. Please consider this my response to the factual and legal analysis concerning the reporting to the Federal Election Committee by the Tulsa County Republican Party.

I believe my answer can best be structured by covering three topics: the actual appointment of the current treasurer for the Tulsa County Republican Party; the reasons and circumstances surrounding the lateness of the reporting; and the issue of the civil penalty which the Federal Election Commission can assess against our committee.

APPOINTMENT OF TULSA COUNTY REPUBLICAN COMMITTEE TREASURER

It is my understanding that the records held by the Federal Election Commission show Mr. Jesse Clayton-Aguirre as the treasurer for the Tulsa County Republican Committee. I became chairman of the Tulsa County Republican Party in January, 1991. It is my understanding that at some point in time prior to that date Mr. Clayton-Aguirre was no longer serving as the treasurer. As of this writing, I do not know of Mr. Clayton-Aguirre's whereabouts, nor have any of the officers of the Tulsa County Republican Party been in contact with him for several years. Shortly after my election as Chairman in January, 1991, I asked Mr. Rodney D. Kaufmann if he would serve in the volunteer capacity as treasurer

for our party. I believe approximately February or March, 1991, Mr. Kaufmann agreed to serve in this capacity.

This was the first time that Mr. Kaufmann assumed the position of treasurer for the Tulsa County Republican Party and neither he nor I were aware of any reporting requirements to so inform the Federal Election Commission of this change. There was not a great deal of cooperation or coordination between the prior administration of the Tulsa County Republican Party and when I and Mr Kaufmann assumed our voluntary positions. It is my understanding that Mr. Kaufmann has completed and filed each of the required reports to the Federal Election Commission since he became treasurer. It is also my understanding that he has placed his signature on each of the reports and to the best of our knowledge this was the method by which the Federal Election Commission and those responsible for reviewing the reports were informed of the current treasurer.

FILING OF REPORTS

It is my understanding that all of the reports which were required to be filed between 1991 and the current date have been completed. It is also my understanding that we have not received any questions, concerns, or challenges to any of the information or contents of the filed reports. For various reasons which I will address, these reports have been filed late with the Federal Election Commission.

In January, 1991, I became Chairman of the Tulsa County Republican Party. For many many weeks after that it was quite difficult assembling the financial records and information which had been maintained. Because of a complete change of all officers responsible for running the Tulsa County Republican Party, we inadvertently became late with several of our reporting obligations. We also soon determined that some of the records and information necessary for the filing of these reports were missing. It also may appear that correspondence from the Federal Election Commission to the Republican County Headquarters addressed to Mr. Clayton-Aguirre may have been forwarded on to him. At some point during 1991, I believe volunteers were staffing the Tulsa County Republican Headquarters and were not passing this mail addressed to Mr. Clayton-Aguirre on to me, but were attempting to forward the same to him. Unfortunately, either Mr. Clayton-Aguirre never received this information, or responded to either myself or to the Federal Election Commission. In January 1993, the Tulsa County Republican Party once again had a complete change of officers with the exception of myself and Mr. Kaufmann. The change of officers again produced some transition period and consequent lateness in the filing of reports.

During several of these quarterly reporting periods, Mr. Kaufmann or a member of his office was in contact with the Reports Analysis Division. Often times these contacts were to straighten out information which was being requested, clarifying instructions, or requesting a continuation of time in which to file the report. Admittedly, as a busy professional certified public accountant and serving in a voluntary capacity as treasurer for our party, Mr. Kaufmann may not have placed the reporting requirements of the Federal Election Commission at the top of his office priority. This is not in any way to detract or minimize the importance of the disclosure. Both Mr. Kaufmann and other officers of the party certainly realize the policy and purpose behind timely reporting. We also have attempted, very diligently, to make sure that all reports are filed and that they are prepared and calculated correctly according to all regulations. I believe this to be of equal, if not greater importance in light of the voluntary nature under which all components of the Tulsa County Republican Party must operate.



The Commission found reason to believe that the Tulsa County Republican Committee and its treasurer ("the Respondents") violated 2 U.S.C. §§ 433(c) and 434(a)(4)(A)(i), (iii) and (iv).

NOW, THEREFORE, the Commission and the Respondents, having participated in informal methods of conciliation, prior to a finding of probable cause to believe, do hereby agree as follows:

I. The Commission has jurisdiction over the Respondents and the subject matter of this proceeding, and this agreement has the effect of an agreement entered pursuant to 2 U.S.C. § 437g(a)(4)(A)(i).

II. The Respondents have had a reasonable opportunity to demonstrate that no action should be taken in this matter.

III. The Respondents enter voluntarily into this agreement with the Commission.

IV. The pertinent facts in this matter are as follows:

1. The Tulsa County Republican Committee is a political committee within the meaning of 2 U.S.C. § 431(4) and is not an authorized committee of any candidate.

2. The present treasurer of the Tulsa County Republican Committee is Rodney D. Kaufmann. Although Jesse Clayton-Aguirre was the "treasurer of record" for the Committee during the time period relevant to this matter, Mr. Kaufmann signed as treasurer all of the reports at issue in this matter.

3. The Federal Election Campaign Act of 1971, as amended, ("the Act") requires treasurers of political committees other than authorized committees of a candidate to file periodic reports of receipts and disbursements. In any calendar year in which a regularly scheduled general election is held, all political committees that choose not to file on a monthly basis shall file quarterly reports which shall be filed no later than the 15th day after the last day of each calendar quarter, except that the report for the quarter ending on December 31 of such calendar year shall be filed no later than January 31 of the following calendar year. 2 U.S.C. § 434(a)(4)(A)(i).

4. Political committees shall file a post-general election report no later than the 30th day after the general election, which shall be complete as of the 20th day after such general election. 2 U.S.C. § 434(a)(4)(A)(iii).

5. In a non-election year, political committees shall file a report covering the period beginning January 1 and ending June 30, which shall be filed no later than July 31, and a

report covering the period beginning July 1 and ending December 31, which report is due no later than January 31 of the following calendar year. 2 U.S.C. § 434(a)(4)(A)(iv).

6. The Tulsa County Republican Committee has elected to report on a quarterly basis.

7. Pursuant to 2 U.S.C. § 434(a)(4)(A)(iv), the 1991 Mid-Year Report was due on July 31, 1991. The Respondents filed the 1991 Mid-Year Report on September 30, 1991, 61 days late, disclosing receipts totaling \$19,701.73 and disbursements totaling \$13,532.28.

8. Pursuant to 2 U.S.C. § 434(a)(4)(A)(iv), the 1991 Year-End Report was due on January 31, 1992. The Respondents filed the 1991 Year-End Report on June 22, 1992, 143 days late, disclosing receipts totaling \$10,220.64 and disbursements totaling \$10,262.62.

9. Pursuant to 2 U.S.C. § 434(a)(4)(A)(i), the 1992 April Quarterly Report was due on April 15, 1992. The Respondents filed the 1992 April Quarterly Report on June 22, 1992, 68 days late, disclosing receipts totaling \$5,640.82 and disbursements totaling \$9,037.85.

10. Pursuant to 2 U.S.C. § 434(a)(4)(A)(i), the 1992 July Quarterly Report was due on July 15, 1992. The Respondents filed the 1992 July Quarterly Report on August 6, 1992, 22 days late, disclosing receipts totaling \$3,545.90 and disbursements totaling \$4,119.86.

11. Pursuant to 2 U.S.C. § 434(a)(4)(A)(i), the 1992 October Quarterly Report was due on October 15, 1992. The

Respondents filed the 1992 October Quarterly Report on October 29, 1992, 14 days late, disclosing receipts totaling \$3,071.27 and disbursements totaling \$4,501.17.

12. Pursuant to 2 U.S.C. § 434(a)(4)(A)(iv), the 1992 Year-End Report was due on January 31, 1993. The Respondents filed the 1992 Year-End Report on March 3, 1993, 31 days late, disclosing receipts totaling \$158.59 and disbursements totaling \$2,198.29.

13. Pursuant to 2 U.S.C. § 434(a)(4)(A)(iii), the 1992 30-Day Post-General Election Report was due on December 3, 1992. The Respondents filed the 1992 30-Day Post-General Election Report on December 28, 1992, 25 days late, disclosing receipts totaling \$8,326.82 and disbursements totaling \$6,836.08.

14. The Act also requires each authorized principal campaign committee of a federal candidate to file a statement of organization. 2 U.S.C. § 433(a). Any changes in information previously submitted in the statement of organization shall be reported no later than 10 days after the date of the change. 2 U.S.C. § 433(c).

15. Rodney D. Kaufmann signed the Tulsa County Republican Committee's 1991 Mid-Year, 1991 Year-End, 1992 April Quarterly, 1992 July Quarterly, 1992 October Quarterly, 1992 Year-End, and 1992 30-Day Post-General Election Reports as the Committee's treasurer. Pursuant to 2 U.S.C. § 433(c), the Respondents were required to file an amendment to their statement of organization no later than 10 days after the change in treasurer, and they did not.

16. The Respondents did not file an amendment to their statement of organization to reflect the change in treasurer until July 19, 1994.

V.1. The Respondents failed to file timely the 1991 mid-year and year-end reports, in violation of 2 U.S.C. § 434(a)(4)(A)(iv).

2. The Respondents failed to file timely the 1992 quarterly and year-end reports, in violation of 2 U.S.C. § 434(a)(4)(A)(i).

3. The Respondents failed to file timely the 1992 30-Day Post-General Report, in violation of 2 U.S.C. § 434(a)(4)(A)(iii).

4. The Respondents failed to amend their statement of organization to reflect a change in treasurer within 10 days of when the change took place, in violation of 2 U.S.C. § 433(c).

VI. The Respondents will pay a civil penalty to the Commission in the amount of three thousand, seven hundred dollars (\$3,700), pursuant to 2 U.S.C. § 437g(a)(5)(A), such penalty to be paid as follows:

1. One initial payment of \$1,000 due thirty (30) days after the date on which the Conciliation Agreement is fully executed;

2. Thereafter, beginning ninety (90) days after the date of the initial payment, 3 consecutive installment payments of \$900 each;

3. Each installment shall be paid ninety (90) days after the previous payment;

4. In the event that any installment payment is not received by the Commission by the fifth day after the date in which it becomes due, the Commission may, at its discretion, accelerate the remaining payments and cause the entire amount to become due upon ten days written notice to the Respondents. Failure by the Commission to accelerate the payments with regard to any overdue installment shall not be construed as a waiver of its right to do so with regard to future overdue installments.

VII. The Commission, on request of anyone filing a complaint under 2 U.S.C. § 437g(a)(1) concerning the matters at issue herein or on its own motion, may review compliance with this agreement. If the Commission believes that this agreement or any requirement thereof has been violated, it may institute a civil action for relief in the United States District Court for the District of Columbia.

VIII. This agreement shall become effective as of the date that all parties hereto have executed same and the Commission has approved the entire agreement.

IX. Except as provided in paragraphs 2-4 of Section VI, the Respondents shall have no more than thirty (30) days from the date this agreement becomes effective to comply with and implement the requirements contained in this agreement and to so notify the Commission.

X. This Conciliation Agreement constitutes the entire agreement between the parties on the matters raised herein, and no other statement, promise, or agreement, either written or oral, made by either party or by agents of either party, that is

Dear Mr. Simonson:

This acknowledges receipt of your letter of November 30, 1995, and the \$1,200 final payment on the civil penalty from the Tulsa County Republican Committee. In your letter, you state that the Tulsa County Republican Committee does not receive funds from or make contributions to Federal candidates and inquire whether this would qualify the committee for a "waiver" from filing future FEC reports.

Committees must file FEC reports if they receive contributions or make expenditures which exceed certain threshold amounts and which are made or received for the purpose of influencing a Federal election. Although there are no "waivers" from filing reports, a political committee may terminate its registration and reporting obligations at any time, provided that: (1) the committee no longer intends to receive contributions or make expenditures; (2) the committee has no outstanding debts or obligations; and, (3) the committee is not involved in an ongoing enforcement matter. A committee eligible to terminate may do so at any time by filing a termination report, using FEC Form 3X (checking the "termination report" box on the Summary Page). The termination report must disclose: (1) all receipts and disbursements not previously reported, including an accounting of debt retirement; and, (2) the purpose for which residual funds will be used. Please write or call Donald L. Averett, Reports Analysis Division, at (800) 424-9530, to determine if the Tulsa County Republican Committee qualifies for termination or if you have any questions.
