III. BACKGROUND:

Failure to File Forty-Eight Hour Notifications

The Friends of Bob Carr ("the Committee") has failed to file the required 48-Hour Notifications ("48-Hour Notices") for one hundred fifty-seven (157) contributions totalling \$167,500 received prior to the 1994 General Election.

The candidate was involved in the General Election held on November 8, 1994. Prior Notice was sent to the Committee on October 3, 1994 (Attachment 2). The Notice includes a section titled "48 Hour Notices on Contributions". This section reads "Notices are required if the committee receives contributions (including contributions and loans from the candidate's personal funds; and endorsements or guarantees of bank loans) of \$1,000 or more, during the period of October 20 through November 5. The notices must reach the appropriate federal and state filing offices within 48 hours of the committee's receipt of the contribution(s)."

Schedule A of the 30 Day Post-General Report indicates that the Committee failed to file 48-Hour Notices for one hundred fifty-seven (157) contributions received during the aforementioned period (Attachment 3). The following is a list of the contributions for which no 48-Hour Notices were filed:

On January 3, 1995, a Request for Additional Information ("RFAI") was sent to the Committee (Attachment 4). The RFAI notes on an informational basis that the Committee may have failed to file one or more of the required 48-Hour Notices for "last minute" contributions of \$1,000 or more. The notice requests the Committee to review their procedures for checking contributions received during the aforementioned time period. In addition, the notice states that although the Commission may take legal steps, any response would be taken into consideration.

On January 25, 1995, a Reports Analysis Division analyst spoke to a representative for the Committee. The representative stated.. "she didn't realize 'the Committee' was required to file 48-hour notices for the transfers and...all of those names were filed as 48-hour notices for the Michigan Senate Victory Fund report." A review of the 48-Hour Notices for the Fund shows they filed 66 of the required 117 48-Hour Notices (Attachment 5).

. These sixty-six (66) contributions were reported on 48-Hour Notices filed by the Fund.

x These ninety (90) contributions were included on 48-Hour Notices filed with the Committee's amended 30 Day Post-General Report (Attachment 6).

The Committee's February 10, 1995 response states "we believe we reported all receipts of \$1,000 or greater received between October 20 and 48 hours before the election" on November 8, 1994. Included in the Committee's Amendment were copies of the 48-Hour Notices they claimed to have filed with the Commission. "The Committee also stated ..." the transfers received from Michigan Senate Victory Fund ... were all reported during the 48-hour reporting period under heading of Michigan Senate Victory Fund and in consult with Friends of Bob Carr." (Attachment 6).

On April 26, 1995, a Reports Analysis Division analyst telephoned a representative at the Office of the Secretary of the Senate to confirm that the 48-Hour Notifications on file in that office matched those on file with the Commission (Attachment 7). The Secretary's representative stated that the Secretary's Office was not in possession of any 48-Hour Notifications in addition to those received by the Commission.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule A of your report discloses a contribution(s) which appears to exceed the limits set forth in the Act (copies attached). You should conduct a review of all of your contributions to determine the rest of the excessives that your committee may have received. As you check for additional excessives, you should review the committee's procedures for handling the receipt of contributions.

An individual or a political committee other than a qualified multicandidate committee may not make a contribution to a candidate for federal office in excess of \$1,000 per election. A qualified multicandidate committee may not make a contribution to a candidate for federal office in excess of \$5,000 per election. The term "contribution" includes any gift, subscription, loan, advance, or deposit of money or anything of value made by any person for the purpose of influencing any election for federal office. (2 U.S.C. §441a(a) and (f); 11 CFR §110.1(b), (e) and (k))

If the contribution(s) in question was not completely or correctly reported, you should amend your original report using the new or corrected information. On January 25, 1995, I phoned "the Committee" and spoke to Megan Bennett, a representative for "the Committee". I asked her if she had received my letter regarding the 30 Day Post-General Report and if she was going to respond soon. She said she had received my letter and was working on it as we spoke.

I then asked if she understood that all of the memo entries pertaining to the transfers on Line 12, from Michigan Senate Victory were the main source of missing 48 Hour notifications her committee sent.

She said she didn't realize that "the Committee" was required to file 48 Hour Notices for the transfers and told me that all of those names were filed as 48 Hour Notices for the Michigan Senate Victory Report.

I further explained to her that the 48 Hour notifications should have been filed with "the Committee" and not Michigan Senate Victory because "the Committee" needs to show, for the public record, that they received these contributions 48 hours before the election since they were the ones running for office and not Michigan Senate Victory. I asked her to work on an amendment that would explain what happened. She agreed.

Based on our conversation, I went ahead and looked up the 48 Hour Notices for Michigan Senate Victory. They only filed sixty-six (66) of the required one hundred seventeen (117) 48 Hour Notices missing from the transfers on Line 12 for "the Committee".

We would like to respond to the Federal Election Commission's preliminary review of the Friends of Bob Carr 30 day post general election report.

There were six contributions about which the commission requested further information:

1. The contribution received from Mandell Berman in an allocation from the Michigan Senate Victory Fund on September 2, 1994 has been redesignated according to the allocation agreement of the Michigan Senate Victory Fund (see Exhibit A.) Of the total contribution, \$750 is designated to the general election and \$250 is designated to the primary election. This brings his total for the primary election and the general election each to \$1000.
2. Mark Saffer's contribution received in an allocation from the Michigan Senate Victory Fund should have been reported as designated half to the primary election and half to the general election, per the allocation agreement of the Michigan Senate Victory Fund (see Exhibit B.) This brings Mr. Saffer's contribution to the primary election to \$500 and the general election to \$1000.
3. Similarly, the second contribution received from Ted Gatzaros in an allocation from Michigan Senate Victory Fund on November 2, 1994 has been redesignated to the primary election, per the allocation agreement (see Exhibit C.)
4. The \$250 contribution from Robert Brand received on November 22, 1994 has been reattributed to the primary election (see Exhibit D.)
5. The \$1000 contribution from the joint account of Rodney and Laverne Hagenbuch received on November 7, 1994 and reported as a contribution from Rodney Hagenbuch has been reattributed as a contribution from

Laverne Hagenbuch (see Exhibit E.)

6. The contribution from Norbert Zuckerman received in an allocation from Michigan Senate Victory Fund on October 28, 1994 has been redesignated to the primary election, per the allocation agreement (see Exhibit F.)

Accompanying this letter is an amendment that corrects the discrepancy on the totals on our outstanding debts, picking up the obligations owed as itemized on our amended third quarterly report. The change in the amount owed to Grunwald, Eskew & Donilon and to Greenberg Research on our previous report is the result of some payments (listed on the amended report) and some corrections for misbiling and double billing.

In resuming our total operating expenditures we still have a total of \$906,875.12, as previously reported on both line 17, column A of the detailed summary page and on the last page of the supporting schedule B. We are attaching copies of our tapes to document this figure.

Also accompanying this letter and amendment are copies of all 48 hour notices filed with the Federal Election Commission. We believe that we reported all receipts of \$1000 or greater received between October 20 and 48 hours before the election on November 9, 1994. Please contact us if your records do not match ours.

In answer to a question raised during a conversation with Ms. Costa, the transfers received from Michigan Senate Victory Fund by Friends of Bob Carr were all reported during the 48 hour reporting period under the heading of Michigan Senate Victory Fund and in consult with Friends of Bob Carr. All funds received by Friends of Bob Carr, therefore, were reported to the Federal Election Commission.

The contributions for which 48 hour notices were filed but that you did not find on the report can be explained as follows:

Antonita H. Hawi's name was misspelled on the 48 hour notice as Antonita H. Hawa, and appears on page 48 of schedule A for line 11a as Antonita H. Hawi.

Illana P. Greenberg's contribution was of \$100 and was included on a 48

hour notice as such. Because her aggregate year to date contribution did not exceed \$200, her name does not appear on schedule A for line 11a (see exhibit G.)

Stephen Darcy's contribution was in fact a contribution to the Michigan Senate Victory Fund and should not have been included with the 48 hour notices for Friends of Bob Carr (see exhibit H.)

Joe Michaels's contribution was returned to him before it was deposited but after it had been reported on a 48 hour notice.

John Jacob's contribution is reported on page 35 of schedule A for line 11a.

Louis Glazer's two contributions, the Goldman Sachs Partners PAC contribution, and the SIC/PAC FEC contribution were all received by October 19 and thus reported on the pre-General Election report, but copies of the checks did not reach the person filing the 48 hour notices until after the cut off date for the pre-General report and were thus reported again on the 48 hour notices (see exhibit J.)

The UA Local 337 PAC was in fact a contribution from the Pipe Fitters Federal Election Fund drawn on their funds kept in the UA Local Credit Union (see exhibit K.) While this was reported on the 48 hour notice as a receipt from the UA Local 337 PAC, in final preparation of the general election report we reviewed the check copy and correctly reported the receipt as one from the Pipe Fitters Federal Election Fund, which can be found on page 9 of schedule A for line 11c.

Both the Boeing PAC Federal Account contribution and the Co America PAC contribution were reported on the 48 hour notices twice, once by the person who received the checks and once by the person who deposited the checks. Both of these contributions can be found on page 3 of schedule A for line 11c.

We have followed the commission's rules for making the best effort possible in reporting occupation and name of employer for our contributors whose aggregate year to date contributions exceed \$200. All solicitations include requests for information (see exhibit L.) If we did not receive the information needed with the original solicitation, we



The Office of the General Counsel received a referral from the Reports Analysis Division ("RAD") on June 6, 1995 (Attachment 1). The basis for the referral is the failure of the Friends of Bob Carr to file one hundred fifty-seven 48 Hour notifications ("48 Hour Notices") for contributions totaling \$167,500.¹ Bob Carr lost the 1994 General Election for the Senate in the State of Michigan with forty-three percent (43%) of the vote.

II. FACTUAL AND LEGAL ANALYSIS

Based on the Factual and Legal Analysis, see Attachment 2, this Office recommends the Commission find reason to believe the Friends of Bob Carr and Bob Carr, as treasurer,² violated 2 U.S.C. § 434(a)(6)(A).

III. DISCUSSION OF CONCILIATION AND CIVIL PENALTY

¹ At the time of the activity in this matter, Dennis Ritter was treasurer of Friends of Bob Carr. On January 24, 1995, the candidate assumed the role of treasurer.



On March 8, 1996, the Federal Election Commission found that there is reason to believe Friends of Bob Carr and you, as treasurer, violated 2 U.S.C. § 434(a)(6)(A), a provision of the Federal Election Campaign Act of 1971, as amended ("the Act"). The Factual and Legal Analysis, which formed a basis for the Commission's finding, is attached for your information.

You may submit any factual or legal materials that you believe are relevant to the Commission's consideration of this matter. Please submit such materials to the General Counsel's Office within 15 days of your receipt of this letter. Where appropriate, statements should be submitted under oath. In the absence of additional information, the Commission may find probable cause to believe that a violation has occurred and proceed with conciliation.

In order to expedite the resolution of this matter, the Commission has also decided to offer to enter into negotiations directed towards reaching a conciliation agreement in settlement of this matter prior to a finding of probable cause to believe. Enclosed is a conciliation agreement that the Commission has approved.



This matter was generated based on information ascertained by the Federal Election Commission ("the Commission") in the normal course of carrying out its supervisory responsibilities. See 2 U.S.C. § 437g(a)(2).

The Federal Election Campaign Act of 1971, as amended ("the Act"), requires principal campaign committees of candidates for federal office to notify in writing either the Secretary of the Senate, the Clerk of the U.S. House of Representatives or the Commission, as appropriate, and the Secretary of State, of each contribution totaling \$1,000 or more, received by any authorized committee of the candidate after the 20th day but more than 48 hours before any election. 2 U.S.C. § 434(a)(6)(A). The Act further requires notification to be made within 48 hours after the receipt of the contribution and to include the name of the candidate and office sought, the date of receipt, the amount of the contribution, and the identification of the contributor. Id. The notification of these contributions shall be in addition to all other reporting requirements. 2 U.S.C. § 434(a)(6)(B). On October 3, 1994, the Commission sent a notice to the Friends of Bob Carr ("the Committee") regarding the 48 hour reporting requirements.

The General Election in the state of Michigan was held on November 8, 1994. Pursuant to the Act, the Committee was required to notify the Commission, in writing, of all contributions of \$1,000 or more received from October 20, 1994 to November 5, 1994, within 48 hours of their receipt. A review of the Committee's 1994 30 Day Post-General Report identified one hundred fifty-seven (157) contributions received between October 20, 1994 and November 5, 1994, of \$1,000 or more, totaling \$167,500, for which the Committee did not submit 48 Hour Notices. One hundred seventeen of the 157 contributions were transfers from the Michigan Senate Victory Fund, a joint fundraising committee which had filed 48 Hour Notices regarding

66 of the contributions. Such reporting, however, does not satisfy the requirements of section 434(a)(6)(A), which provides that principal campaign committees shall file 48 Hour Notices disclosing contributions received shortly before an election. Furthermore, even if the Michigan Senate Victory Fund's 48 hour reporting satisfied this requirement, it only covered 66 of the 157 contributions that the Committee failed to report by 48 Hour Notice.

Therefore, there is reason to believe that the Friends of Bob Carr and Bob Carr, as treasurer, violated 2 U.S.C. § 434(a)(6)(A) by failing to report campaign contributions of \$1,000 or more, received after the 20th day, but more than 48 hours before the general election, within 48 hours of receipt of the contributions.

Based on information ascertained in the normal course of carrying out its supervisory responsibilities, on March 8, 1996, the Federal Election Commission found reason to believe that Friends of Bob Carr and Bob Carr, as treasurer, ("Committee") violated 2 U.S.C. § 434(a)(6)(A).

After considering all the evidence available to the Commission, the Office of the General Counsel is prepared to recommend that the Commission find probable cause to believe that a violation has occurred.

The Commission may or may not approve the General Counsel's recommendation. Submitted for your review is a brief stating the position of the General Counsel on the legal and factual issues of the case. Within 15 days of your receipt of this notice, you may file with the Secretary of the Commission a brief (ten copies if possible) stating your position on the issues and replying to the brief of the General Counsel. (Three copies of such brief should also be forwarded to the Office of the General Counsel, if possible.) The General Counsel's brief and any brief which you may submit will be considered by the Commission before proceeding to a vote of whether there is probable cause to believe a violation has occurred.

If you are unable to file a responsive brief within 15 days, you may submit a written request for an extension of time. All requests for extensions of time must be submitted in writing five days prior to the due date, and good cause must be demonstrated. In addition, the Office of the General Counsel ordinarily will not give extensions beyond 20 days.



GENERAL COUNSEL'S BRIEF

I. BACKGROUND

Friends of Bob Carr is the authorized principal campaign committee for Bob Carr's 1994 senate campaign. Friends of Bob Carr and Bob Carr, as treasurer, ("the Committee") failed to file one hundred and fifty-four (154) 48-Hour Notifications for contributions totaling \$164,500 received shortly before the 1994 General Election. On March 8, 1996, the Commission voted to find reason to believe that the Committee violated 2 U.S.C. § 434(a)(6)(A).

II. ANALYSIS

The Federal Election Campaign Act of 1971, as amended ("the Act"), requires principal campaign committees of candidates for federal office to notify in writing either the Secretary of the Senate, the Clerk of the U.S. House of Representatives or the Commission, as appropriate, and the Secretary of State, of each contribution totaling \$1,000 or more, received by any authorized committee of the candidate after the 20th day but more than 48 hours before any election. 2 U.S.C. § 434(a)(6)(A). The Act further requires notification to be made within 48 hours after the receipt of the contribution and to include the name of the candidate and office sought, the date of receipt, the amount of the contribution, and the identification of the contributor. *Id.* The notification of these contributions shall be in addition to all other reporting requirements. 2 U.S.C. § 434(a)(6)(B). On October 3, 1994, the Commission sent a notice to the Committee regarding the 48-Hour reporting requirements.

The General Election in the state of Michigan was held on November 8, 1994. Pursuant to the Act, the Committee was required to notify the Commission, in writing, of all contributions of \$1,000 or more received from October 20, 1994 to November 5, 1994, within 48 hours of their receipt. A review of the Committee's 1994 30 Day Post-General Report identified one hundred fifty-four (154) contributions received between October 20, 1994 and November 5, 1994, of \$1,000 or more, totaling \$164,500, for which the Committee did not submit 48-Hour Notices. Thirty-seven contributions were made directly to the Committee. The Committee did not timely submit timely 48-Hour Notices for these contributions, but rather filed the Notices on February 10, 1995 in response to a Commission Request For Additional Information.

The remaining one hundred seventeen contributions were transfers from the Michigan Senate Victory Fund ("MSVF"), a joint fundraising committee which filed 48-Hour Notices regarding seventy-nine of the contributions. Such reporting, however, does not satisfy the requirements of section 434(a)(6)(A), which requires principal campaign committees to file 48-Hour Notices disclosing contributions received shortly before an election. Further, the MSVF 48-Hour Notices did not include the name of the candidate and office sought as required by section 434(a)(6)(A).

Therefore, this Office recommends that the Commission find probable cause to believe that the Friends of Bob Carr and Bob Carr, as treasurer, violated 2 U.S.C. § 434(a)(6)(A) by failing to report campaign contributions of \$1,000 or more, received after the 20th day, but more than 48 hours before the general election, within 48 hours of receipt of the contributions.



This case has proceeded to probable cause, apparently because the Office of General Counsel ("OGC") concluded that negotiations had run on too long. The report of the General Counsel identifies the only issue of consequence remaining, and it is a legal issue.

In short, the question is: if a joint fundraising committee receives contributions subject to reporting on a 48-hour basis, and reports them on that basis, do the regulations of the FEC require that the candidate committee, on whose behalf of the reports were filed, also report them on the same 48-hour basis.

The General Counsel insists that the double counting is required. The Carr Committee disagrees. The regulations establish clearly the reporting obligations of political committees that receive transfers from joint fundraising representatives. Those regulations, appearing at 11 C.F.R. § 102.17, set out procedures for "reporting of receipts and disbursements." 11 C.F.R. § 102.17(c)(8). Of particular importance is the requirement that the joint fundraising representative report all contributions "in the reporting period in which they are received." By contrast, the "participant political committee," on whose behalf the contributions were received is required to report its share of net proceeds received as a "transfer in" and also, in an accompanying


Schedule A, an itemization of contributions "to the extent required under 11 C.F.R. § 104.3(a)."

In summary, the regulations place the responsibility for reporting of contributions within the relevant reporting period on the fundraising representative, not the participating candidate committee. The same requirement is not placed on the candidate committee, because the objective of timely public disclosure is fully served by the reporting of the committee's agent, the fundraising agent, which as a matter of public record is raising the money for the participating candidates.

Once the fundraising representative has made the 48-hour report, there is no need — and the regulations clearly indicate, no requirement — specifications for duplicative reporting on the same 48-hour basis by the participating committee candidate. The candidate committee's obligations are clearly established by regulation — the reporting of the transfer-in and itemization in accordance with the requirements of § 104.3(a).

These regulations were designed to set out in clear terms the relative reporting and other responsibilities of the candidate and joint fundraising committees or representatives. The rule articulated by the Office of General Counsel, requiring duplicative 48-hour reporting by the candidate committees, is not supported by the regulation. The OGC does not cite any support, or acknowledge the issue — it merely states its belief about what the rule is, without support or justification.

GENERAL COUNSEL'S REPORT

I. BACKGROUND

The Friends of Bob Carr Committee and Bob Carr, as treasurer, ("the Committee") failed to file one hundred fifty-four (154) 48 Hour notifications for contributions totaling \$164,000 received shortly before the 1994 general election. On March 8, 1996, the Commission voted to find reason to believe that the Committee violated 2 U.S.C. § 434(a)(6)(A) and entered into pre-probable cause conciliation. In response, counsel disputed the number of contributions not reported by 48 Hour Notice. This Office examined the Committee's reports and slightly adjusted the number of such contributions. Counsel also asserted that the Committee had in fact filed a number of the missing notices. Documents submitted by counsel, however, indicate that the Committee filed the notices in February 1995, several months after the 1994 election. On May 9, 1996, this Office sent a probable cause brief to counsel, who responded on May 22, 1996. This Office now recommends that the Commission find probable cause to believe that the Committee violated 2 U.S.C. § 434(a)(6)(A).

II. ANALYSIS

Counsel's May 22, 1996, response ("reply brief") focuses exclusively on the Commission's joint fundraiser regulations at 11 C.F.R. § 102.17 and ignores the statutory requirement governing

the Committee's 48 Hour Reporting.¹ See 2 U.S.C. § 434(a)(6). Counsel for the first time asserts that the regulations "establish clearly the reporting obligations of political committees that receive transfers from joint fundraising representatives." Counsel specifies that the regulations place reporting responsibility within the relevant reporting period on the fundraising representative, Michigan Senate Victory Fund, and not the participating candidate committee, Friends of Bob Carr. Under counsel's scenario,

Once the fundraising representative has made the 48-hour report, there is no need -- and the regulations clearly indicate, no requirement -- specifications for duplicative reporting on the same 48-hour basis by the participating committee candidate [sic]. The candidate committee's obligations are clearly established by regulation -- the reporting of the transfer-in and itemization in accordance with the requirements of § 104.3(a).

Counsel's reliance on the regulations is misplaced. It is the statute that establishes the reporting obligations of candidate committees. Section 434(a)(6)(A) explicitly imposes upon candidate committees the duty to file 48 Hour Notices for contributions received shortly before an election. This requirement equally applies to "transfers-in" from joint fundraisers. Further, and of particular importance here, section 434(a)(6)(B) provides that the notification required under section 434(a)(6) "shall be in addition to all other reporting requirements under this Act." [Emphasis added]. Thus, under the Act, it is the principle campaign committee of a candidate that is required to file 48 Hour Notices. By contrast, there is no statutory or regulatory requirement that joint fundraising representatives file 48 Hour Notices. The joint fundraiser regulations do not shift a candidate committee's reporting obligations on to the fundraising representative, but rather set out the timing of the fundraising representative's reporting: that it "shall report all funds received in the reporting

¹ As noted in the General Counsel's Brief, of the 154 contributions to the Committee, 117 were transfers from the Michigan Senate Victory Fund, a joint fundraising committee which filed its own 48 Hour Notices for 79 of the contributions.

period in which they are received." 11 C.F.R. § 102.17(c)(8)(i)(A). Contrary to counsel's assertions, it is the joint fundraising representative's 48 Hour Notice reporting that is the "duplicative reporting."

In sum, the reply brief relies on the joint fundraising regulations in a manner that appears to eliminate the statutory 48 Hour reporting requirement. Further, the reply brief makes no mention of the contributions received directly by the Committee for which the Committee failed to file 48 Hour Notices. Therefore, this Office recommends that the Commission find probable cause to believe the Friends of Bob Carr Committee and Bob Carr, as treasurer, violated 2 U.S.C. § 434(a)(6)(A).

III. DISCUSSION OF CONCILIATION AND CIVIL PENALTY

IV. RECOMMENDATIONS

1. Find probable cause to believe that Friends of Bob Carr and Bob Carr, as treasurer, violated 2 U.S.C. § 434(a)(6)(A).
2. Approve the attached conciliation agreement and appropriate letter.





On October 21, 1996, the Federal Election Commission accepted the signed conciliation agreement submitted on your clients' behalf in settlement of a violation of 2 U.S.C. § 434(a)(6)(A), a provision of the Federal Election Campaign Act of 1971, as amended. Accordingly, the file has been closed in this matter.

The confidentiality provisions at 2 U.S.C. § 437g(a)(12) no longer apply and this matter is now public. In addition, although the complete file must be placed on the public record within 30 days, this could occur at any time following certification of the Commission's vote. If you wish to submit any factual or legal materials to appear on the public record, please do so as soon as possible. While the file may be placed on the public record before receiving your additional materials, any permissible submissions will be added to the public record upon receipt.

Information derived in connection with any conciliation attempt will not become public without the written consent of the respondent and the Commission. See 2 U.S.C. § 437g(a)(4)(B). The enclosed conciliation agreement, however, will become a part of the public record.

CONCILIATION AGREEMENT

This matter was initiated by the Federal Election Commission ("Commission"), pursuant to information ascertained in the normal course of carrying out its supervisory responsibilities. The Commission found probable cause to believe that Friends of Bob Carr and Bob Carr, as treasurer ("Respondents"), violated 2 U.S.C. § 434(a)(6)(A).

NOW, THEREFORE, the Commission and the Respondents, having participated in informal methods of conciliation, prior to a finding of probable cause to believe, do hereby agree as follows:

I. The Commission has jurisdiction over the Respondents and the subject matter of this proceeding.

II. Respondents have had a reasonable opportunity to demonstrate that no action should be taken in this matter.

III. Respondents enter voluntarily into this agreement with the Commission.

IV. The pertinent facts in this matter are as follows:

1. Friends of Bob Carr is a political committee within the meaning of 2 U.S.C. § 431(4), and is the authorized principal campaign committee for Bob Carr's 1994 senate campaign.

2. Bob Carr is the treasurer of the Friends of Bob Carr committee.

3. Michigan Senate Victory Fund ("MSVF") was a joint fundraising committee supporting Friends of Bob Carr and other congressional candidates.

4. The Federal Election Campaign Act of 1971, as amended ("the Act"), requires principal campaign committees of candidates for federal office to notify in writing either the Secretary of the Senate, the Clerk of the U.S. House of Representatives or the Commission, as

appropriate, and the Secretary of State, of each contribution totaling \$1,000 or more, received by any authorized committee of the candidate after the 20th day but more than 48 hours before any election. 2 U.S.C. § 434(a)(6)(A). The Act further requires notification to be made within 48 hours after the receipt of the contribution and to include the name of the candidate and office sought, the date of receipt, the amount of the contribution, and the identification of the contributor. *Id.* The notification of these contributions shall be in addition to all other reporting requirements. 2 U.S.C. § 434(a)(6)(B).

5. Among the contributions that the Respondents received between October 20, 1994 and November 5, 1994, there were one hundred fifty-four (154) contributions of \$1,000 or more totaling \$164,500 for which the Respondents did not submit 48 Hour Notices. Thirty-seven (37) contributions were made directly to Respondents. One hundred seventeen (117) contributions came through the MSVF.

6. For the 37 contributions made directly to Respondents, in response to a Commission Request For Additional Information Respondents filed 48-Hour Notices on February 10, 1995. Under the Act, the 48-Hour Notices were required to be filed between October 20 and November 5, 1994. 2 U.S.C. § 434(a)(6)(A).

7. Commission records indicate that the MSVF provided 48-Hour Notices for 79 of the 117 contributions made through the MSVF to the Friends of Bob Carr Committee. Such reporting does not satisfy the requirements of 2 U.S.C. § 434(a)(6)(A), which provides that principal campaign committees shall file 48-Hour Notices disclosing contributions received shortly before an election.

V. The Respondents failed to report campaign contributions of \$1,000 or more received after the 20th day, but more than 48 hours before the general election, within 48 hours of receipt of the contributions, in violation of 2 U.S.C. § 434(a)(6)(A).

VI. Respondents will pay a civil penalty to the Federal Election Commission in the amount of Eleven Thousand dollars (\$11,000), pursuant to 2 U.S.C. § 437g(a)(5)(A).

VII. The Commission, on request of anyone filing a complaint under 2 U.S.C.

§ 437g(a)(1) concerning the matters at issue herein or on its own motion, may review compliance with this agreement. If the Commission believes that this agreement or any requirement thereof has been violated, it may institute a civil action for relief in the United States District Court for the District of Columbia.

VIII. This agreement shall become effective as of the date that all parties hereto have executed same and the Commission has approved the entire agreement.


IX. Respondents shall have no more than 30 days from the date this agreement becomes effective to comply with and implement the requirements contained in this agreement and to so notify the Commission.

X. This Conciliation Agreement constitutes the entire agreement between the parties on the matters raised herein, and no other statement, promise, or agreement, either written or oral, made by either party or by agents of either party, that is not contained in this written agreement shall be enforceable.
