On July 20, 1999, in considering the General Counsel's Report in this matter dated July 12, 1999, the Commission found reason to believe that Daniel M. Doyle knowingly and willfully violated 2 U.S.C. §§ 441a(a)(1)(A) and 441f. At that time, the Commission instructed this Office to make certain revisions to the Factual and Legal Analysis and Conciliation Agreement for Mr. Doyle which had been attached to the General Counsel's Report. The Factual and Legal Analysis was to be revised to include references

The attached documents contain these revisions. Given the unusual circumstances involved, the letter to be sent to Mr. Doyle is also attached for the Commission's review.
