- III. BACKGROUND:

Failure to File Forty-Eight Hour Notifications

The Feingold Senate Committee ("the Committee") has failed to file the required Forty-Eight (48) Hour Notifications ("48-Hour Notices") for 41 contributions totaling \$54,726.73 received prior to the 1998 General Election.

The candidate was involved in the General Election held on November 3, 1998. Prior Notice was sent to the Committee on September 30, 1998 (Attachment 2). The Notice includes a section titled "48 Hour Notices on Contributions". This section reads "Notices are required if the committee receives contributions (including in-kind gifts or advances of goods or services; loans from the candidate or other non-bank sources; and guarantees or endorsements of loans to the candidate or committee) of \$1,000 or more, during the period October 15 through October 31. The notices must reach the appropriate federal and state filing offices within 48 hours of the committee's receipt of the contribution(s)."

On January 20, 1999, a Request for Additional Information ("RFAI") was sent to the Committee (Attachment 4). The RFAI notes on an informational basis that the Committee may have failed to file one or more of the required 48-Hour Notices for "last minute" contributions of \$1,000 or more. The notice requests the Committee to review their procedures for checking contributions received during the aforementioned time period. In addition, the notice states that although the Commission may take legal steps, any response would be taken into consideration.

The Committee's response dated January 31, 1999 does not adequately address the failure to file 48-Hour Notices. The response dated March 15, 1999 does address this issue. The Committee states that, "Although there is a possibility that some of these contributions were included in a 48 hour report which failed to reach the Commission, . . . all or most of these contributions were apparently omitted inadvertently from the 48 hour reporting process". The Committee further explains that, "This oversight may have resulted from a lapse in communication between two of the Committee's offices. In October of 1998, the contributions were processed in one office, while the 48 hour reports were generated in a different office at a separate location. Since that time, the fundraising office of the Committee has been consolidated to one office for all operations, lessening the chance of miscommunication. Accordingly, the Committee has taken actions to ensure that the situation that caused this reporting problem cannot be repeated" (Attachment 5).

All 1998 general election principal campaign committees of congressional candidates (including unopposed candidates) who seek election in the November 3, 1998, General Election must file the Pre- and Post-General Election Reports. If the campaign has an authorized committee(s), in addition to the principal campaign committee, the principal campaign committee must also file a consolidated report on Form 3Z and attach the report(s) of the authorized committee(s).

48 HOUR NOTICES ON CONTRIBUTIONS

Notices are required if the committee receives contributions (including in-kind gifts or advances of goods or services; loans from the candidate or other non-bank sources; and guarantees or endorsements of loans to the candidate or committee) of \$1,000 or more, during the period October 15 through October 31.

The notices must reach the appropriate federal and state filing offices within 48 hours of the committee's receipt of the contribution(s). U.S. House candidates faxing 48-hour notices should transmit them to the FEC at 202/219-0174. Senate candidates should transmit them to the Secretary of the Senate at 202/224-1851. Note that 48-hour notices are the only FEC documents that may be faxed.

*These dates indicate the beginning and the end of the reporting period. A reporting period always begins the day after the closing date of the last report filed. If the committee is new and has not previously filed a report, the first report must cover all activity that occurred before the committee registered.

** Reports sent by registered or certified mail must be postmarked by the mailing date; otherwise, they must be received by the filing date.

ELECTRONIC FILING

Political committees have the option of filing electronically. If you are interested in this option, review the enclosed handout entitled "Electronic Filing of Disclosure Reports," and call the Data Division at (800) 424-9530 or (202) 694-1250.

COMPLIANCE

Treasurers of political committees are responsible for filing all reports on time. Failure to do so is subject to enforcement action. Committees filing illegible reports or using non-FEC forms (except for FEC approved computer generated forms) will be required to refile.

This letter is in further response to your January 20, 1999 letter prompted by the Commission's preliminary review of the 30 Day Post-General Report (10/15/98-11/23/98). In that letter, you informed the Committee that: 1) six contributions were reported on 48 hour notices and then did not appear on schedule-A of the Post-General report, 2) some contributions appeared to exceed the federal limits on contributions and, 3) that there may be missing 48 hour notices for contributions in the amount of \$1000 or more each, based on the fact that not all such contributions on the 1998 Post-General Election Report had matching 48-hour reports.

ISSUE ONE

In a letter dated January 31, 1999, the Committee addressed the omissions on schedule-A of the Post General Report. (The January 31, 1999 response (*attachment #1*) and 48 hour reports dated October 23, 24 & 28, 1998 are attached (*attachment #2*).) The January 31 letter from the Committee also suggested that henceforth the Committee would notify the

Commission of contributions which are received and then returned before being deposited. Obviously, it makes sense to do this only if the Commission would find such notification helpful. We would appreciate your guidance as to whether the Commission would like such notification. The Committee hopes that its response of January 31, 1999 was adequate in addressing the concern about contributions which were disclosed on 48 hour reports, but not on schedule-A of the Post-General report.

ISSUE TWO

As to the issue of apparently excessive contributions, questions were asked about contributions from Henry Lord, Ruth Lord and Mary Pennock.

The appearance of excessive contributions in the cases of Henry Lord and Ruth Lord was created because the Committee reported these two contributions incorrectly. The contributions were made through a conduit, and although it may appear that contributions were excessive, they simply needed to be reported accurately as appropriate conduit contributions. The Committee mistakenly reported the same contributions twice on the schedule-A portion of the 1998 Post-General report. (The only checks from the Lords received by the Committee (*attachment #3*), the schedule-A form which was previously filed (*attachment #4*), and an amendment explaining the Lord's contributions (*attachment #5*), which should have been sent previously, are attached. Also attached is a corrected schedule-A form which correctly reports other conduit contributions as they should have appeared on schedule-A of the 1998 Post-General Election Report (*attachment #6*).) The Committee understands the need to report conduits accurately, and correctly reported conduits on the 1998 Year End Report, which was due on, and filed by, January 31, 1998. (Attached are copies of several pages of the 1998 Year End Report with conduit contributions as they are now reported by the Committee (*attachment #7*).)

The \$250 contribution from Mary Pennock received by the Committee on October 27, 1998 put her \$200 over the \$1,000 limit on contributions for the 1998 General election. At the time of her contribution, the Committee inadvertently failed either to refund \$200 to Ms. Pennock or to seek Ms. Pennock's permission in redesignating the additional \$200 for the 2004 Primary election. At this time, the Committee has refunded \$200 to Ms. Pennock, and has taken measures to ensure this mistake will not occur in the future. (A copy of Ms. Pennock's contributions filed by the Committee (*attachment #8*), the \$200 refund check and refund form is attached (*attachment #9*).) The Committee understands the importance of federal limits on contributions.

The Committee is also carefully examining all of our contributions to check for the possibility of any additional excessive contributions. Because this process is time consuming, the Committee will contact the Commission as soon as possible in a follow-up correspondence to notify the Commission if any other mistakes are located. We have also corrected our method of reporting conduits under the direction of the Commission; and we are also carefully reviewing and consolidating the procedures for processing contributions.

ISSUE THREE

Finally, let me address the concern of certain 48 hour reports which were not and should have been filed. While the Committee correctly reported all the contributions in question on the schedule-A portion of the 1998 Post-General Election Report, a number of the contributions were inadvertently not reported under the 48 hour report requirement for the final weeks of October 1998. Although there is a possibility that some of these contributions were included in a 48 hour report which failed to reach the Commission, (The October 17, 1998 48 hour report is attached (*attachment #10*).) all or most of these contributions were apparently omitted inadvertently from the 48 hour reporting process.

(The 48 hour reports which should have been prepared and sent in a timely manner are also attached, dated March 11, 1999 (*attachment #11*).) The Committee sincerely apologizes for these omissions, recognizing and respecting the importance of the 48 hour disclosure requirement. As you recommended, the Committee's procedures for filing the 48 hour notices have been reviewed and the Committee has taken action to ensure that the problem will not be repeated.


For your information, it appears that the problem largely resulted from an internal lapse in communication in the context of the Committee's effort to abide by Senator Feingold's voluntary pledges to limit the amount of out-of-state and PAC contributions which his campaign received to certain maximum percentages of the campaign's total receipts. As you will note, most of the contributions in question were either PAC contributions or out-of-state contributions, and therefore were not always immediately accepted by the campaign in order to ensure Senator Feingold's pledges were never violated. In other words, sometimes contributions were not deposited for a brief period of time, as permitted under federal law, given that they might have had to be returned if they would put the Feingold Senate Committee out of compliance with Senator Feingold's fundraising instructions.

The omissions apparently occurred when these checks were ultimately deposited and the relevant campaign staff simply failed to file the 48 hour notices that had been filed for other contributions. This oversight may have resulted from a lapse in communication between two of the Committee's offices. In October of 1998, the contributions were processed in one office, while the 48 hour reports were generated in a different office at a separate location. Since that time, the fundraising office of the Committee has been consolidated to one office for all operations, lessening the chance of miscommunication.

Accordingly, the Committee has taken actions to ensure that the situation that caused this reporting problem cannot be repeated. The Feingold Senate Committee would like to thank the Commission for bringing these serious matters to its attention and giving us the opportunity to respond.

- 2) Helen Dinelum Jack. Ms. Dinelum Jack's contribution was returned, and not deposited, so it was not reported on the Post General Report.
- 3) Abbey, Gardy, Squitieri. This contribution was not from Abbey, Gardy, Squitieri. On the 48-hour report, the name was incorrectly reported. The contribution was from Jay Jacobs, and was reported on page 178 of the Post General Report.
- 4) James Shulman. Mr. Shulman's contribution was returned, and not deposited, so it was not reported on the Post General Report.
- 5) Tom C Young. Mr. Young's contribution was returned, and not deposited, so it was not reported on the Post General Report.
- 6) Human Rights Campaign PAC. This PAC contribution was returned, and not deposited, so it was not reported on the Post General Report.

As you recommended, the Committee's procedures for checking contributions received during the "48-hour" time period have been reviewed. In the future, in the interest of complete disclosure, the committee will take the additional step of notifying the Commission in writing when a contribution is received and then returned before being deposited.
