GENERAL COUNSEL'S REPORT #2

I. ACTIONS RECOMMENDED

Accept the counterproposed conciliation agreement as signed by the Respondents and close the file.

II. BACKGROUND

On November 30, 1999, the Commission found reason to believe that the Northeast Utilities Employees' Political Action Committee ("NUEPAC" or the "Committee") and Jennifer L. Diggins, as treasurer (collectively, the "Respondents") violated 2 U.S.C. § 434(b) by failing to report non-federal receipts and disbursements to the Commission from 1995 through the 1998 April Quarterly reporting period. The Commission simultaneously determined to offer to enter into pre-probable cause conciliation with the Respondents prior to a finding of probable cause to believe and approved a conciliation agreement containing a civil penalty

stated herein, the Office of General Counsel recommends that the Commission accept this counterproposed conciliation agreement and that it close the file in this matter.


IV. RECOMMENDATIONS
