I. ACTIONS RECOMMENDED

II. BACKGROUND

On December 7, 1999, the Commission found reason to believe that City Political Action Committee and Matthew G. Mitzen, as treasurer ("Respondents"), violated 2 U.S.C. §§ 434(a)(4)(i),(ii) and (iv) by failing to timely file their 1997 Mid-Year, 1997 Year End, 1998 April Quarterly, 1998 July Quarterly, 1998 12 Day Pre-General and 1998 Year End Reports. The Commission simultaneously determined to offer to enter into pre-probable cause conciliation with the Respondents and approved a conciliation agreement

III. DISCUSSION
