Dear Ms. Smith:

Our firm represents respondent Florida Democratic Party in the above-captioned MUR. A Statement of Designation of Counsel is attached hereto.

Please be advised that "Florida Democratic Victory 2004" is not a separate entity or organization of any kind, but simply a project name utilized by the Florida Democratic Party. Accordingly, "Florida Democratic Victory 2004" should not be treated as a separate respondent and will not be separately represented in this matter.

The Florida Democratic Party received the Complaint in this matter on November 8, 2004, only a few days after the 2004 General Election. As is usual at this time, the State Party is experiencing significant staff turnover. A number of senior staff involved in the Florida Democratic Victory 2004 project are in transition or on vacation. In addition, the files and records from this election cycle are still being collected and organized.

In these circumstances, it will be impossible to prepare a meaningful response to the Complaint within 15 days. Accordingly, the Florida Democratic Party requests an extension of twenty (20) days in which to respond to the Complaint.

If this request for extension is granted, the response would be due on December 13, 2004.


