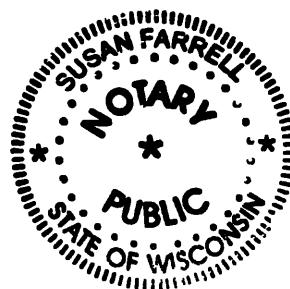

seign has no disclaimer on it.

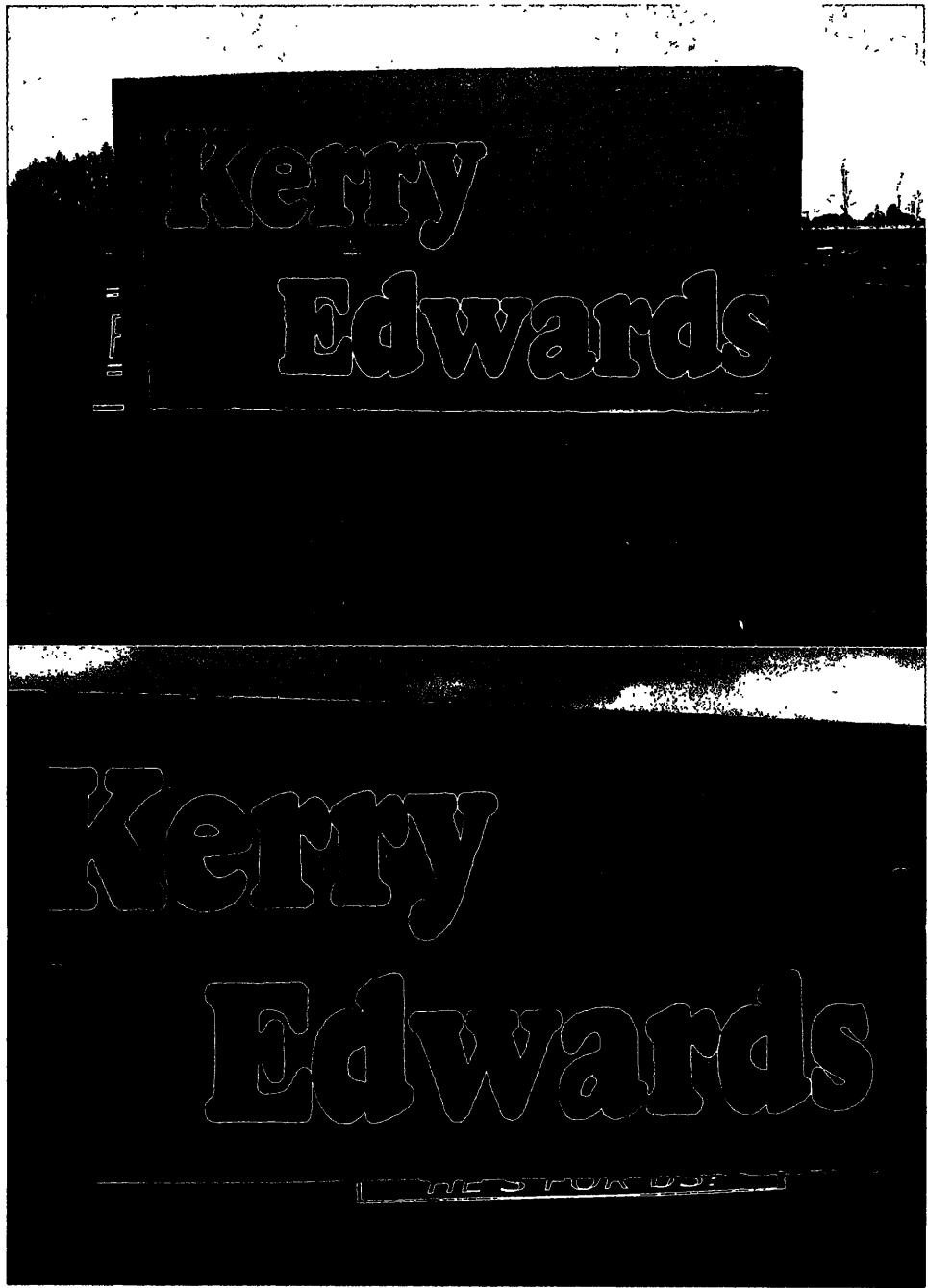

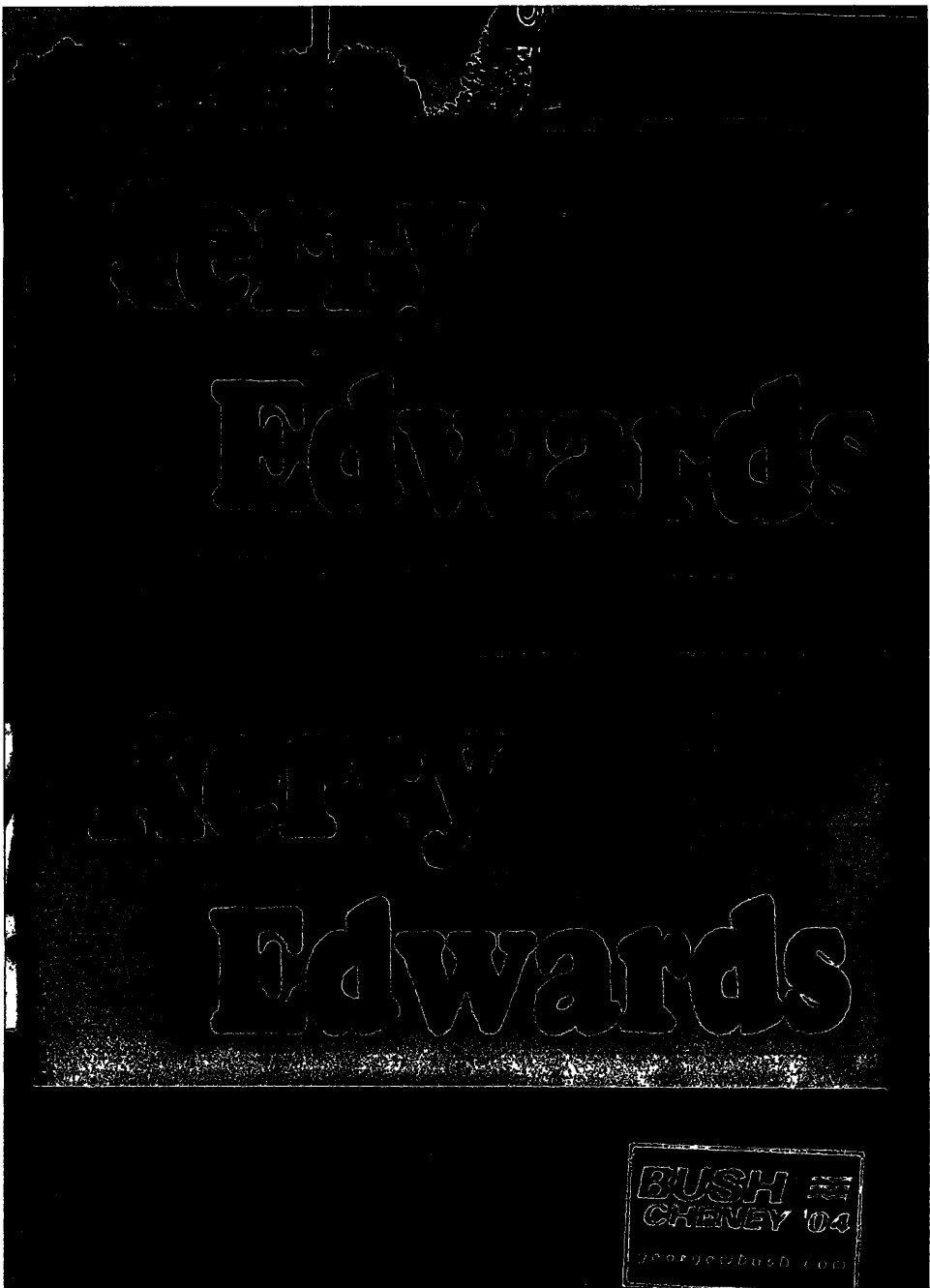

Hwy 27 South

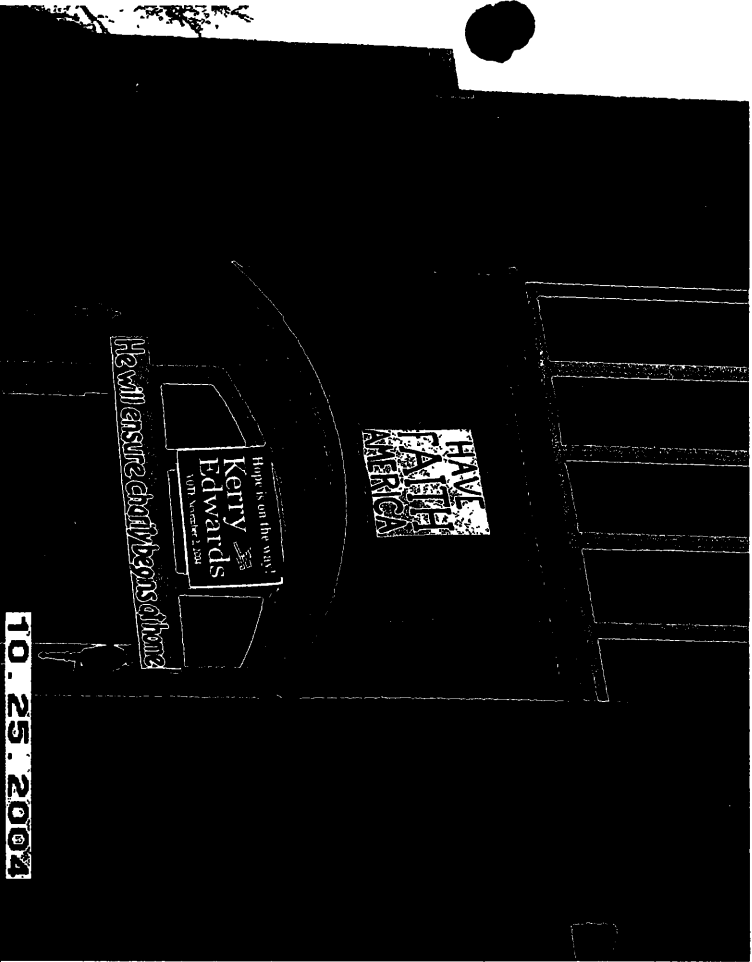
Hwy 27 North

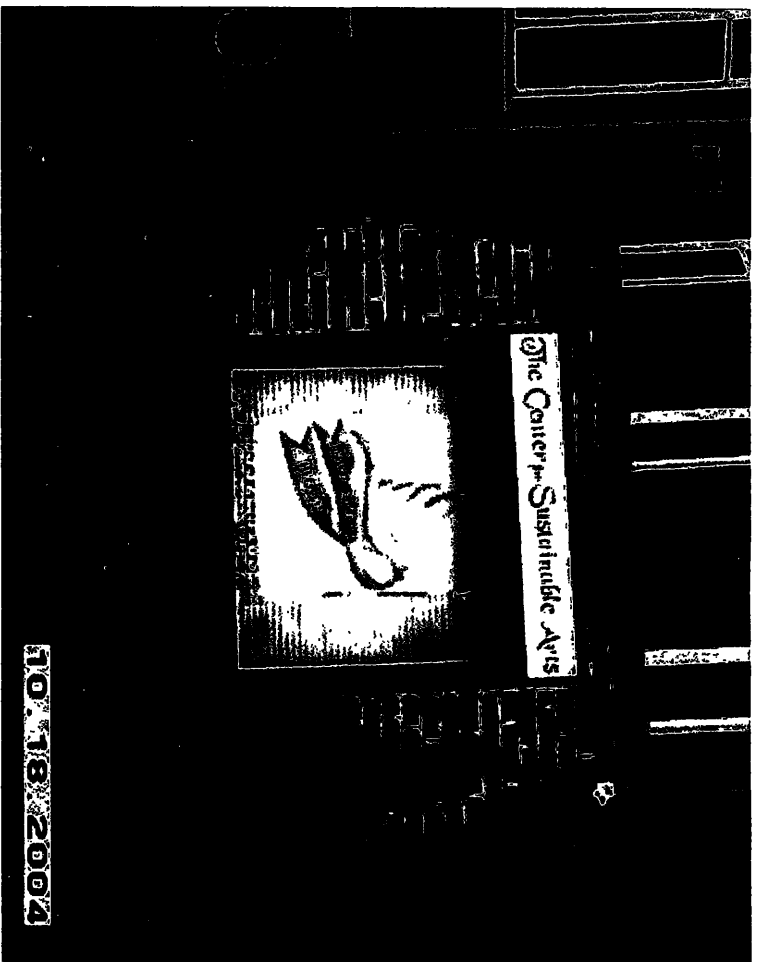
Hwy 8 west

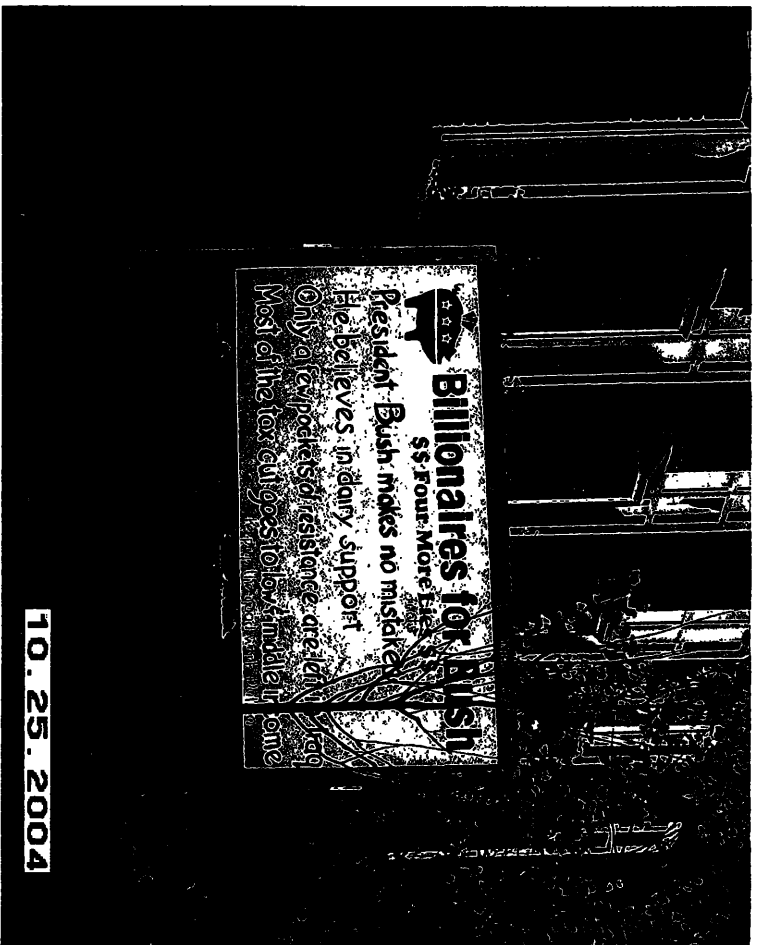
