On or about June 5, 2006 an investigation by the Trumbull County Board of Elections began in regard to irregularities contained in the nominating petition for the independent candidacy of Randy D. Walter for the Ohio 17th Congressional District.

During the investigation several occurrences of apparent election falsification, a felony of the fifth degree, by petition circulators were uncovered and referred to the Trumbull County Prosecutor. Also brought to light in the investigation were apparent illegal campaign contributions that occurred in an earlier campaign by Randy D. Walter.

An interview occurred in the office of the Trumbull County Prosecutor on June 21, 2006 where the following discussion took place between assistant county prosecutors and Mr. Patrick Vanetti who kept the books for Mr. Walter's campaign for Ohio's 17th Congressional District in 2000:

Q: Do you know anything else about any deficient petitions or election chicanery that we haven't talked about, either this time or historically?

A: Even six years ago?

Q: Yes.

A: Yeah. I, uh... Randy had told me that, back than I was handling all the money that came in...

Q: This was six years ago?

A: Yeah, and uh, there was times that I was given cash and told to uh, find people's names to put it under.

Q: So you were the treasurer for his campaign in essence?

A: I was not the treasurer. His sister was actually put down as the treasurer. I was the one that handled all of the checks coming in, all of the cash coming in.

Q: Do you have any idea how much cash you were given?

A: I remember times where I was given \$1000 in cash. I believe you were only allowed to put up to, uh \$60 per, um, per person in cash or, uh, under \$100 was the most. I don't remember what it was.

Q: What names did you use?

A: He told me to pick names. He said put your relatives or do whatever so.

Q: Ok, so that's what I'm asking you, what names did you use?

A: Yeah, I think I put, I put down some of my relatives. I think I put my brothers and sisters and my parents and...

Q: If we showed you a list of his campaign contributions from six years ago do you think that that might help?

A: Yeah. I can tell you anyone from my family and there might have been some people from work that I had asked them if I could put their names down.

Q: This question will be a little more specific.

A: Ok.

Q: He gave you certain amounts of money...

A: Yes.

Q: that, are we to assume were donations...

A: Yes.

Q: or he wanted you to justify them as donations on the books?

A: He wanted me to justify them as donations on the books.

Q: So you think this was his own money

A: I don't, that I don't know.

Q: You don't know where this money came from.

A: Right. I don't know, have any idea where the money came from.

The above exchange is contained in the enclosed tape towards the end of side A. It is respectfully submitted that the information revealed therein demonstrates violations of federal election law including but not limited to 2 USCS § 441f and 2 USCS § 441g.
