Respondents"), approve the appropriate letters, and close the file.

II. BACKGROUND

On September 12, 2006, the Commission found that there is reason to believe Planned

Parenthood Action Fund, Inc. PAC and Chris Korsmo, in her official capacity as Treasurer,

violated 2 U.S.C. §§ 434(b) and 441b, and that Planned Parenthood Action Fund, Inc. and

Planned Parenthood Federation of America violated 2 U.S.C. § 441b

attached proposed global conciliation agreement, close the file, and approve the appropriate letters.


IV. RECOMMENDATIONS

3. Close the file.


