Dear Mr. Jordan:

This law firm represents the Committee to Elect Mike Boyce (the "Committee") in connection with all matters before the Federal Election Commission (the "FEC"). On behalf of the Committee, this letter responds to your letter dated April 30, 2008, concerning a complaint filed against the Committee by Mike Waddell (the "Complaint").

Citing the Committee's April 15, 2008 Quarterly Report, the Complaint alleges that the Committee accepted an improper in-kind contribution from a corporation, Lensaj Inc. The Committee acknowledges that it accepted a contribution from this entity. The Committee denies, however, that it was aware at the time that the contributor was a corporation.¹

As the Complaint itself acknowledges, Lensaj, Inc. does business under the name "Lensaj Marketing and Promotions." There is obviously no "Inc." in this name. The invoice received from this entity was also entitled in the name of "Lensaj Marketing and Promotions." In light of these facts, the Committee and its treasurer quite simply did not realize that this entity was a corporation. In good faith compliance with FECA, the Committee properly calculated the amount of the in-kind contribution, and it timely and accurately disclosed the contribution on its quarterly report.

Please note that, on its own initiative, the Committee is issuing a check in the amount of \$819.00 to Lensaj, Inc. to pay for the services provided to the campaign. Upon request, a copy of

this check will be provided to the FEC. Please also note that Michael Boyce, a retired United States Marine Corps colonel who served his country in Iraq and was running for office for the first time, has withdrawn from the race for Congress and intends to terminate the Committee shortly.

In light of the facts that the Committee did not realize that this was a corporate contribution; the Committee fully disclosed the contribution; the contribution is being refunded; the candidate at issue was running for office for the first time; and the Committee is terminating operations, it is respectfully suggested that his matter should be dismissed without further action by the FEC.
