
As I mentioned to you, it is possible that additional or substitute counsel will enter appearances on behalf of one or more of the respondents prior to the submission of formal responses to the complaint.

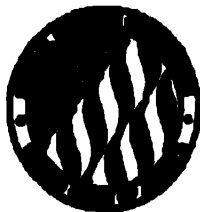

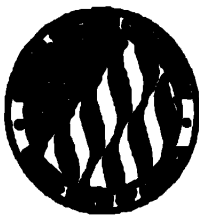

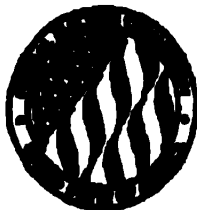
