Dear General Counsel:

The instant letter shall serve as the undersigned's formal response to the complaint filed by one Ernest Pagenel. In connection thereto, we are enclosing the Statement of Designation of Counsel.

By way of background, the Respondent would submit to the Commission that Mr. Pagenel was a well known operative of the Rudolph "Rudy" Moise for Congress committee. Mr. Pagenel, who is a good friend of the undersigned has since stated to several individuals including the undersigned that he did not file this complaint and that his signature was forged. In any event, until he formally withdraws this complaint, the undersigned would submit that the complaint was filed in bad faith, whether by Mr. Pagenel or an imposter, in that the alleged billboard was not a billboard; it was simple a vinyl banner hoisted onto the top floor of a vacant building.

In addition, the expenditures for the banner in question were not due to be filed until the pre-primary report due on August 3, 2010. That the complainant filed the complaint, before the said report was due further demonstrates bad faith. The expenditure for the said banner was duly listed in the pre-primary report, which has since been filed with the commission. Attached herewith, please find the copy of the invoices for the same.

With regard to the end of year report for the year ending in 2009, please note that we have filed the same on in early 2010. For some reason, and as confirmed in our various telephone conversations with tech support, the said report was not uploaded into the FEC database. The ~~same~~ day the complaint was received, the undersigned spent upwards of 4 hours on the telephone with tech support in an attempt to address the uploading failure. With tech support's guidance, the undersigned undlosed and relosed the report to upload it. This procedure overwrote the original date the said report was initially completed. To date, the report shows a date of filing on the undersigned's computer. Enclosed, please find the copy of the latter's computer screen showing the status of the said report as filed. Because the file was still not showing that it was filed, the undersigned agreed to reenter the unitemized entries after the election. The undersigned would submit that the same will be filed by August 31, 2010.

Lastly, the undersigned would request that this complaint be dismissed as it was part of a strategy of an adversary to detract the undersigned's campaign. Further, the alleged complaint has denied filing it; the undersigned would, therefore, request that he be contacted to confirm the improper use of his name. More importantly, the complaint did not and could not point to any improprieties, the issues raised therein simply pointing to a report that was filed by the undersigned, although not officially uploaded into the FEC's database. Furthermore, the issue of the billboard was no issue at all, as borne out by the invoices in question. The undersigned would request a formal dismissal of the complaint for the reasons stated hereinabove.
