Pursuant to the Commission's rules, I, Sheldon Kadish, :
Sherman Oaks, California, 91423, file this complaint against Mark Reed and Mark Reed for
Congress (FEC#C00462317), a candidate for congressional office representing the California
27th Congressional District

I

Mark Reed for Congress has reported the receipt of thousands of dollars in cash
payments that exceed the Commission's limit of \$100 per donor.

In its pre-primary report filed on 7/14/10, Mark Reed for Congress annotates the word
"cash" next to the following contributions received (see Attachment "A")

In its July quarterly report filed on 7/15/10, Mark Reed for Congress annotates the word "cash" next to the following contribution received (see Attachment "B")

As donors are not permitted to contribute more than \$100 in cash to a congressional committee, the Commission should compel Mark Reed for Congress to return these excess cash contributions

II

Mark Reed for Congress failed to file finance reports by the Commission's deadlines. Mark Reed for Congress filed its first finance report on 7/14/10. That report indicates that on 4/6/2010 Mark Reed crossed the \$5000 threshold of cumulative contributions received. He reports the following contributions received by 4/6/10 (see Attachment "C")

Despite having received more than \$5000 in contributions as early as 4/6/2010, Mark Reed for Congress filed no finance reports until 7/14/2010. The committee specifically failed to file the pre-primary report due for California congressional candidates by 5/27/2010.

The committee's failure to file is particularly egregious in light of the fact that, despite actively raising and disbursing thousands of dollars, the committee deprived the voters of California's 27th District of access to this information before the Jan 8 Primary Election. Mark Reed was engaged in a contested Primary Election contest against an opponent who did file a pre-primary report.


The Commission should therefore find reason to believe that Mr. Mark Reed and Mark Reed for Congress have committed a violation of federal election laws and Commission rules by (1) accepting cash contributions from individual donors in excess of \$100 and (2) failing to file finance reports by the filing deadlines. The Commission should conduct an investigation and pursue necessary means to enforce federal elections law in this matter, and impose fines if applicable.

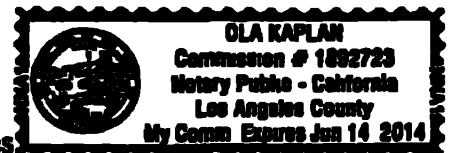
