Subject: Complaint against Robert Mittman/Mittman for Congress, Candidate for Member of Congress Democratic Party, New York State, District 6; FEC # C00521674.

Dear Mr. Herman:

My name is Elliot Arroyo of Brooklyn NY 11237. I am submitting this complaint against Robert Mittman ("Mittman") for violations of the Federal Election Campaign Act of 1971, as amended (the "Act"). Specifically, Mittman failed to disclose a debt to Elliot Arroyo and an expenditure to Port Motors Daily Rentals/ Cruise America.

Charges

*One- Mittman Failed to disclose a debt \$ 300 to me for working as the driver of the Campaign RV/ Mobile Office.*

*Two- Mittman Failed to disclose an expenditure, made by credit card of approximately \$3,800 to Port Motors Daily Rentals/ Cruise America of 1045 Northern Blvd Roslyn, New York, for rental of an RV used exclusively for campaign purposes on or about June 1, 2012- June 28, 2012.*

Mittman was, and is required to comply with the Act, and required to disclose both expenditures and any outstanding debt of his campaign committee to the FEC. On July 3<sup>rd</sup>, 2012 I personally went to Dr. Mittman's office on Bell Blvd. accompanied by Mr. Miguel Lopez who was also attempting to collect on monies due to him for campaign work. Mittman assured me he would pay but has made no attempt to pay the debt. Mittman was given numerous opportunities to make good on the debt to me, he still to this day has not paid me for my services despite his personal assurances that he would pay me for the work he recognized that I did. On August 20, 2012, I again visited Dr. Mittman at his office on Bell Boulevard to collect again he did not make payment. He has been a big disappointment for not paying what he owes despite promising he would. Mittman knowing that he had this debt to me failed to disclose this debt for services I rendered to him and his campaign to the FEC, a violation of the Act.

Mittman again violated the Act by not disclosing the expenditure to Port Motors Daily Rentals/Cruise America. That expenditure was charged to a credit card (non campaign, possibly his corporate credit card from his medical clinic) which he has not disclosed in his filings or amended filings with the FEC. This is a clear violation of the Act.

### BACKGROUND

On or about the on or about June 1, 2012 through June 28, 2012. Mittman requested that I drive (enclosed are pictures of Mittman Campaign RV/Mobile Office) the Campaign RV/Mobile Office. Parts of my responsibilities were to stage the RV which was used as a mobile campaign office. Here campaign workers were given assignments. The primary staging place was on Broadway and Baxter Street in Elmhurst Queens but we were also staged at different locations throughout the district. I also drove RV to various subways stations at 7:30 AM where at times Mittman would join me in leafleting train stations. Additionally, I would drive the RV to street fairs and debates. My work day usually ended at 9PM.

Of special note is that Mittman apparently reported the expenditures of the signs that were placed on RV/ Mobile Office (Signs & Letreros) but for some unknown reason has concealed the actual expenditure for the RV.

I am requesting that the Commission investigate this matter and take all appropriate actions.

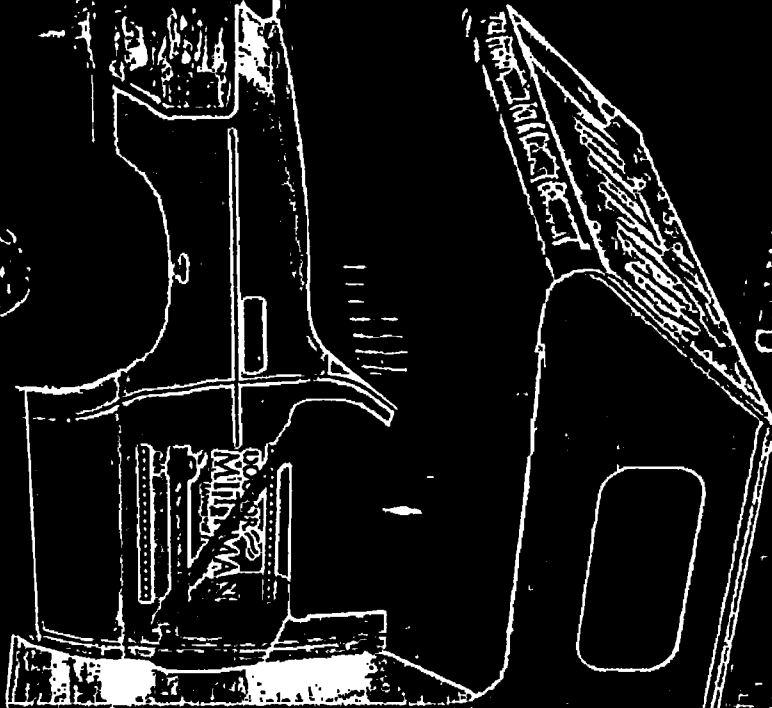
