Dear General Counsel,

It has come to our attention that the Delaware State GOP through it's executive director John Fluharty, has been distributing "public communications" that "clearly identified" our supported candidate Rose Izzo. This is a clear violation of the Federal Election Law. I am enclosing the records of the "public communications".

I am filing this addition to the amended complaint with the Federal Election Commission (FEC) because, according to the FEC Basic Rule, Political Committees must include a disclaimer on (1) all "public communications", (2) bulk electronic email and (3) web sites available to the general public, regardless of whether the communication expressly advocates the election or defeat of a clearly identified candidate.. & Individuals, a disclaimer must appear on any "electioneering communication".

Izzo wins ballot battle

MEDIA - Even though it was only the Primary Election, the Democrats in Delaware County can hang their hats on one victory over the powerful GOP.

Wednesday, April 28, 2004

Rose Izzo, who was kicked off of the Democratic ballot in March after her petitions were challenged by the Republican Party, easily won a write-in campaign for a spot on the November ballot against incumbent Republican Nicholas A. Micozzie in the 163rd district.

Micozzie tried to keep his opponent off the ballot a second time by sending letters to Democratic voters in Upper Darby, Lansdowne, Clifton Heights, Aldan and parts of Darby and Ridley Townships asking for them to write him in on the Democratic ticket.

In the letter, he told voters he appreciated the "left-handed" endorsement and that there wasn't a Democratic candidate opposing his re-election.

The Democratic voters felt otherwise.

izzo scored Micozzie, unofficially taking 60 percent of all the Democratic votes in the district. With the precincts yet to report, Izzo had an insurmountable 679-189 lead, according to county Democratic Party Chairman Clifford E. Wilson.

"Voters in Delaware County don't like to be told the game is over," Wilson said. "A smart candidate would have let (Izzo) go on her write-in campaign without making a noise. Let her get her 300 votes and deal with her in November. She wouldn't have gotten any attention, and she wouldn't be making headlines in the papers because the story would have been as dull as dishwater, but that's not what happened here."

Micozzie was slaughtered in Lansdowne 272-76 and in Izzo's hometown of Ridley Township 134-15. Micozzie even lost his own home precinct by a count of 29-15.

It was the first time Micozzie had ever tried such a tactic in his more than three decades of being an elected official in Delaware County.

A former Democrat while on Upper Darby Council, Micozzie hoped to utilize his friendship with many Democrats in Harrisburg to get the votes he needed.

Unfortunately for the representative, his efforts failed.

Izzo, 35, of Ridley Township, was removed from the ballot after a few of the signatures on her nomination petition were deemed illegal.

In 2003, Izzo was also hounded from a ballot, when she ran for County Council -- as an Independent Republican -- when she also had signature issues.

"I just feel great," said Izzo, a grin creeping from ear-to-ear. "I'm thankful to Cliff Wilson for having faith in me and to all the people of the Democratic Party who helped me in this victory. I'm ready and eager to go out there and make everyone in the 163rd District recognize my name."

Both Micozzie and Upper Darby GOP chairman John McNichol were unable to be reached for comment Tuesday night.

Wilson was especially excited by Izzo's victory, saying that it could cause her to gain some momentum in the district.

"Sometimes a win like this can create a lot of interest and momentum for a candidate and I think this has done just that," he said.

Wilson said that while the Democrats would still concentrate on all of their races countywide in November, that the Izzo-Micozzie contest could be the closest of them all, comparing it to the Tom Gannon - Sara Lynn Petrosky race in 2002.

"There's a famous incident from English history when (Oliver) Cromwell went into the parliament and said, 'get ye gone for you have sat too long,'" Wilson said. "Maybe, after 28 years, we need a new approach and a new identity in the 163rd district."


Her website states Rose "stands for Union Jobs." Read her comments that from the article "Labor Unions Rally Against Wal-Mart" written by Barbara Ormsby appearing in the Delaware County Times on September 12, 2004. She attended their rally:

Izzo said she is united with all the unions.


"I like unions," she said. "They keep the work place safe for the workers, they provide equal pay and opportunity for both men and women. Unions provide skilled workers to get the job done efficiently and effectively."



Micozzie, foe Izzo try for the 'write stuff'

State Rep. Nicholas A. Micozzie, R-163, has never faced an opponent in a primary election. Usually, he just sits back and waits to see who his Democratic opponent will be in November. However, after 14 years in office, Micozzie is hoping to see an unusual name opposing him on the ballot come November — his own.

With no "official" opponent on the Democratic ticket for the first time in his more than three decades in office, Micozzie felt it was time to reach out to his Democratic constituents and ask them to write his name on the Democratic candidate for the same seat.

"I'd just like to be on the Democratic ticket," said Micozzie. "I have a very good relationship with the Democrats in my district. I've been very responsive to their needs and secured them a lot of grant money. Micozzie will have Republican supporters at voting stations across his district armed with stamps and certificates on how Democrats could vote for him in a letter written to Democrats in his district," Micozzie said. "There is no Democratic candidate opposing my re-election. I have interpreted that as a left-handed endorsement at the least and maybe even an acknowledgment of a job well done."

What Micozzie failed to say is there is a Democrat interested in the race.

Rose Izzo, 31, of Rogers Township, is running a furious write-in campaign in an effort to get her name on the Democratic ballot in November.

Izzo, who was originally on the ballot as the Democratic candidate in the 163rd, saw her nomination petition voided after the GOP challenged the validity of some of the signatures on her petition. Now, with the support of the county Democratic party, Izzo is not only trying to secure the required 100 write-in votes to get back on the ballot, but also her own Micozzie, who wants there to be no evidence of Izzo's political aspirations when the General Election rolls around.

"Here we go again. The Republican bounce me off the ballot on a technicality," said Izzo, who was also removed from the Republican primary election for county council in 2003 for similar signature violations. "They know we were going to run as a write-in candidate anyway, so Micozzie does that so he doesn't have to have a race in November and the voters don't have a choice in November."

"I guess the Republicans are not afraid of Rose Izzo."

Micozzie admitted Izzo was influential in the decision.

"I've been running a write-in campaign for me to do the same," said Micozzie, who is reaching out to Democrats for the first time since he switched political parties early in his political career. "This happened to me before and I don't want it to happen again."

Micozzie was referring to the 1994 election when Democrats, after Had was removed from the ballot, but then gained 619 write-in votes to make the November ballot. "You never know in this business," said Micozzie. "That's why I've been as successful as I have for so long. — I leave no stone unturned. (People) say she has no shot. Well, I thought she had no shot either and look what happened then."

When Izzo, Rose's husband, who doubles as her campaign manager, said they were going to have plenty of Democrats writing the polls in order to get Izzo elected, she said: "We'll have people there that Democrats can identify with," he said. "We'll have actual Democrats and Republicans standing side-by-side."

Primary showdown set

GOP candidates with two distinct views vie for House seat

Delaware Republicans smoothed out almost all of the kinks in their statewide election ticket by their April convention in Rehoboth, putting forward a slate of candidates meant to unify a party crippled by a schism two years ago.

Candidates in the ballot-topping races for U.S. senator, governor and lieutenant governor rose without opposition, and a threatened challenge for the insurance commissioner nomination never materialized.

But one Republican statewide nomination, for Delaware's lone seat in the U.S. House of Representatives, will be decided in Tuesday's primary polling.

New Castle County Council President Tom Kovach, the party-endorsed candidate, faces far-right firebrand Anne Izzo, who unsuccessfully sought the Republican nomination for the U.S. House in 2010.

Kovach, a former state representative from Brandywine Hundred, won his seat in a special election last year. He is campaigning as a centrist Republican in the style of Mike Castle, a former Delaware governor and congressman.

He's refused to sign a pledge saying he'll never vote to raise taxes and said he won't lead the charge to repeal the 2010 health care reform law nicknamed Obamacare, favoring instead new measures to correct the parts of the law he disagrees with.

"The responsibility of this position is too great for me to play these political games. I have refused to say things to the right that I wouldn't say to the left, to the center," Kovach said. "I am not going to take extreme positions to satisfy what people call the base and handcuff myself when I'm serving as their representative."

Those stances have earned him a barrage of criticism from Izzo, who ~~blasts~~ blasts Kovach in several YouTube videos on her campaign website, labeling him a RINO — Republican in name only.

Izzo would not make herself available despite repeated attempts to schedule an interview. Her campaign manager and husband, Kevin Izzo, said she was too busy campaigning to speak with a reporter and would only communicate via email.

In an email, Izzo said Kovach is a product of the party machine who doesn't understand what conservative voters want in a representative.
