
Dear Mr. Jordan:

This office represents Every Republican Is Crucial (ERICPAC), Treasurer Melinda Fowler Allen, and Congressman Eric Cantor. Enclosed please find an executed Designation of Counsel form from each of our clients.

On May 10, 2013, our clients received your letters indicating that ERICPAC, its Treasurer, and Congressman Cantor may have violated the Federal Election Campaign Act of 1971, as amended. Counsel was away from the office and unable to attend to this matter – as was one of our clients – during the week since they received your letters. Accordingly, we will need more than the 15-day allotted time to confer with our clients and to compile an appropriate response. Therefore, we respectfully request a 20 day extension until June 17, 2013, to file a response.
