COMPLAINT

Complainant files this complaint under 52 U.S.C. § 30109(a)(1) against Allen Weh, Allen Weh for Senate and Rebecca Sanchez in her official capacity as Treasurer for Allen Weh for Senate (collectively, the "Weh Campaign") for violations of the Federal Election Campaign Act of 1971, as amended (the "Act"). As detailed below, the Weh Campaign has blatantly violated the Act and Federal Election Commission ("FEC" or "Commission") regulations by failing to disclose the full nature of payments that Mr. Weh has been making to unknown third parties for his campaign travel. While a candidate is permitted under the Act to spend his or her own money on campaign travel, the campaign must disclose who the candidate is paying. This is a fundamental issue of public transparency. Because the Weh Campaign has failed to meet its basic disclosure obligations, the voters of New Mexico are unable to determine who is flying Mr.

Weh around the state, whether he is traveling on corporate planes, and whether he is paying the correct amount for this travel as required by law. The FEC should promptly act to investigate the full scope of these reporting violations and ensure they cease immediately, determine whether the Weh Campaign has paid the correct amount for its campaign travel, and seek the appropriate financial penalties.

FACTS AND LEGAL ANALYSIS

Allen Weh is a candidate for the United States Senate in New Mexico and Allen Weh for Senate is his authorized campaign committee. Mr. Weh is also the current Chief Executive Officer of CSI Aviation.¹

The Weh Campaign's April 15, 2014 Quarterly Report, July 15, 2014 Quarterly Report and Pre-Primary report filed with the Commission collectively report eighty unreimbursed disbursements that were made by Allen Weh to pay for campaign airfare costs.² According to the reports, the aggregate value of these payments comes to well over \$70,000. However, not a single one of the eighty entries discloses the actual entities that received the money from Mr. Weh.

Under the basic disclosure rules of the Act, authorized committees must disclose disbursements made by candidates on their reports filed with the Commission just as they would disclose any other disbursements they make. *See* 52 U.S.C. § 30104(b)(4), (5), (6)(A); 11 C.F.R. § 104.3(b)(4). The Commission has explicitly stated that "out-of-pocket spending by candidates, as agents of their authorized committees, requires memo entry itemization of the ultimate payee if the aggregate amount of payments to that vendor exceeds \$200 for the election cycle." 78 Fed.

The Weh Campaign has failed to comply with this reporting obligation. In clear contrast to the Commission's examples, the entries by the Weh Campaign fail to include the memo entry detailing the payee.⁴ While it is impossible to tell from the reports filed by the Weh Campaign if the same payee received the money for each airfare disbursement, seventy nine of the eighty entries are *individually* reported as being for over \$200. Therefore, at a minimum, the Weh Campaign failed seventy nine times to properly disclose the name and address of the person or entity that received the payment from Mr. Weh. The Commission requires that the Weh Campaign disclose who Mr. Weh is paying for his travel, and it has not done so.

As a result of this failure to properly disclose the payee for the airfare expenses, it is impossible to tell not only who Mr. Weh paid, but whether the Weh Campaign has complied with the rules regarding the appropriate payment for travel on non-commercial aircraft, like the aircraft owned by Mr. Weh's company, CSI Aviation. See 11 C.F.R. § 100.93. Failure to comply with the Commission's rules regarding payment for travel on corporate planes could mean that the Weh Campaign has accepted significant sums in prohibited corporate contributions.

CONCLUSION

For the reasons described above, we respectfully request the Commission investigate this matter immediately, and fine the Weh Campaign the maximum amount permitted by law for the clear reporting violations. The Commission should also investigate whether the Weh Campaign's violation was knowing and willful and whether he paid the full fair market value for his travel.

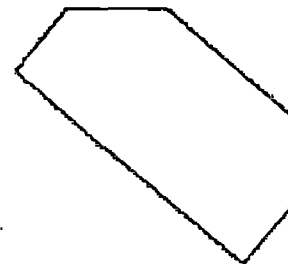
