Dear Ms. Collins:

I have been retained as counsel for New Day Independent Media Committee, Inc. and Susan Jones, Treasurer, New Day Independent Media Committee, Inc. (collectively "New Day Media") in the above-referenced matter. In its Complaint, American Democracy Legal Fund and Hillary Clinton advisor Brad Woodhouse (collectively "ADLF") allege New Day Media violated the Federal Election Campaign Act of 1971 (the "Act") by "knowingly accepting a contribution that was made in the name of another." See Complaint at 2. In addition, the Complaint alleges that MMWP12, K2m LLC, Mark Kvamme, and Paul Johannsen violated the Federal Election Campaign Act of 1971 (the "Act") by (1) using MMWP12 to make contributions in the name of

another person and (2) failing to register MMWP12 with the Federal Election Commission (the "Commission") as a political committee under the Act.¹

Argument

The Commission should promptly dismiss this matter. The single allegation against New Day Media is based upon internet news articles to incorrectly assert that New Day Media knowingly accepted a contribution in the name of another. In reality, this allegation is directly contradicted in the ADLF complaint itself when ADLF makes it clear that MMWP12 made a corporate contribution to New Day Media, and it "did so without disclosing . . . the source of the money to New Day [Media] at the time the contribution is made." Moreover, the contribution form for New Day Media clearly states that "Contributions made in the name of another are strictly prohibited." See New Day Independent Media Committee, Inc., Contribution Form, attached hereto as Exhibit A. New Day Media simply does not accept contributions in the name of another. Because ADLF's Complaint fails to allege facts showing specific violations, the matter should be dismissed without further action.

Conclusion

For the foregoing reasons, ADLF's Complaint should be dismissed and the Commission should take no further action.
