III. BACKGROUND:

Other Violations of the Federal Election Campaign Act (Unauthorized Use of Committee Funds)

House Conservatives Fund ("the Committee") filed its 2014 Year-End Report disclosing a partial restitution payment for unauthorized activity totaling \$7,210.00 (Attachment 2).

On December 2, 2014, Lisa Lisker, the Committee's Treasurer, called a Reports Analysis Division (RAD) Manager. Among other issues, Ms. Lisker identified the Committee as subject to an embezzlement case. She stated that the Committee received a restitution check and asked who to disclose the check from, the U.S. Treasury or the vendor. As the check originated with the U.S. Treasury, she was advised to disclose the check as being from the U.S. Treasury with memo text identifying the individual and explaining the situation. The RAD Manager also instructed Ms. Lisker to include a spreadsheet disclosing the original contributor information for the misappropriated funds (Attachment 3).

On January 31, 2015, the Committee filed the 2014 Year-End Report covering the period from November 25, 2014 to December 31, 2014. The report disclosed one (1) receipt on Schedule A, supporting Line 17 (Other Federal Receipts) of the Detailed Summary Page totaling \$7,210.00 with a purpose of "Partial Payment-Diverted Funds-See memo" (Image 15970252972). The report also included memo text, which stated:

"The receipt disclosed on line 17 from the US Treasury is a partial repayment of funds diverted from the Committee by an outside vendor. The Committee will report the contributor detail when it is made available to the Committee by the investigating agencies" (Image 15970252966).

On April 7, 2015, Lisa Lisker, called the RAD Manager. Among other issues, Ms. Lisker stated that she would amend the Committee's 2014 Year-End Report to include the name of the embezzler when the next report was filed (Attachment 3).

On April 20, 2015, the Committee filed an Amended 2014 Year-End Report with no changes in receipts on Schedule A, supporting Line 17 (Image 15951189745, Attachment 2). However, the Committee did provide additional detail in memo text attached to the report, which stated:

"The receipt disclosed on line 17 from the US Treasury is a partial repayment of funds diverted from the Committee by an outside vendor, Stonewood Marketing, owner Ken Pate. The Committee will report the contributor detail when it is made available to the Committee by the investigating agencies" (Image 15951189739).

To date, no further communication has been received from the Committee regarding this matter.
